

Executive Summary

CBP is tasked with safeguarding America's borders while enhancing the Nation's global economic competitiveness by facilitating legitimate trade and travel. CBP's Office of Field Operations (OFO) conducts inspections of all travelers and their belongings at POEs. CBP conducts border inspections to determine the traveler's admissibility to the United States, to determine whether the traveler is bringing items into the United States contrary to law, and to identify threats to border security. Border inspections begin with "primary" inspection, and, in some instances, a traveler may be referred for additional scrutiny, which is a continuation of the border inspection known as "secondary" inspection. Individuals, including U.S. citizens, who are suspected of or are found to have violated U.S. law may be held in custody for further appropriate processing. Available OFO data indicate that OFO held U.S. citizens longer than 24 hours on 562 occasions from October 1, 2019, through April 30, 2021.

I. Legislative Language

This document was compiled pursuant to direction set forth in House Report 116-458, which accompanies the Fiscal Year (FY) 2021 Department of Homeland Security (DHS) Appropriations Act (P.L. 116-260).

House Report 116-260 states:

Additionally, CBP shall continue to follow the directive in House Report 116–180 related to the following according to the previously directed timeframes unless otherwise specified: ...

(3) U.S. Citizens Held in CBP Custody ...

House Report 116-458 references House Report 116-180, which accompanies the FY 2020 DHS Appropriations Act (P.L. 116-93) and states:

U.S. Citizens Held in CBP Custody.—The Committee directs CBP to provide a detailed report within 90 days of the date of enactment of this Act on the number of U.S. citizens detained for more than 24 hours at POEs during the last two fiscal years. The report should include the ages of the individuals detained, the length of detention, and the rationale for their detention.

II. Background

U.S. Customs and Border Protection (CBP) is tasked with safeguarding America's borders while enhancing the Nation's global economic competitiveness by facilitating legitimate trade and travel. CBP's Office of Field Operations (OFO) conducts inspections of all travelers and their belongings at ports of entry (POE). CBP conducts border inspections to determine the traveler's identity and alienage, to determine if the traveler is bringing items into the United States contrary to law, and to identify threats to border security. Border inspections begin with "primary" inspection, and, in some instances, a traveler may be referred for additional scrutiny, which is a continuation of the border inspection known as "secondary" inspection. Generally, a border inspection is conducted by a CBP officer who interviews the traveler, inspects travel documents, and uses CBP systems to run basic queries to ensure that: (1) the traveler and his or her baggage are admissible; (2) the traveler is not wanted by a law enforcement agency; and (3) the traveler does not pose a health, safety, or national security risk if admitted into the United States.

CBP officers at primary inspection have broad discretion to refer travelers for a secondary inspection, with or without suspicion. Some reasons that a traveler may be referred for secondary inspection include: (1) if the CBP officer at primary inspection believes that further inspection is needed; (2) if the officer at primary inspection is alerted to an issue that may require further inspection; (3) to address issues with the documentation or information supplied; (4) to address potential administrative immigration violations and criminal violations; or (5) at random. At the secondary inspection location, CBP officers will conduct further assessments to resolve the reason for the referral.

OFO has the authority to inspect all persons, baggage, and merchandise entering the United States.¹ During these inspections, any individual, including a U.S. citizen who is suspected of violating or found to have violated U.S. law, may be held in custody to complete the appropriate processing. Individuals who have outstanding extraditable warrants from other law enforcement agencies also may be detained pending transfer. Occasionally, CBP may inconvenience law-abiding persons to detect, deter, and mitigate threats to the homeland caused by the few individuals who are involved in illicit activities. OFO may hold U.S. citizens who have not violated the law under certain circumstances. For example, U.S. citizens accompanying noncitizen family members may be held in custody for a limited period if they are traveling with a noncitizen family member whom OFO determines is removable and who must be processed for an appropriate administrative immigration action.

As of June 2020, Unified Secondary (USEC) is OFO's principal secondary processing system nationwide. USEC is built on a modern platform with an intuitive user interface that unifies the function of two different CBP secondary systems, Secure Integrated Government Mainframe Access and Consolidated Secondary Inspection System. The requested time-in-custody data discussed in the report is housed in Secure Integrated Government Mainframe Access data

tables, while the reason for initial referral or inspection is housed in the Consolidated Secondary Inspection System. USEC's modern platform allows OFO to continue improving and linking data systems to provide greater clarity and transparency of mission-critical activities.

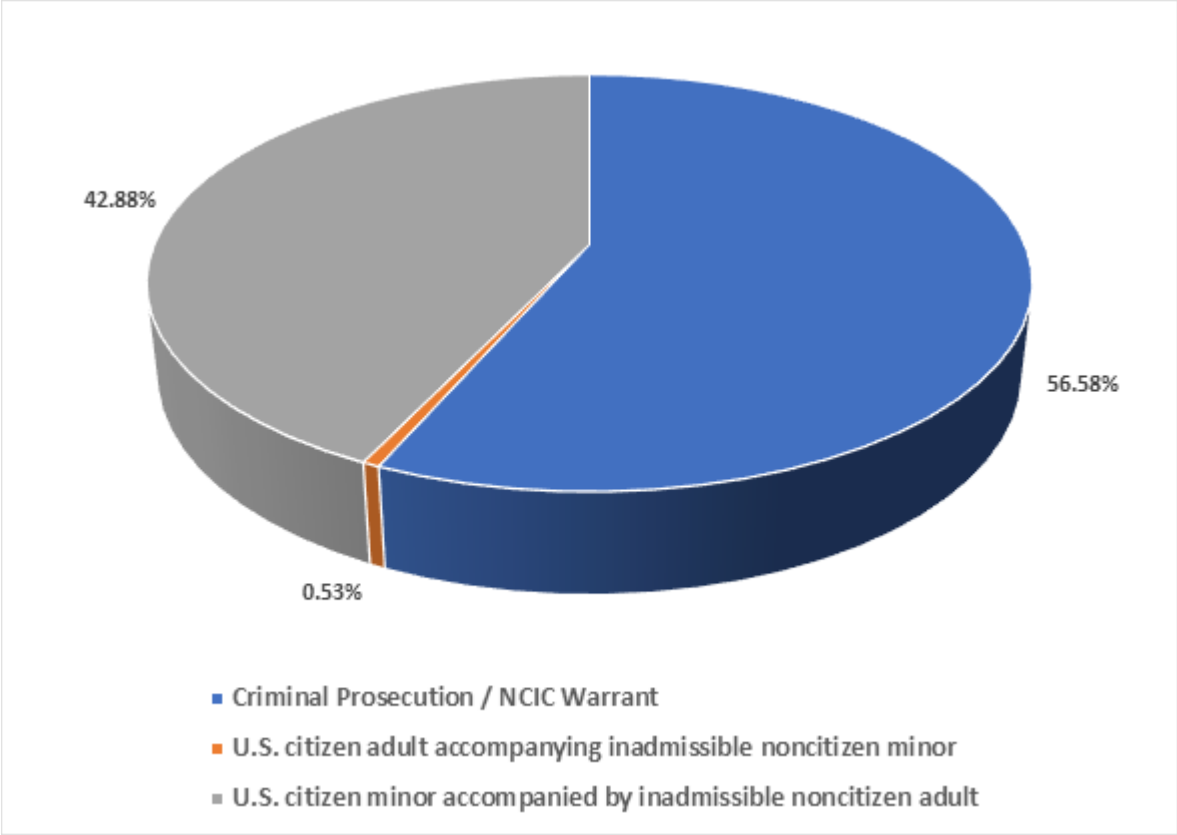
For example, on September 24, 2020, OFO built a dashboard/notification system within USEC to notify users and supervisors of events that are open without activity for the prior 8 hours. This system enhancement was designed to bring awareness of and correction to any potential data quality issues for all individuals in custody. CBP expects that this system enhancement will allow OFO to improve reporting of the time in custody of all individuals going forward, including U.S. citizens.

III. Data

The following information includes individuals with U.S. citizenship that OFO referred for secondary inspection and held in custody longer than 24 hours. Available OFO data indicate that OFO held U.S. citizens longer than 24 hours on 562 occasions from October 1, 2019, through April 30, 2021. See Appendix B, “U.S. Citizens Held in CBP Custody Data,” for additional detail (e.g., age and time in custody) about each event.

IV. Analysis

Most U.S. citizens held by OFO for longer than 24 hours were adults held for criminal prosecution or with matching extraditable NCIC warrants. In these cases, detention is necessary for processing and transfer to the custody of another law enforcement agency.

The second most common reason that OFO held U.S. citizens in custody for longer than 24 hours was in instances where OFO encountered a minor U.S. citizen being accompanied by an inadmissible noncitizen adult parent or legal guardian. In these cases, the minor U.S. citizens are kept with their parent or legal guardian to maintain family unity. Detention of the noncitizen parent or legal guardian beyond 24 hours is often necessary to complete immigration processing. At the conclusion of this processing, the entire family leaves CBP custody together.

The final reason, occurring in only three occasions during this timeframe, was where OFO encountered a U.S. citizen adult accompanying an inadmissible noncitizen minor. On two of the three occasions, the accompanying adult was the parent of the minor. Once again, the reason for the detention was to maintain family unity during the processing of the noncitizen. On these two occasions, the noncitizen minors ultimately were paroled into the United States and were released with their accompanying U.S. citizen parents. In the final case, an adult U.S. citizen arrived at the POE as a travel companion to an inadmissible noncitizen minor. The POE allowed the travel companion adult to stay with the noncitizen unaccompanied child during processing; however, the minor ultimately was turned over for placement with the Department of Health and Human Services, Office of Refugee Resettlement, as required by law.

IV. Conclusion

OFO may hold U.S. citizens in custody in certain situations, such as suspicion of or a determination of violating U.S. law, pending transfer to another law enforcement agency on an extraditable warrant, or if accompanying a family member being processed for appropriate immigration proceedings. Available data indicate that OFO held U.S. citizens longer than 24 hours on 562 occasions from October 1, 2019, through April 30, 2021.
