#### **Project Abstract**


Berkeley County will establish a coordinated Berkeley County Homeland Security Program including a county-wide multi-disciplinary threat assessment and management task force supported by education trainings, technology to mitigate, refer, and respond to targeted violence. Under the leadership of county law enforcement in partnership with emergency management and first responders will develop a sustainable countywide communication plan with standardized protocols regarding violent crime, increased awareness and competencies through training sessions and increase school and community-based efforts to encourage reporting of suspected behavior, threats and violent crimes. The task force will meet regularly to communicate, collaborate and consolidate knowledge from which plans are made, actions determined and future decisions influenced regarding risk readiness and response.

The Berkeley County Homeland Security Program Threat Assessment and Management Task Force will enhance the long-range community wide emergency plan ensuring all citizens achieve a superior quality of life within a safe, active and healthy community.

# 1. Needs Assessment (15 points)

Domestic terrorism and targeted violence has continued to evolve over the last decade-with incidents in which innocent persons killed or injured in communities across the country. Mass violent attacks have increased in frequency and lethality just in 2021 alone. These attacks are a concern for Berkeley County, especially with its unique situation on the Interstate 81 corridor along with being located approximately 70 miles from Washington D.C. and 95 miles from Baltimore, Maryland. The effects of attacks are devastating for the survivors, families of victims, communities and first responders. For public safety officials, mass violence incidents challenge emergency response protocols and demand actionable research, intensive trainings, and innovative warnings to inform the community in the areas of prevention, response and recovery.

Berkeley County is one of the eastern most counties in West Virginia, occupying 321 square miles of land adjacent to western Maryland and northern Virginia. With population at 126,069, 16% of which are school aged children (American Fact Finder, 2022). Berkeley County is in transition from a rural to suburban area. Its largest city, Martinsburg, has a population of approximately 18,777, with three Qualified Opportunity Zones (U.S. Department of Treasury, 2018) [10)(7)(E)



In 2015 the Federal Government designated Berkeley County a High Intensity Drug Traffic Area (HIDTA) since then the Berkeley County Council and local leadership have embraced a holistic, three-pronged strategy to combat the opioid epidemic: **enforcement, treatment and prevention**. The programs including **Community Correction and Home Confinement Programs** offering alternatives to incarceration via the **Berkeley County Day Report Center**; **Recovery Resource Center Program** that promotes prevention and treatment options for addicts, offering wrap around continuum of care services such as peer recovery coaching and case management; and a **Harm Reduction Program** offering a needle exchange and STD testing. The Berkeley County School System, with support from the Berkeley County Council has funded through grants **Project AWARE**, a program targeted at improving the mental health and wellbeing of school aged children (kindergarten – 12<sup>th</sup> grade).

In 2021, Berkeley County had 47,728 violent crimes for homicide, forcible rape, robbery, and aggravated assault-which was over half of the total in the entire state. (Berkeley County Sheriff Office, unpublished data). While the trend of violent crime in Berkeley County is trending down according to the American Community Survey (ACS), the platform and potential for a violent attack to occur still exists. According to the Southern Poverty Law Center there are two known extremist groups in the Eastern Panhandle, the West Virginia Fusion Center has tracked more extremist activity located in the county. Individuals were either arrested or are under investigation in Berkeley County with participation in the violent attack on the United States Capitol on January 6, 2021. (U.S. News).

Creating a countywide threat assessment and management task force, would provide increased security and protection for residents and tourists while providing economic protection to the county, a perceived lack of safety can be detrimental to all persons and industries. The mission of the Berkeley County Sheriff's Office is to provide excellence in police services while building partnerships with citizens in the community. Berkeley County Sheriff's Office is comprised of 67 sworn officers, 20 reserve officers and 10 civilians covering Berkeley County through its patrol division, criminal investigations division, strategic response team, aggressive criminal enforcement team, school resource officers, K-9 unit, SWAT, ACE and dive team. The threat assessment-management task force would fill a critical gap that has been identified through an internal needs assessment and will increase communication for prevention of and responding to threats of terroristic events.

# 2. Program Design and Implementation and Measurement Plan (45 points)

Our county public safety organizations work in partnership to reduce risk associated with violence and terrorism, Berkeley County is not currently prepared to manage risk factors in a coordinated countywide effort. With support from the Department of Homeland Security, Berkeley County will establish a coordinated Berkeley County Homeland Security Program inclusive of a countywide multi-disciplinary threat assessment management task force, supported and enhanced by innovative technology to mitigate and respond to incidents of violence. First, all Berkeley County law enforcement, emergency management, and first responders will attend four targeted violence domestic terrorism prevention trainings, covering specific topics of behaviors and characteristics of extremist behavior; domestic terrorism-ideologies, group, symbols and tactics; and by-stander training. These classes will give the head of the threat assessment management task force the information needed to set up the threat assessment task force which will have representatives from law enforcement, emergency management, public health, mental /behavioral health, and juvenile justice, education, and community organizations. The threat assessment management task force will develop a long-range community wide strategic plan ensuring all citizens achieve a superior quality of life within a safe, active and healthy environment. The threat assessment management task force will also connect and educate community stakeholders in Berkeley County's six managerial districts while building a county wide multi-disciplinary network focused on threat and risk mitigation. The school resource officers will also be an integral part of the task force, they will train school personnel on the behavior and characteristics to look for in students for possible violence and extremist tendencies. After the initial training resource officers will have quarterly meetings with school personnel to continue trainings, keep an open and direct line of communication for mitigating school violence and extremist behaviors. Local leadership has laid the groundwork for this initiative by having a Local Emergency Planning Committee-headed by the Berkeley County Director of Emergency Management, which meets monthly and has partnerships with private sector and the faith-based community preventing and responding to natural and man-made emergencies.

Under the direction of the Berkeley County Sheriff's Office and working with the Berkeley County Emergency Management Department, the Berkeley County Homeland Security Program will have the following goals:

Goal One: Educate Berkeley County Law Enforcement, Emergency Management, and First Responders in order for them to have a deeper understanding of violent extremism-targeted violence and ensure they can mitigate and be the primary defense in Berkeley County. The county will be tasked with holding four in-depth trainings for 80 Berkeley County law enforcement, emergency managers and first responders so they will be able to identify the warning signs in behaviors and behavioral characteristics of extremist and targeted violence. Law enforcement, emergency management and first responders will also learn how to identify the ideology activities, tactics, symbols and a class on how to respond and de-escalate the extreme behavior. After each of these trainings School Resource Officers will train school personnel at their assigned schools as well as trainings held at the Berkeley County Board of Education Office.

Goal Two: Strengthen the understanding and ensure the county stakeholders and school personnel can assist in identifying extremist behavior with youth in Berkeley County. It is important for school personnel to be properly trained and to keep the communication continuing with quarterly meetings. Security measures must extend outside of law enforcement personnel to school personnel and general audiences, as they can prove essential in reporting suspicious or potentially suspicious behavior. These extra eyes in the field are valuable when large events far exceed law enforcement personnel such as the highly attended Apple Harvest Festival, the weeklong Berkeley County Youth Fair or the Shiley Acres Outdoor Concert Venue that hosts 16-20 concerts a year. The Task Force Specialist will schedule quarterly training opportunities for all county stakeholders in the six magisterial districts in the county to include but not limited to mental/physical/behavioral health, tourism industry, faith based leaders, education, community based organizations and civic/social groups located in Berkeley County; through an array of venues and formats. Some trainings may be virtual learning opportunities while others will be in person experiences so that members can begin to build capacity individually as well as a task force and network of county citizens.

Goal Three: Develop a sustainable countywide threat assessment management task force and countywide communication plan on violent crimes. Berkeley County Sheriff's Department currently has a deputy who is responsible for performing crime and intelligence analysis in support of the department's criminal investigations functions and patrol operations. The individual works in collaboration with the West Virginia Fusion Center, a state center that opened in 2008 to gather, process, analyze and share information and intelligence relating to all crimes and all hazards.

To assist in this effort, tools already in place will be pivotal; these tools include Crime Solvers Tip-line and SwiftReach a notification system. The Berkeley County Office of Emergency Management operates SwiftReach an emergency communication tool and incident solution for emergency alerts and notifications to increase safety and information distribution during critical events. The system can be used for countywide events or limited to a specific geographical area,

with notifications submitted through phone calls, text, and email. The threat assessment management task force aligns with the main objective, to assist communities within Berkeley County, the media and law enforcement, to work together to solve crimes. The threat assessment management task force will work with the Berkeley County Office of Emergency Management to create an awareness campaign to increase anonymous call tips while building on the relationship of the West Virginia Fusion center for intelligence sharing among partners. The task force will utilize Berkeley County's Strategic Planning and Communications Director and relationships with local media outlets to develop a countywide awareness and education campaign ensuring all residents are knowledgeable of the Berkeley County Homeland Security Program, Threat Assessment Management Task Force, Crime Solvers tip-line, the combined efforts of law enforcement and first responders and the reporting and notification process when needing assistance with solving a crime or prevention.

The funding will provide the three project goals mentioned above with the following outcomes and impacts:

Goal 1: Educate Berkeley County Law Enforcement, Emergency Management, and First Responders in order for them to have a deeper understanding of violent extremism-targeted violence and ensure they can mitigate and be the primary defense in Berkeley County.

Goal 2: Strengthen the understanding and ensure the county stakeholders and school personnel can assist in identifying extremist behavior on the front lines with youth in Berkeley County.

Goal 3: Develop a sustainable countywide threat assessment management task force and countywide communication plan on violent crimes.

The evaluation of the programmatic goals will be based on the following performance measures:

Performance Measures for goal 1 include number of trainings conducted, number of meetings conducted, number of individuals in attendance, percent of increase in knowledge regarding TVTP and population served.

Performance Measures for goal 2 include number of meetings conducted, number of individuals in attendance, percentage of increase in knowledge regrading TVTP, referrals received, and number of identifications of at-risk persons.

Performance Measures for goal 3 include task force named and formed, number of meetings held, number of individuals in attendance, and number of community engagement activities, number of agencies and individuals served by SwiftReach, Crime Solvers and number of threats.

The Berkeley County Homeland Security Program logic model is included with this proposal as a graphic. The graphic best details the program from the needs assessment through the programmatic learning and action-based outcomes to the long-term Impacts. The model also present the inputs from the partnerships, technologies and resources in place to the outputs, which are the activities that will be conducted during the funding cycle.

# 3. Organizational and Key Personnel (15 Points)

The program has three levels of competencies: fiscal responsibility, staffing, and evaluation.

# Fiscal Responsibility

Berkeley County Council has extensive experience in managing federal and state grants among multiple agencies including a number of accountability's i.e. Drug, Mental Health, Recovery Resources, and Court Security; which rely on relationships between members of the Criminal Justice Community and Berkeley County's services and non-profit sector. Berkeley County has extensive fiscal and administrative controls in thirteen different areas including allowed and unallowed activities, allowable cost/cost principals, and cash managements to manage and approve the use of federal funding. During the implementation process, as well as throughout the program, network membership will explore diversification and sustainability opportunities including fundraising, additional grant-writing and creating permanently sustained positions. The Berkeley County Council Grants Department administers the federal and state grants with draw downs, reporting and close outs.

# Staffing

Sheriff Harmon took on the task this past January of having a county that is aware of and prepared for targeted violence and terrorism. He has an extensive background with assessing high level-threats, including supervising, organizing and conducting high-threat missions including the protective detail of the United States Ambassador in Baghdad, Iraq and the United States Ambassador to the United Nations. He has served in the United States Marines Corps, with both local and state police and has numerous trainings and certifications along with being a certified active shooter trainer. He currently oversees 100 employees in Berkeley County.

Randy Lilly, is the Director of Berkeley County Homeland Security and Emergency Management, and was tasked with establishing a Homeland Security Division. He has been with the county as an emergency management personnel since April 2016, he is currently the chairperson of the Berkeley County Local Emergency Planning Committee. He also maintains and operates the county's mass notification system, SwiftReach. Mr. Lilly is key in development, organizing, and executing disaster exercises both locally and regionally. He maintains various Emergency Operation Plans within both the county government and large business corporations in the county and assists with public training programs both at schools and public forums. He brings an extensive background in logistics.

James Wolford, Emergency Manager of Berkeley County, has 22 years' experience in emergency management. He is the liaison for all public safety agencies including city, county, state and federal. He also has oversite of all levels of emergency management from mitigation through recovery. Mr. Wolford brings experience as a middle school teacher and will be instrumental in the threat assessment task force, targeted violence plan for the county and getting information to the public and schools.

Funds are being requested to support a position for the two-year scope of this project a Threat Assessment & Management Specialist who will oversee the day-to-day operations and ensure ongoing compliance with Department of Homeland Security programmatic and financial requirements, who will be key in bridging information and communication strategies across law enforcement, emergency management, first responders and technologies as it specifically relates to violent crime and situations of risk.

#### Evaluation

The National Policing Institute (NPI), Center for Mass Violence Response Studies (CMVRS), will be contracted through grant funding to collect and analyze data to satisfy the reporting metrics for this project. The NPI is the oldest nationally known, nonprofit (501c3), nonpartisan, and non-membership-driven organization dedicated to improving American policing. In addition to designing, conducting, and evaluating controlled experiments, NPI provides a range of services to local law enforcement agencies, including training, technical assistance, management analyses and planning with the purpose of increasing efficacy of police in deterring crime, improving relationships between the police and the communities they serve, or responding to mass casualty incidents.

The CMVRS, a NPI program, will conduct the evaluation of Berkeley County Homeland Security Threat Assessment Task Force. The evaluation will include both process and outcome components to ensure sustainability. Efforts will continually monitor and improve the program to have the greatest impact on the community. The process evaluation will focus on document review, meeting minutes, review of processes and engagement of task force members. Outcome evaluation efforts will focus on changes of policy and procedures with the implementation of countywide standardized protocols.

Implementation and measurement plans for Year 1 and Year 2 are included with this proposal. During Year 1 the program will focus on establishing the Berkeley County Homeland Security Threat Assessment Management Task Force by identifying county wide partners through obtaining formal memoranda of understandings, developing the task force's structure and way to approach efforts through evaluating current procedures and identifying current processes; work on development of the Berkeley County Homeland Security Threat Assessment standardized protocols with being in Year 1 along with identification of bystander and community entities to include in the task force. Year 1 through Year 2 the training sessions will occur, these sessions will provide data on those that attend, pre-knowledge on crime and reporting that can be compared to post knowledge. Through varied formats, the program intends to reach wide and varied audiences to increase the broader impact-knowledge is power. Year 2 will move from establishing the program, task force and the draft of the countywide threat communication plan to sustaining operations of the Berkeley County Homeland Security Threat Assessment Management Task Force through the final written communication plan for targeted violence. During the second year, the crime analyst and task force lead will look at the metrics of crime reporting to see if shifts have occurred in the number of cases opened, case status date, use of the tip-line, number of referrals for outside services and cases.

# 4. Sustainability (15 points)

Berkeley County Council will be accountable for ensuring the continuation of the Berkeley County Homeland Security and Threat Assessment Management Task Force through the quarterly reports to the council from meeting reports gathered from task force meetings, school personnel meetings, and community wide town halls. The Threat Assessment Management Task Force, law enforcement, emergency management, and the local emergency planning committee will meet once a year to evaluate the community wide communication plan and targeted violence plan to make changes and additions as deemed necessary with the changing environment of targeted violence and terrorism.

# 5. Budget Detail and Narrative (10 points)

Berkeley County Sheriff's Office, Office of Emergency Management and First Responder's program will align with the local emergency planning committee to develop prevention framework with partners to enhance their ability to identify and respond to individuals at-risk of mobilizing to violence and terrorism. The budget request are broken down as follows:
