



Ammunition

The Department of Homeland Security (DHS) established the following Department-wide and Multi-Agency Contract (MAC) vehicles to purchase a variety of ammunition for duty, training, and officer firearms qualifications:

- .223 Remington Duty Ammunition
- 9mm Luger +P Caliber Ammunition 124 Grain
- 9mm Luger Readily Identifiable Training Ammunition (RITA)
- 9mm Duty Ammunition 147 Grain
- 12 Gauge Shotgun Ammunition 00 Buck Reduced Recoil
- Commercial Leaded Training Ammunition
- Less than Lethal Specialty Munitions (LLSM)
- Marking Cartridges
- Reduced Hazard Training Ammunition (RHTA)

Key Contract Vehicle Features:

- Enables DHS Components and other federal agencies, when applicable, to strategically leverage collective buying power through a simplified, expedited and lower cost method of procurement;
- Reduces the need for multiple contracts across DHS through the use of consolidated contract vehicles;
- Training ammunition closely mimics the performance standards of duty ammunition at a lower cost; and
- Increases consistency in ammunition performance due to a standard quality assurance process.
