

Program Management, Administrative, Operations (Clerical), and Technical Services II (PACTS II)

The Department of Homeland Security (DHS) established a second generation of Indefinite Delivery/Indefinite Quantity (IDIQ) strategically sourced contracts for non-IT Program Management, Administrative, Operations (Clerical), and Technical Services II (PACTS II). This vehicle is designed to enable DHS to accomplish its mission objectives through a variety of services.

PACTS II is a 100 percent set-aside for Service-Disabled Veteran Owned Small Businesses (SDVOSB) with IDIQs awarded across two Functional Categories:

Functional Category 1

- Program Management Services Administrative management, general management consulting services, process, physical distribution, and logistics consulting services
- Technical Services engineering services, environment, technical, and other scientific consulting services

Functional Category 2

- Administrative and operations services, financial planning, personnel, billing, and recordkeeping
- Court reporting and stenotype services

Key Contract Vehicle Features:

- Provides access to a comprehensive range of services in an effective, economical, and mission-focused manner;
- Supplements current DHS-wide procurement vehicles that require innovative sourcing strategies;
- Promotes and supports DHS small business goals and initiatives; and
- Provides opportunities for Service-Disabled Veteran-Owned Small Businesses.

Period of Performance (POP):

Two-year base, plus three one-year options (3/1/2017 - 2/28/2022), Option period three has been extended for a period of three years (3/1/2022 - 2/28/2025)
