The report also includes the ages of the individuals detained, the length of detention, and the rationale for their detention.

Executive Summary

CBP is America's frontline border security agency. CBP operates around the clock to prevent the entry of inadmissible persons and contraband into the United States at and between our Nation's POEs, promote the safe and efficient flow of commerce into the United States, and enforce trade and travel laws and regulations. CBP remains committed to performing its mission with integrity and professionalism and ensuring that every individual in our custody is treated with humanity and dignity.

CBP officers welcome international travelers into the United States daily. Individuals seeking entry into the United States are inspected at POEs by CBP officers who determine their admissibility. When screening foreign visitors and returning U.S. citizens, CBP uses a variety of techniques to assure that global tourism remains safe and strong. CBP's Office of Field Operations (OFO) inspects all travelers and their belongings at POEs. In addition to determining the nationality and identity of each applicant for admission, CBP conducts border inspections to determine whether the traveler is bringing items into the United States contrary to law, and to identify contraband and threats to public safety and national security.

Border inspections begin with primary inspection. In some instances, a traveler may be referred for additional scrutiny, which is a continuation of the border inspection known as secondary inspection. Individuals, including U.S. citizens, who are suspected of violating or are found to have violated U.S. law may be held in custody pending further screening and inspection. CBP data indicate that between October 1, 2020, and September 30, 2022, OFO held 555 U.S. citizens in custody at a POE longer than 24 hours.

I. Legislative Language

This document was compiled pursuant to direction set forth in House Report 117-396, which accompanies the Fiscal Year (FY) 2023 Department of Homeland Security (P.L. 117-328), states:

U.S. Citizens Held in CBP Custody.—The Committee directs CBP to provide a detailed report, within 90 days of the date of enactment of this Act, on the number of U.S. citizens detained for more than 24 hours at POEs during the last two fiscal years. The report should include the ages and other demographic information of the individuals detained, the length of detention, and the rationale for their detention.

II. Background

U.S. Customs and Border Protection (CBP) is America's frontline border security agency. CBP operates around the clock to prevent the entry of inadmissible persons and contraband into the United States at and between our Nation's ports of entry (POE), promote the safe and efficient flow of commerce into the United States, and enforce our trade and travel laws and regulations. We remain committed to performing our mission with integrity and professionalism and ensuring that every individual in our custody is treated with humanity and dignity.

CBP officers welcome international travelers into the United States daily. Individuals seeking entry into the United States are inspected at POEs by CBP officers who determine their admissibility. When inspecting foreign visitors and returning U.S. citizens, CBP uses a variety of techniques to assure that global tourism remains safe and strong. CBP's Office of Field Operations (OFO) inspects all travelers and their belongings at POEs. In addition to determining the nationality and identity of each applicant for admission, CBP conducts border inspections to determine whether the traveler is bringing items into the United States contrary to law, and to identify threats to border security.

Border inspections begin with primary inspection, and, in some instances, a traveler may be referred for additional scrutiny, which is a continuation of the border inspection known as secondary inspection. Generally, a border inspection is conducted by a CBP officer who interviews the traveler, inspects travel documents, and uses CBP systems to run basic queries to ensure that: (1) the traveler and his or her baggage are admissible; (2) the traveler is not wanted by a law enforcement agency; and (3) the traveler does not pose a health, safety, or national security risk if admitted into the United States.

CBP officers at primary inspection have broad discretion to refer travelers for a secondary inspection, with or without suspicion. Some reasons that a traveler may be referred for secondary inspection include: (1) if the CBP officer at primary inspection believes that further inspection is needed; (2) if the CBP officer at primary inspection is alerted to an issue that may require further inspection; (3) to address issues with the documentation or information supplied; (4) to address potential administrative immigration violations and criminal violations; or (5) to screen at random. At the secondary inspection location, CBP officers will conduct further assessments to resolve the reason for the referral.

OFO has the authority to inspect all persons, baggage, and merchandise entering the United States.¹ During these inspections, any individual, including a U.S. citizen who is suspected of violating or found to have violated U.S. law, may be held in custody to complete the appropriate processing. Individuals who have outstanding extraditable warrants from other law enforcement agencies also may be held pending transfer. Occasionally, CBP may inconvenience law-abiding persons to detect, deter, and mitigate threats to the homeland caused by the few individuals who

are involved in illicit activities. U.S. citizens who have not violated the law may temporarily be under the care of OFO under certain circumstances. For example, U.S. citizens accompanying noncitizen family members may be temporarily present with OFO for a limited period if they are traveling with a noncitizen family member who OFO determines is inadmissible and who must be processed for an appropriate administrative immigration action or requires additional inspection.

III. Data Report

The following information includes individuals with U.S. citizenship whom OFO referred for secondary inspection and held in custody longer than 24 hours. CBP data indicate that between October 1, 2020, and September 30, 2022, OFO held 555 U.S. citizens longer than 24 hours at a POE.

IV. Analysis/Discussion

Most individuals with U.S. citizenship whom OFO referred for secondary inspection and held in custody longer than 24 hours were adults held for criminal prosecution or adults who matched an extraditable NCIC warrant. In these cases, holding the individual is necessary for processing and transfer to the custody of another law enforcement agency.

The second most common reason for holding individuals with U.S. citizenship in custody for longer than 24 hours were instances where OFO encountered U.S. citizen minors accompanied by their inadmissible noncitizen adult parents or legal guardians. In these cases, U.S. citizen minors are detained until the noncitizen parent or legal guardian transfers custody of the minor to another adult, or the child is transferred to the local Child Protective Services agency. Holding the noncitizen parent or legal guardian beyond 24 hours is often necessary to complete immigration processing. To preserve family unity, the U.S citizen minor may be referred with their noncitizen parent or legal guardian until the parent/legal guardian's admissibility is determined. The inadmissible noncitizen parent will be processed under the appropriate U.S.C. Title 8 disposition. If the inadmissible noncitizen parent is taken into custody or returned to a foreign country, then the minor may proceed into the United States as a U.S. citizen. The parent or legal guardian will be consulted when determining to whom the child will be released (i.e., self-released depending on age, released to family member, or Child Protective Services).

The third reason, happening only four times during this timeframe, occurred when OFO encountered a U.S. citizen adult accompanying an inadmissible noncitizen minor. In the first case of four, the U.S. citizen, an adult relative who was not a parent or legal guardian, elected to accompany the minor to the secondary inspection. The noncitizen minor was placed with the Department of Health and Human Services, Office of Refugee Resettlement (HHS/ORR) as required by law, and the adult was admitted into the United States. In the second case, the U.S. citizen, an adult sister, elected to accompany the minor brother and her mother to the secondary inspection. The noncitizens were turned over to the custody of U.S. Immigration and Customs Enforcement pending a credible fear interview by an Asylum Officer and the adult U.S. citizen was admitted into the United States. In the third case, the U.S. citizen adult parent and her minors were kept in CBP custody to maintain family unity while CBP completed immigration processing. The entire family left CBP custody together at the conclusion of this processing. In

last of the four cases, the U.S. citizen adult attempted to smuggle the noncitizen child into the United States from Mexico using a birth certificate that was not lawfully issued to the child. In this case, the U.S. citizen adult was charged under 8 U.S.C. § 1324 - *Bringing in and harboring certain aliens*, and the adult was admitted into the United States. The noncitizen minor was placed with HHS/ORR, as required by law.

The fourth reason, happening only twice during this timeframe, occurred when OFO encountered a U.S. citizen minor accompanied by their U.S. citizen adult parent and an inadmissible noncitizen minor. On both occasions, the U.S. citizen minor and U.S. citizen adult mother were traveling from Mexico to the United States with a noncitizen minor. The adult attempted to smuggle the noncitizen child into the United States from Mexico using a birth certificate that was not lawfully issued to the child. Once again, the reason for the detention was to maintain family unity during the processing of the noncitizen. In both cases, the U.S. citizen adults were charged under 8 U.S.C. § 1324 - *Bringing in and harboring certain aliens*, and the adult and U.S. citizen minor were admitted into the United States. The noncitizen minors were placed with HHS/ORR, as required by law.

CBP operates around the clock to prevent the entry of inadmissible persons and contraband into the United States at and between the Nation's POEs, promote the safe and efficient flow of commerce into the United States, and enforce our trade and travel laws and regulations. We remain committed to performing our mission with integrity and professionalism and ensuring that every individual in our custody is treated with humanity and dignity.

CBP officers welcome international travelers into the United States daily. Individuals seeking entry into the United States are inspected at POEs by CBP officers who determine their admissibility. In inspecting foreign visitors and returning U.S. citizens, CBP uses a variety of techniques to assure that global tourism remains safe and strong. CBP's OFO inspects all travelers and their belongings at POEs. CBP conducts border inspections to determine whether the traveler is bringing items into the United States contrary to law, and to identify threats to border security. The two most common cases in which U.S. citizens were held by OFO for longer than 24 hours were adults held for criminal prosecution or matched to an extraditable NCIC warrant, and instances where OFO encountered a U.S. citizen minor accompanied by an inadmissible noncitizen adult parent or legal guardian.
