I. Legislative Requirement

This document was compiled pursuant to direction set forth in the House Report (H.R. 117-396), accompanying the Fiscal Year (FY) 2023 Department of Homeland Security Appropriations Act (P.L. 117-328).

The House Report provides:

B-1 Visa Holders.—The Committee directs the Secretary to submit a report not later than 180 days after the date of enactment of this Act that includes summary data on B-1 personal or domestic workers, including visa holders' years of birth; genders; countries of citizenship and birth; dates of visa issuance and expiration; and the cities and states where the visa holders will be working. The report shall employ data disclosure avoidance measures to protect personally identifiable data and be made available to the public. The Secretary shall promptly inform the Committee if a federal agency partner does not comply with a request to provide relevant records needed to complete the report.

II. Background

This report presents the Office of Immigration Statistics' (OIS) analyses of Department of State (DOS) data in the form of summary data for B-1 visa holders issued for personal or domestic work, including birth year; gender; country of citizenship and birth; date of visa issuance and expiration; and city and state where the visa holders work. Data include visas issued between 2013 and May 1, 2023, that were valid as of May 1, 2023.

III. Data and Analysis

OIS compiled and analyzed the data received from DOS regarding B-1 visas issued for personal or domestic workers. Figures and tables in this section include notes about data sources. References to years in this report are made for fiscal years (October 1 - September 30) and include the full fiscal year's data unless specified otherwise. Some data were withheld (indicated with a "D" in tables) to limit disclosure of identification of individuals.

Table 1 presents the years and total number of B-1 visas issued between 2013 and May 1, 2023. There was a notable decline in issuances during 2020 and 2021 before a large increase in 2022 and 2023.

Table 2 presents the total number of B-1 visas issued for personal or domestic workers from 2013 to May 1, 2023, by the visa expiration year. Years of expiration span from 2023 to 2033. There is a steady decline with each year, aside from a slight increase between 2030 and 2031 expiration dates.

These data are presented based on collection method: city data was self-entered and contains misspellings and other errors and are listed in descending order of total visas for states followed by territories. Florida and California's combined total was more than half of all B-1 visa issued for personal and domestic workers.
