Buying for DHS Operational and Support Components is conducted by nine operational procurement offices:

- Transportation Security
   Administration (TSA)
- Federal Emergency
   Management Agency (FEMA)
- U.S. Secret Service (USSS)
- U.S. Coast Guard (USCG)
- U.S. Customs and Border Protection (CBP)
- U.S. Immigration and Customs Enforcement (ICE)
- Federal Law Enforcement Training Centers (FLETC)
- U.S. Citizenship and Immigration Services (USCIS)
- DHS Headquarters

### **DHS** buying is decentralized

Buying is conducted by the operational procurement offices. There is no centralized DHS vendor portal or interested vendors list. To begin researching DHS opportunities, get to know the mission of the Components and their existing and potential requirements. Review Component websites and budget forecasts to identify where your firm's products or services would provide benefit to DHS and enhance the protection of the Nation and its citizens. Be prepared to offer value-added solutions that put the DHS mission first!

## First point of contact – Small Business Specialist (SBS)

Each DHS Component has a dedicated SBS – the first point of contact. The SBS can help identify current opportunities and discuss specific Component buying practices. To get started, send an email to the SBS introducing your firm and include your capability statement. As you explore opportunities with DHS, become knowledgeable about the DHS Category Management/Strategic Sourcing Program. Strategic sourcing vehicles are designed to manage costs and reduce duplicative contracts in meeting defined DHS-wide requirements. Most are mandatory for use for covered products and services, with limited exceptions.
