



Executive Summary

Background

<u>The Student and Exchange Visitor Program (SEVP)</u> is part of U.S. Immigration and Customs Enforcement's (ICE) Homeland Security Investigations within the U.S. Department of Homeland Security (DHS). SEVP manages the <u>Student and Exchange Visitor Information</u> <u>System (SEVIS)</u>, the web-based system DHS uses to maintain and manage information on nonimmigrant students whose primary purpose for coming to the United States is to study.

A nonimmigrant is any foreign national who temporarily visits the United States to fulfill a specific purpose (e.g., tourism, business, study). SEVP acts as a bridge for organizations and individuals with an interest in information about nonimmigrant students in the following categories:

- F-1 STUDENTS Nonimmigrant students whose primary purpose is to complete an academic course of study at an SEVP-certified school or program.
- M-1 STUDENTS Nonimmigrant students whose primary purpose is to complete a vocational course of study at an SEVP-certified school or program.
- J-1 EXCHANGE VISITORS Nonimmigrant students selected to participate in a U.S. Department of State-designated exchange visitor program.

SEVP certifies U.S. schools to enroll nonimmigrant students and ensures their compliance with administrative regulations. The U.S. Department of State manages the J-1 Exchange Visitor Program. Both SEVP and the Department of State use SEVIS to maintain critical information that allows DHS to protect national security, while supporting the legal entry of nonimmigrant students, also termed international students and exchange visitors.



SEVIS by the Numbers

SEVIS by the Numbers is an annual report that highlights key SEVIS data. The data illustrates trends, values and information specifically on F and M international students studying in the United States. The report includes the following sections:

- <u>STUDENTS</u> Data on international students who come to the United States to study.
- <u>SCHOOLS</u> Data on SEVP-certified schools that enroll international students in the United States.
- <u>STATES AND TERRITORIES</u> Data about international student demographics within individual U.S. states and territories.

This SEVIS by the Numbers report uses SEVIS data from calendar year 2021 and compares it to data from calendar year 2020. This report can also be compared to calendar year data in the <u>SEVP Data Library on ICE.gov</u> as well as the <u>2020 SEVIS by the Numbers report</u>.


PLEASE NOTE: An international student or exchange visitor is deemed active once they enter the United States and engage in their program of study or exchange visitor program.

COVID-19 Impact

The COVID-19 pandemic continued to impact international student enrollment in the United States in 2021. The total number of SEVIS records for active F-1 and M-1 students was 1,236,748 in calendar year 2021, a decrease of 1.2 percent from calendar year 2020.

- The number of international students enrolled at kindergarten through grade 12 (K-12) schools decreased 16 percent from 2020 to 2021 (-9,489).
- In 2019, more than three K-12 schools enrolled more than 700 international students, with one school hosting more than 1,000 international students. In comparison, in 2020, only one school hosted more than 700 international students. In 2021, no K-12 schools hosted more than 600 international students.
- While all four regions in the United States saw a decline in international student records from 2019 to 2020, only the Western region saw a decline from 2020 to 2021 of 7.5 percent.
- There were 105,970 pre- and post-completion optional practical training (OPT) students with both an employment authorization document (EAD) and who reported working for an employer in calendar year 2021, compared to 122,699 in calendar year 2020 a 13.6 percent decrease.





The figure above illustrates the percent change of international student records by U.S. region from calendar year 2020 to calendar year 2021. Groupings are based on the U.S. Census regions.

Other Trends

Other notable trends from international student enrollment in 2021 include:

- A total of four SEVP-certified schools each enrolled more than 15,000 international students, unchanged from 2020.
- In calendar year 2021, 8,038 SEVP-certified schools were eligible to enroll international students, a decrease of 280 schools from 2020 (8,369 schools).
- The number of students from China and India made Asia the most popular continent of origin. However, China sent fewer students in 2021 in comparison to 2020 (-33,569) while India sent more students (+25,391).
- In 2021, California hosted 208,257 international students, the largest percentage of international students (16.8 percent) of any U.S. state.
- There were 240,479 active exchange visitors in the United States in 2021 compared to 256,944 active exchange visitors in 2020.

Overview

Between the calendar year 2020 and calendar year 2021 reporting period, the total number of F-1 and M-1 international student records decreased by 14,821 (-1.18 percent). In calendar year 2021, international students in the United States hailed from 225 countries and pursued 1,485 different primary majors.¹ International students engaged in studies across a variety of education levels, from primary schools to flight training schools to higher education.

International Students in Higher Education

Most F-1 and M-1 students come to the United States to take part in the higher education system. In 2021, roughly 92 percent of all F-1 and M-1 students were enrolled in an SEVP-certified associate, bachelor's, master's or doctoral program. Specifically, international students in the United States pursued 1,142,352 degrees in higher education, which is an increase from calendar year 2020 (1,121,981). It is important to note that one student might partake in more than one level of education in a given calendar year, so they may be counted in multiple educational levels.

Associate Degrees

There were 69,495 F-1 students who sought an associate degree in calendar year 2021, which accounted for almost six percent of degrees pursued by the international student population. In calendar year 2020, a total of 85,909 F-1 students sought an associate degree, which accounted for eight percent of degrees sought by the international student population. The number of students enrolled in associate degree programs decreased 19.1 percent (-16,414) between calendar year 2020 and 2021.

Bachelor's and Master's Degrees

There were 881,830 F-1 students who sought either a bachelor's (443,440) or master's (438,390) degree in calendar year 2021, which accounted for 71 percent of degrees sought by the international student population. These two levels of education were the most popular among international students studying in the United States. The percentage of students pursuing bachelor's degrees decreased by .5 percent (-2,219) and the percentage

of students pursuing master's degrees increased by 6.6 percent (27,050) between calendar year 2020 and 2021.

Doctoral Degrees

There were 191,027 F-1 students who sought a doctoral degree in calendar year 2021, which accounted for 15.4 percent of degrees sought by the international student population. In calendar year 2020, 179,073 F-1 students sought a doctoral degree, which accounted for 15.7 percent of degrees sought by the international student population. The number of students enrolled in doctoral programs increased 6.7 percent (11,954) between calendar year 2020 and 2021.

International students can pursue more than one major during their program of study in the United States. This section focuses on students' primary majors, which are the foremost majors listed on their SEVIS record and correspond to most of their coursework in the United States.

International Students at K-12 Schools

There were 49,630 international student records for K-12 education during calendar year 2021. Approximately 8.4 percent of K-12 students in 2021 pursued primary school education, while approximately 92.7 percent of K-12 students pursued secondary school education (grades 9-12). China sent 38 percent of all K-12 students in 2021, followed by South Korea, Mexico, Vietnam and Canada.

Optional Practical Training and Curricular Practical Training

International students can participate in various types of practical training related to their field of study while they are in the United States.

- Pre-completion OPT takes place prior to a student's program end date and can last up to 12 months.
- Post-completion OPT takes place after a student's program end date and can also last up to 12 months.
- STEM OPT is a 24-month extension of OPT for qualifying students with degrees in Science, Technology, Engineering and Math (STEM).
- Curricular Practical Training (CPT) takes place prior to a student's program end date and is integral to the school's established curriculum.

PLEASE NOTE: To participate in any form of OPT, an international student must receive an EAD from U.S. Citizenship and Immigration Services.

The total number of international students working at any point during a calendar year may exceed the number of employment authorizations issued each year because STEM OPT extensions are two-year authorizations and OPT authorizations are granted on a rolling basis throughout the year. Reporting the number of authorizations issued allows for precise reporting on how many individuals pursued work authorization under the program in a given year. International Students from Around the World

Other than Antarctica, F-1 and M-1 students come from every continent in the world, and from more than 224 countries and territories. Asia had the largest number of active international student records (889,093), accounting for 71.9 percent of the international student population.

The figure below illustrates the overall increase or decline rate of international student records from each continent from calendar year 2020 to calendar year 2021.

Africa

The overall number of active F-1 and M-1 student records coming from Africa increased by 5,602 student records from calendar year 2020 (60,347) to calendar year 2021 (65,949). Nigeria (19,338) was the West African country that sent the most students in 2021. Additionally, Kenya (5,462) was the East African country that sent the most students in 2021. Lastly, Libya (769) saw the steepest decrease in student records across the continent.

Asia

Forty-seven percent (581,843) of all active SEVIS records hailed from either China (348,992) or India (232,851) in calendar year 2021, the same percentage as calendar year 2020. While the overall number of active F-1 and M-1 student records coming from Asia decreased by 34,781 from calendar year 2020 to calendar year 2021, student record trends varied across different countries.

The number of international student records from China and India made Asia the most popular continent of origin. However, China sent fewer students in 2021 in comparison to 2020 (-33,569), while India sent more students (+25,391).

Still, 71.9 percent of all international students in the United States call Asia home.

Other Asian countries sent fewer students including South Korea (-9,430), Saudi Arabia (-9,439) and Japan (-6,155).

Australia and Pacific Islands

The overall number of active F-1 and M-1 student records from Australia and Pacific Island nations decreased by 357 from calendar year 2020 to calendar year 2021. In calendar year 2021 there were 7,723 active student records from this region, which is a 4.4 percent decrease from calendar year 2020 (8,082). Ninety-five percent of enrollments from this continent hail from the region's largest countries: Australia (5,423) and New Zealand (1,986).

Europe

Europe is the third most popular continent of origin and saw an increase in the number of student records in calendar year 2021. The overall number of active F-1 and M-1 student records coming from Europe increased by 8,852 from calendar year 2020 (100,820) to calendar year 2021 (109,672). Student enrollment from Spain (+1,670), Italy (+1,639), France (+1,375), the United Kingdom (+835), and Germany (+684) increased in calendar year 2021.

North America

The overall number of active F-1 and M-1 student records coming from North America increased by 1,908 from calendar year 2020 to calendar year 2021, resulting in 37,965 students studying in the United States in 2021. The increase in the number of student records from Canada (+1,945) and the decrease in the number of student records from Bermuda accounted for the overall continental trend.

Central and South America

The number of students coming into the United States from Central and South America increased by 4,626 from calendar year 2020 (104,851) to calendar year 2021 (109,574). There was a decrease in student records from Brazil (-1,340) and Venezuela (-1,192).

International Student Gender Trends

Forty-four percent (548,705) of F-1 and M-1 international students in calendar year 2021 were female, while 56 percent (687,534) were male. Of K-12 student enrollments in 2021, 42.6 percent were female (19,596). In addition, 44 percent (195,511) of bachelor's and master's international students were female, 50.2 percent (34,886) of international students seeking associate degrees were female and 40 percent (76,394) of international students seeking doctoral degrees were female in 2021. Of the top 10 countries of



citizenship in calendar year 2021, the average female enrollment was 44.5 percent (380,062) and the average male enrollment was 55.5 percent (473,960).

Overview

F-1 and M-1 students must attend schools that are SEVP-certified. U.S. schools can petition for SEVP certification to enroll F-1 students, M-1 students, or both F-1 and M-1 students. In calendar year 2021, there were 8,038 SEVP-certified schools in the United States, 331 fewer schools than in calendar year 2020. In 2021, 85.5 percent (6,875) of SEVP-certified schools could enroll only F-1 students; seven percent (558) could enroll only M-1 students; and 7.5 percent (623) could enroll both F-1 and M-1 students.

Enrollment at SEVP-certified Schools

There were 8,038 SEVP-certified schools in calendar year 2021. Of the 6,432 SEVP-certified schools that enrolled students in 2021, 68 percent hosted one to 50 international students. Eleven percent of schools that enrolled international students hosted 101 to 1,000 international students, 11 percent of schools that enrolled international students hosted 51 to 100 students and three percent of schools hosted 1,001 to 5,000 students. Less than one percent of schools that enrolled international students in 2021 hosted 5,001 or more international students.

There were four schools that enrolled more than 15,000 international students in 2021; Northeastern University, Columbia University in the City of New York, New York University, and University of Southern California.

Above is the breakdown of the number of SEVP-certified schools with at least one international student by active student enrollment. There are an additional 1,606 schools that have been certified to accept international students but did not enroll any international students in 2021.

F-1 Schools

F-1 schools are SEVP-certified schools that enroll international students with F-1 visas. F-1 students are in an academic program, often with a core academic curriculum, and can remain in the United States for the duration of their program of study. F-1 students can change their major or program of study, and they can transfer at any time during their program or begin a new program after completing one.

The top 20 most popular F-1 schools hosted 20.1 percent (249,137) of the entire international student population.

M-1 Schools

M-1 schools are SEVP-certified schools that enroll international students with M-1 visas. M-1 students are in a vocational program, typically without a core academic curriculum, and can only remain in the United States for up to one year unless they apply for an extension. M-1 students cannot change their major or program of study, and they can only transfer in the first six months after arrival in the United States.

There were 558 schools certified to enroll only M-1 students in 2021. Eighty-five M-1 schools only enrolled one international student during the reporting period.

K-12 Schools

K-12 schools are SEVP-certified schools that enroll international students with F-1 visas in the grade years from kindergarten through grade 12. Students can attend private elementary schools, private middle schools, private high schools (grades 9-12) or public high schools (grades 9-12). SEVP regulations place no limit on the length of time an F-1 student may attend a private SEVP-certified school; however, F-1 students can only attend public schools in grades 9-12 schools and for up to one year.

Location of SEVP-certified Schools

Although there are SEVP-certified higher education and vocational schools throughout the United States and its territories, 54 percent (3,470) of these schools are in 10 U.S. states. California alone is home to 13.6 percent (873) of all SEVP-certified schools. Only Connecticut (+1), North Dakota (+1) and Louisiana (+1) saw an increase in the number of certified schools from calendar year 2020.

States and Territories


Overview

F-1 and M-1 students study across the United States and its territories. California, New York, Massachusetts, Texas and Florida hosted the largest number of student records and together welcomed 48.4 percent (598,207) of all international students.

International Students Across the United States

Of the four major regions within the continental United States, the Northeast had the greatest number of students in calendar year 2021, followed closely by the South, the West and the Midwest. Only the West saw a net decrease in its F-1 and M-1 student populations from calendar year 2020 to calendar year 2021.

The Northeast saw the greatest percentage increase and welcomed 3.2 percent more student records (+11,165) than in calendar year 2020. The South also welcomed 0.2 percent more student records (+712) than in calendar year 2020, followed by an increase of 2.5 percent (+5,715) in the Midwest. The West welcomed 7.5 percent (-26,377) fewer student records than in calendar year 2020. Non-continental U.S. territories also had about 11 percent fewer student records (-159) in calendar year 2021 than in calendar year 2020.

International Students in the Northeast

In calendar year 2021, nine Northeastern states hosted 362,982 F-1 and M-1 student records. New York had 142,281 international student records in 2021, the largest number of international student records in the region. Massachusetts experienced the largest increase in student enrollment (+5,698) while Maine saw the largest percentage change in the region (+9.3%).

Below are the three Northeastern states that saw the greatest percentage change in enrollments in the reporting period calendar year 2020 to calendar year 2021.

International Students in the South

Sixteen Southern U.S. states and the District of Columbia hosted 345,034 international student records in calendar year 2021. The state in the region with the largest increase in student records in 2021 was Texas, which hosted 87,939 student records in 2021 (+2,765). Virginia, by comparison, saw the steepest decline in student records (-2,408). Virginia hosted 31,776 student records.

International Students in the Midwest

The Midwest saw a 2.5 percent increase in the number of international student records. Illinois hosted 58,501 student records in 2021 and saw the greatest increase in student records (+2,958), followed by Ohio (+1,530). Michigan saw the steepest decline in student records (-944).

International Students in the West

The West saw the largest (-26,377) decline in the number of international student records in calendar year 2021.

The overall regional decline was due in part to the dip in international student records in California, the region's most popular state. California hosted 208,257 student records in calendar year 2021, which was a decline of -18,934 from calendar year 2020. While Oregon saw the largest proportional decline with -16.3 percent (-2,251), Utah saw the largest proportional increase in student records at 5.3 percent (+683).

International Students Studying in Non-continental U.S. Territories

The non-continental United States territories hosted 1,287 student records during calendar year 2021, and 55 percent of those records were from international students in Puerto Rico. All but one territory in the region, American Samoa (+1), experienced a decline in F-1 and M-1 participation from calendar year 2020 to calendar year 2021. Puerto Rico (-85) and Northern Mariana Islands (-36) experienced the steepest declines in student records.



In calendar year 2021, Puerto Rico hosted 710 student records and Northern Mariana Islands hosted 345. There is one distinct territory that appears on the 2020 report but does not appear on the 2021 report due to zero active student records: Marshall Islands.
