### VI. Litigation

- In the matter of America First Legal Foundation v. U.S. Department of Homeland Security (DHS) (22-cv-01896) (2022-HQLI-00044), plaintiff filed a complaint on July 5, 2022, seeking records pertaining to political appointees since January 20, 2021. On May 6, 2024, the U.S. Department of Homeland Security (DHS) Privacy Office issued a supplemental response consisting of 8 pages of records to the plaintiff. Portions of this response are withheld pursuant to FOIA exemption 6.
- In the matter of *Immigrants' Legal Defense v. U.S. Department of Homeland Security (DHS) (23-cv-06348) (2024-HQLI-00022)*, plaintiff filed a complaint on December 8, 2023, seeking records pertaining to any complete or signed "DHS Multimedia Agreement,"; communications containing the following phrases: "proposed pilot"; "shooting schedule"; "outline of the production"; or "approved production" from the following custodians: Brandon A. Montgomery, Director, DHS, Office of Multimedia Liaison, the current Director of DHS' Office of Multimedia Liaison or any individual who has held the title of Director of DHS' Office of Multimedia Liaison from March 1, 2018, to the present. On May 7, 2024, the U.S. Department of Homeland Security (DHS) Privacy Office issued its third interim response consisting of 66 pages of records to the plaintiff. Portions of this response are withheld pursuant to FOIA exemptions 5,6, and 7(C).
- In the matter of *Bloomberg, L.P. v. U.S. Department of Homeland Security (DHS)* (24-cv-00596), plaintiff filed a FOIA request on October 3, 2023, seeking records pertaining to employer-level records on H-1B lottery and petition results, from lottery season FY2021 (lottery conducted in 2020) to lottery season FY2024 (lottery conducted in 2023). On May 10, 2024, the U.S. Citizenship and Immigration Services (USCIS) released two Excel spreadsheets to the plaintiff.

# **Freedom of Information Act Exemptions**

Exemption 1: classified national defense and foreign relations information

**Exemption 2**: internal agency personnel rules and practices

**Exemption 3**: Information that is prohibited from disclosure by another federal law

Exemption 4: trade secrets and other confidential business information

**Exemption 5**: inter-agency or intra-agency communications that are protected by legal privileges

**Exemption 6**: information involving matters of personal privacy

**Exemption 7**: records or information compiled for law enforcement purposes, to the extent that the production of those records A) could reasonably be expected to interfere with enforcement proceedings, B) would deprive a person of a right to a fair trial or an impartial adjudication, C) could reasonably be expected to constitute an unwarranted invasion of personal privacy, D) could reasonably be expected to disclose the identity of a confidential source, E) would disclose techniques and procedures for law enforcement investigations or prosecutions, or would disclose guidelines for law enforcement investigations or procedures, or F) could reasonably be expected to endanger the life or physical safety of any individual
