<p>ENCOUNTER: On February 25, 2025, Federal Bureau of Investigation (FBI) contacted New York City (NYC), Enforcement and Removal Operations (ERO) Officers in regard to GUTIERREZ FLORES, MERWIL #A (b) (6), (b) (7)(C), a 19 year old citizen and national of Venezuela. The FBI initiated an investigation in regards to GUTIERREZ FLORES for ongoing criminal activity. NYPD arrested GUTIERREZ FLORES for weapon related charges on February 24, 2025 which is currently pending disposition. At approximately 2300 hours, FBI NY turned GUTIERREZ FLORES custody over to NYC ERO Officers after their investigation concluded. At approximately 2302 hours NYC ERO arrested GUTIERREZ FLORES without incident pursuant to a Warrant for Arrest of Alien (Form I-200). NYC ERO Officers transported GUTIERREZ FLORES to 26 Federal Plaza, 10th Floor, New York, NY, 10278 for processing and a custody determination. GUTIERREZ FLORES is currently under 240 removal proceedings and currently pending seeing an immigration judge</p> <p>ALIENAGE AND DEPORTABILITY: GUTIERREZ FLORES is a male citizen and national of Venezuela. Database queries reveal, there are no known derivation of U.S. citizenship issues.</p> <p>IMMIGRATION HISTORY: On June 21, 2023, the United States Border Patrol (USBP) initially encountered and arrested GUTIERREZ FLORES attempting to illegally enter the United States at or near Paso Del Norte, Texas. The USBP found GUTIERREZ FLORES had unlawfully entered the United States from Mexico on June 21, 2023, at a time and place other than as designated by the Secretary of the Department of Homeland Security of the United States.
