

In regards to past environmental considerations associated with wall/levee in RGV, we relocated over 200 Sable palms, several cultural sites were documented through our cultural resource surveys and we attempted to avoid them where possible. In addition there were many wetlands areas identified through our initial surveys and we implemented Best Management Practices (BMPs ) such as sediment and erosion control to minimize impacts to wetlands during construction. Some of the prior segments were constructed on the Lower Rio Grande National Wildlife Refuge and lands used for agricultural purposes. CBP strategically installed (b) (7)(E) within these areas to allow for continued access to these areas.

New levee/wall construction in RGV would likely encounter similar environmental considerations and CBP would address them in a similar manner.

Understanding that each project is unique, based on past levee wall projects in RGV, some in these same zones, is there any environmental considerations we can point to having done as the types of

options or considerations that might be made or could be made in the process? We can certainly caveat that each project, land parcel and situation is unique and not all options utilized in the past would be applicable or viable in the proposed projects.

We believe the staff wants to be supportive of these wall projects and include the funding for them but we are looking for information to help their members be more comfortable with them as well.

This letter responds to the January 28, 2017, notification to transfer or reprogram \$20,000,000 to begin the planning and design of new physical barriers along the Southwest Border, submitted to the Committee by Ms. Stacy Marcott, Chief Financial Officer (Acting) of the Department of Homeland Security (DHS).

The notification proposes investments in the planning and design of physical barriers to be deployed along sections of the Southwest land border with Mexico, to include prototype design, construction, and testing; site analysis and standard designs for an initial section of a Border Wall System; and for real estate, environmental, and site planning activities required prior to future construction of physical barriers along additional sections of the Southwest border. Solutions to achieve operational control of the border shall utilize a multi-layered approach that includes attendant lighting, technology (including sensors), and patrol and access roads; prioritizes officer safety; addresses well defined operational requirements based on threat; and maximizes cost effectiveness. In justifying a final material solution, DHS is expected to follow the acquisition management processes required under all relevant management directives, including DHS Management Directive 102.

The Committee directs CBP to provide briefings as soon as possible on each of the following:

- 1) The results of the source selections for Border Wall System prototypes;
- 2) The evaluation results for the Border Wall System prototypes, including the criteria for selecting one or more prototypes for the proposed initial Border Wall System segment;
- 3) CBP's long-term goals and plan for border security between the ports of entry along the Southwest border and one or more long-term, multi-layered solutions for achieving those goals and plans, informed by alternatives analyses and including proposed laydowns of border infrastructure;

- 4) The current threat assessment along the Southwest Border and how it relates to CBP's long term border security goals and proposed solutions; and
- 5) An independent cost estimate for any proposed solutions.

The Committee approves the reprogramming of funding from the Mobile Video Surveillance System program due to contract delays and the transfer of excess funds from Naco Fence Replacement program to support DHS's border infrastructure planning and design efforts.

I have consulted with the Ranking Member of the Subcommittee, Rep. Lucille Roybal-Allard, and she concurs with these oversight directives.


Dear Secretary Kelly:

I have received the February 28, 2017, letter from Stacy Marcott, Acting Chief Financial Officer, notifying the Committee of a proposed reprogramming of \$20,000,000 to begin the planning and designing of new physical barriers along the Southwest Border.

The Committee does not object to the reprogramming request, as the Department has provided assurances that the evaluation and selection of proposed prototypes will include investments in design, construction, technology (including ground-based and airborne sensors), and patrol and access roads. The Committee has received further assurances from the Department that this process will be conducted transparently and cost effectively, with highest priority for officer safety, with emphasis on risk, and without prejudice for specific solutions. Specifically, it is imperative that the Department give equal consideration to currently deployed and proven border security capabilities. The Committee asserts that no funding for the construction phase of the long-term border solution should be appropriated until the Department has completed an analysis of alternatives to determine the most appropriate and effective solutions for securing the border. This study shall also include a detailed cost-benefit analysis and effectively measure the impact of the existing fencing along the border as recommended by the Government Accountability Office. These are critical steps that must occur in order for the Committee to make informed decisions on any additional funding request.

I have consulted the Ranking Member of the Subcommittee, Senator Jon Tester, and he concurs.

**Summary:** The USBP is requesting funds for (b) (7)(E) of New Wall and supporting roads, in RGV sector. The primary requirement to impede and deny illegal activity in the Rio Grande Valley Sector has been validated through gap analysis and planning since 2014. The secondary requirement to increase lateral access has also been validated through gap analysis and planning since 2014. Historically, the USBP has prioritized these requirements by determining which gaps were necessary to mitigate and which gaps were desirable based on Operational Control. As the definition of Operational Control changes and as the threat shifts and exploits USBP capability, the priorities change. As of March, 2017, mitigating these RGV capability gaps is a 2017 Operational priority.

**Expected Operational Outcomes:**

- To increase overall USBP effectiveness as articulated in 2014 Quadrennial Homeland Security Review (QHSR)
- Mitigate/close Impedance and Denial Capability Gaps within USBP.
- Increase certainty of arrest but denying the adversary access to specific areas.
- To increase Agent and Officer Safety.
- To increase Public Safety, specifically in urban areas where illegal incursions cause law enforcement response and activities within a dense urban environment.
- To decrease injuries to Illegal Aliens by deterring border crossings before they occur.
- To decrease the cost for medical attention and hospital stays for Illegal Aliens injured.
- To decrease the amount of “high risk” incursion events, such as vehicle incursions with armed smugglers or vehicles that often times result in the damages to property and injuries.
- To increase response time and lateral access for responding and patrolling agents.

**2017 Requirement Validation and Development Process:**

Since 2013, RGV had identified multiple impedance and denial capability gaps that negatively impact operations; including but not limited to (b) (7)(E)

RGV has also identified (b) (7)(E) Wall construction, and the supporting road construction, will mitigate these gaps.

Updated analysis conducted in March 2017 assessed the following terrain attributes across the southwest border:

- Proximity to urban areas,
- Proximity to roads,

- Slope (elevation)



[REDACTED] Based on both the capability gaps and additional terrain analysis, the USBP assesses that RGV requires additional barriers (wall/fence), particularly at the McAllen, Weslaco, and Rio Grande City stations.

**History of RGV Requirement:**

The Impedance and Denial capability gap, along with the lack of lateral access has existed for years. This specific issue was well documented and analyzed during 2014 gap analysis efforts in RGV. This gap was not mitigated because of the lack of fence development and design funding.
