

a. PEIS Tucson & Yuma (AERC 225) The Revised Draft PEIS for the Tucson/Yuma Sector Operations was sent out on 13 October. The deadline for comments was established at 29 October. (b)(6) indicated that he would have difficulty meeting this deadline; the EWG/PDT agreed to leave the deadline as is, but incorporate (b)(6) comments to the extent practicable. (b)(6) will still need to provide input/revisions for the CR section. GSRC will ensure that Stations receive

a review copy. b. Checkpoints (b) (7)(E) (AERC 499) The Tucson checkpoints (b) (7)(E) are out for public review (b) (7)(E) only. The public comment period was extended until 16 November due to a mix up (b) (7)(E) regarding public distribution and notice.

Checkpoint - (b) (7)(E) (AERC 227) The Tucson checkpoint (b) (7)(E) Final EA and FONSI will be sent out next week (NLT 31 October) for staffing. GSRC still needs some information from (b)(6) (b)(6) (Ajo) regarding strategic enforcement reasons the checkpoint needs to be relocated.

d. Nogales BPS (AERC 503) GSRC submitted the final Nogales Station EA and FONSI and Phase I ESA for staffing. These documents, including the FONSI, recommend a Phase II investigation to determine the extent of potential contamination around the fuel AST. The EA and FONSI can be finalized prior to the Phase II investigations.

BA – Operations – Tucson & Yuma (AERC 51) The Tucson BA is scheduled to be sent to (b)(6) on Friday (24) October) for QA/QC review prior to submittal to the USFWS. by 4 November (b)(6) will develop a list of conservation measures, with cost estimates, that could be implemented. The Yuma BO has not been received. (b)(6) requested that GSRC send a chronology of the BA/BO process as well as the POC information for the USF&WS Phoenix Field Office. (b)(6)/GSRC will draft a letter for CBP signature; the letter should also acknowledge the USFWS cooperation and prompt attention for the emergency beacons and Op Grip consultations

#### SUMMARY OF PDT ACTIVITIES (INFRASTRUCTURE) 3.

(b)(6) deadline for the Final EA and signed FONSI for 30 November.

b. Nogales Infrastructure EA (AERC #255 & 218 ENV #225) The FONSI for the Nogales Various Infrastructure Improvements final EA was signed on 17 October. (b)(6) will pdf a copy of the signed FONSI to (b)(6) and GSRC. GSRC will distribute the final EA ASAP.

### Other items – updates from GSRC

GSRC called the Phoenix Field Office's Regulatory Functions Branch Section Chief (b)(6)regarding the Whitewater Draw 404 permit application. (b)(6) stated that she would have (b)(6)call GSRC this week. received a call from (b)(6) that the public notice will go out this (b)(6)week.

### (b)(6)

conducted a sidebar meeting to discuss the Sonoita road improvement projects. (b) (6) provided a hardcopy map of the proposed project roads. GSRC will develop a map and project description and send it to the EWG and USFS for review. A copy needs to be sent to (b)(6) as well so that he can begin obtaining the ROEs. The USFS has a CATEX for road grading; but CBP does not have one for such activities. In addition, some of the road improvements would be conducted on state and private lands. GSRC will include a list of the USFS CATEX items, highlighting the road grading item, as an appendix to the EA to strengthen the impact analysis. The group agreed that a joint FONSI, if possible, would also strengthen the EA.

GSRC has received the NTP for the Tucson FY 03 projects. GSRC can initiate the efforts on the Naco-Douglas BA and the Temporary Vehicle Barriers EA. However, surveys cannot be started on the Sonoita or Nogales Stations' road projects until the ROEs are obtained.

GSRC can initiate the efforts on the Naco-Douglas BA and the Temporary Vehicle Barriers EA using the map and project description provided by (b)(6)

GSRC and (b)(6) will coordinate to ensure that the titles used in (b)(6) spreadsheet, GSRC's list, and (b)(6) database are consistent.

Work on the Nogales Stations' road projects cannot start until the ROEs are obtained.

GSRC has re-evaluated the Dip 5 crossing and determined that the area is not a jurisdictional wetland, but it is a WUS. GSRC will provide a report and NWP notification, if the project complies with NWP thresholds.
