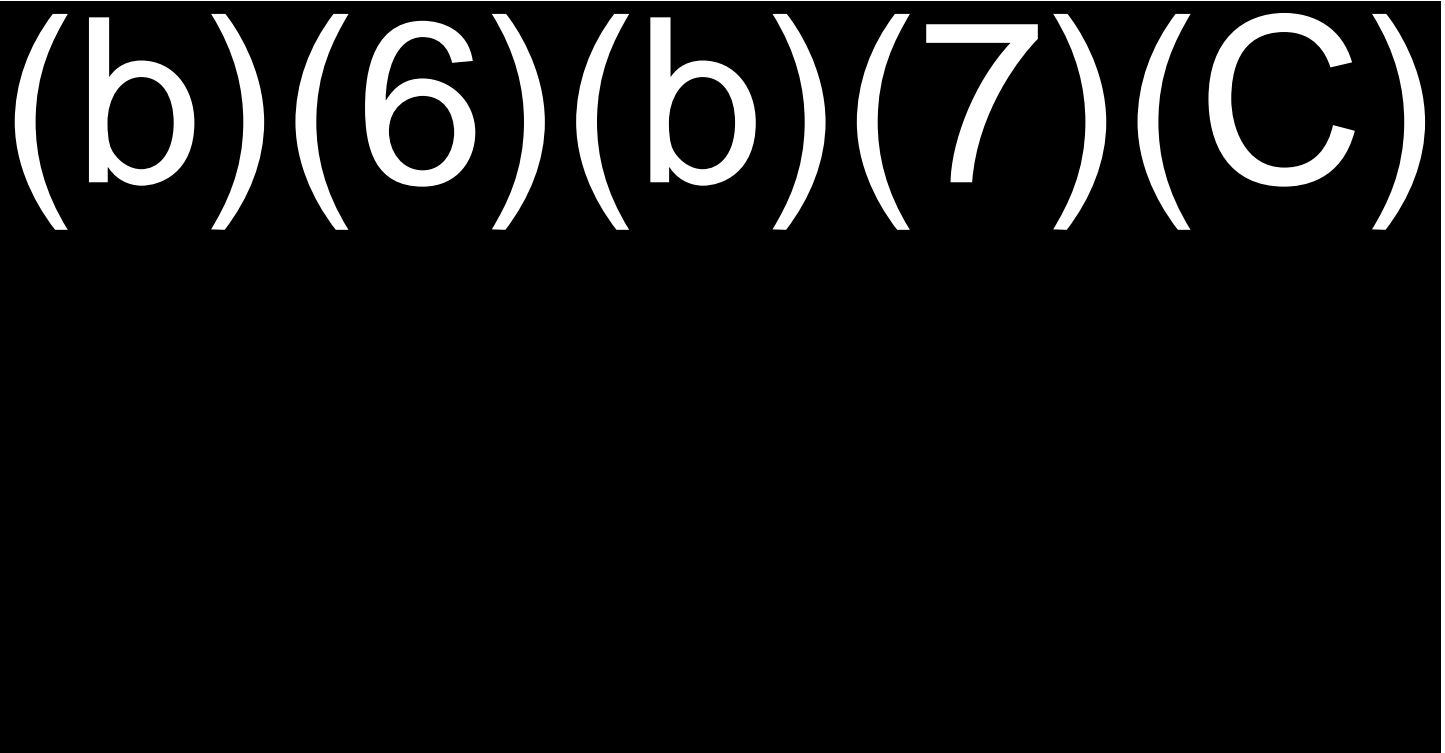

Subject: Immigration EO Tracker

Good evening. Thanks to all of you for joining us for the Task Force meeting today. I think it was really helpful to bring everyone together as we focus on tracking the various lines of effort in each of the components. There's already much work underway to implement the EOs, and it was helpful for all of us to take stock of your efforts to date.

As promised, attached is the DRAFT tracker for review and comment. Please send any edits to the contents to me, (b)(6)(b)(7)(C) and (b)(6)(b)(7)(C) by noon on Friday, February 3rd. Again, we are happy to take your edits/comments in whatever form is easiest for you. Please don't feel as though you have to wrestle with formatting. If you give us the content, we can plug it in accordingly. In addition to adding the actions that we know are missing, the other key items to focus on as you review include:

- Confirming whether the status is currently complete, on track, delayed or off track.
- Adding/changing/confirming the timelines.

- Confirming the lead agency listed is correct and providing the actual name of your POC so we can add that to the chart.
- For actions currently captured, ensure they are captured fully and accurately.
- Noting key progress as well as legal/policy/resource issues that are posing obstacles for completion.

As a reminder, please also send us your more detailed agency implementation plan which will include actions/resource needs/budgetary impact/etc. These are due COB Friday, February 3<sup>rd</sup>.
