- The subject was issued a Special Immigrant Visa (SQ1) on or about Dec 01 2016, due to his previous work with assisting US military forces in Iraq with translation duties.
- The subject stated he attended University of Technology in Iraq, where he received a degree in Chemical Engineering, with a focus on Industrial Units.
- The subject fled Iraq in 2005 due to threats made against US military translators, travelling to Amman, Jordan.
- The subject stated when he returned to Iraq in 2008, he worked for a US linked company called Babylon Gates, which provided explosive detection dogs to US and Iraqi government officials.
- The subject stated he has also worked as a project manager for to USAID- linked companies, called MSI and URS. Subject stated that MSI performed a project called "Tatwir", which trained Iraqi government employees, and URS trained employees for Iraqi ministry of health employees.
- The subject stated that his immigration paperwork is being supported by an individual named (b)(6), (b)(7)(C) who is a representative of an organization called No One Left Behind.
- The subject stated that the family travelled to Iran in 2012 to seek medical treatment during birth of second son.
- The subject married his wife in 2008. The wife (SQ2) stated she attended University of Technology in Iraq, where she received a degree in Chemical Engineering, with a focus on the oil refinement process.

The Port of Entry completed a thorough exam on these individuals and vetting indicates there is no nexus to terrorism. Due to the lack of any indication of a security risk, and the potential claims of fear of his country of nationality, these individuals were admitted consistent with Section 3(g) of the Executive Order. The granting of the waiver was in the interest of the United States government because this family is immigrating to the United States for a better life after fleeing war torn Iraq after assisting the United States Government as a translator. No derogatory information was discovered during the interview.
