# Eligibility and Focus Areas

State, Local, Tribal Governments

And Non-profit organizations:

- Developing resilience;
- Training and engagement with community members; and
- Managing intervention activities

Institutions of Higher Education

And Non-profit Organizations:

- Challenging the narrative; and
- Building capacity of community-level non-profit organizations active in CVE.

Note: Non-profits are eligible in all five focus areas.

# Eligible Activities

- The program intends to fund activities that research has shown produces positive CVE outcomes or has promise to do so.
- The program organizes those activities into five focus areas which are categories of similar activities that can be compared during the competition.
- Applicants can apply for more than one focus area, but must submit separate applications. This allows us to make comparisons between submitted proposals.

Managing Intervention Activities	\$2,000,000	\$50,000 - \$500,000	4 - 12
Building Capacity	\$1,000,000	\$250,000 - \$1,000,000	1 - 3
<b>Total</b>	<b>\$10,000,000</b>	<b>\$20,000 - \$1,500,000</b>	<b>20 - 70</b>

# Programmatic Review Process

- Eligibility Review: Civil Rights and Civil Liberties, Expertise
- Scoring: Four Member Panel (OCP, CVE Task Force, Peer Reviewer, FEMA)
- Ranking and Policy Review (OCP, CVE Task Force, CRCL, FEMA)
  - Diversity of Geography
  - Mix of Eligible Applicant Types
  - Maximize Available Funds
  - Focus Area Funding Targets
- Funding Recommendations approved by OCP Director and FEMA AA GPD and forwarded to Secretary for final approval.

# Budget Review

Review budget and budget narrative to ensure that costs are:

- Allowable, Allocable, Reasonable
- Indirect Cost Rate Agreements are current, if applicable
- 2 CFR 200, Subpart F Audit requirements
- Sam.gov-Applicant's standing (good, debarred, suspended) and applicant information verified

# Cost Categories: Indirect Costs

- Costs incurred for a common or joint purpose benefitting more than one cost objective, and not readily assignable to the costs objectives specifically benefitted, without effort disproportionate to the results achieved.
- The NOFO includes information on criteria under which indirect cost are allowable.

# Management & Administration (M&A) Costs

- Direct costs that are incurred to administer a particular Federal award
- Identifiable and unique to each Federal award
- Charged based on the activity performed for that particular Federal award
- Planning funds cannot be used for M&A activities
- M&A Costs are only eligible for the Building Capacity Focus Area for up to 5% of the award

- Pre-review of training materials
- Review of any changes to Challenging the Narrative campaigns
- Quarterly Reporting
- Site Visits
- Technical Assistance
- S&T Evaluations
- Corrective Measures for non-compliance

# Why Monitor?

- Assesses programmatic, financial, and business management performance of an award
- Occurs during the period of performance
- Ensures compliance with pertinent statutes, regulations, Administrative Requirements, Notice of Funding Opportunity (NOFO)/Program Guidance, OMB Circulars, and relevant FEMA Information Bulletins
- Verifies that Federal property and other grant-related resources are appropriately safeguarded
- Validates information provided by the Recipient

# Timeline

- Application Period Open: July 6<sup>th</sup> 2016
- Application Deadline: Sept. 6<sup>th</sup> 2016 (62 days)
- Anticipated Funding Selection: October 30<sup>th</sup> 2016
- Projected Period of Performance Start: December 1<sup>st</sup> 2016
- Projected Period of Performance End: November 30<sup>th</sup> 2018 (2 years)
