Fiscal Year 2018 in Review

The Department of Homeland Security (DHS) has a fundamental duty-to secure the Nation from the many threats we face. This requires the dedication of more than 240,000 employees in jobs that range from aviation and border security to emergency response, from cybersecurity analyst to chemical facility inspector. Our duties are wide-ranging, and as one team, with one mission—we are one DHS—keeping America safe.

During Fiscal Year (FY) 2018, DHS has delivered results in terms of ensuring lawful trade and travel, enhancing border operational control, interdicting migrants and drugs in the maritime environment, combatting transnational criminal organizations, responding to disasters, managing immigration benefits, and the continued vetting of 100 percent of domestic passengers and checked baggage.

DHS has a robust set of strategic performance measures that gauge and communicate the value we deliver to our stakeholders and the American public. A review of the FY 2018 performance results demonstrates ongoing progress for securing the aviation sector, the border, and federal civilian networks. Also reflected in our results are our efforts to secure key leaders and critical infrastructure, continuing to enhance our immigration system, and our ability to respond to, and recover from, disasters.

This is DHS's sixth year for a clean financial statement audit opinion. DHS's Net Cost of Operations for FY 2018 was \$66.8 billion as compared to \$66.4 billion in FY 2017. Whether sustaining a clean opinion on our financial statements or improving internal controls, the value of transparent and accurate financial reporting cannot be stressed enough.





- 80% interdiction effectiveness along the Southwest Border, consistent with the prior four year's .
- 99% of recurring border surveillance has been implemented in remote low-risk areas, increasing our situational awareness of illegal activity.
- 98% of inbound cargo identified by CBP as potentially high-risk is assessed or scanned prior to departure or at arrival at a U.S. port of entry.

What's next...

Trade...CBP will continue efforts to improve trade relationships with other countries, the trade community, and international organizations in order to promote safer, faster, and more compliant trading.

Border Security...CBP is implementing an Operational Control (OPCON) framework to: 1) impede or deny illegal border crossings; 2) maintain situational awareness; and 3) apply the appropriate, time-bound, lawenforcement response between the ports of entry.

- 91% of performance standards implemented by the highest risk chemical facilities have been verified by DHS.

- 85% of critical infrastructure owners and operators who implemented at least one cybersecurity assessment recommendation to improve critical infrastructure and federal network security.

- 6,398 enforcement-related actions were taken against employers that violated immigrationrelated employment laws, a significant increase over previous years.
- 256,085 total number of illegal immigrants who were returned or removed from the U.S.

Smart Staffing...ICE will continue its efforts to staff and retain key officer and support staff consistent with EO 13768, Enhancing Public Safety in the Interior of the United States.

Entry Enforcement...Local law enforcement participation with ICE is improving and administrative arrests are increasing. Moving forward, ICE will continue to prioritize efforts to maximize the discharge of those who are subject to a final order of removal.

TSA is currently deploying Computed Tomography X-ray scanning technology to security checkpoints to enhance threat detection capabilities for carry-on baggage.

Expansion Efforts...With

more lanes recently added, TSA is continuing efforts to expand TSA PreCheck as it allows for shorter wait times while allowing TSA officers to focus on higher threat areas.

provide the President, Secretary of Homeland Security, and Secretary of Defense, a range of operations to ensure the safety, security, and stewardship in the maritime domain. USCG has five mission programs: Maritime Law Enforcement; Maritime Prevention; Maritime Response; Marine Transportation System Management; and Maritime Security Operations.

Modernization...the U.S. Coast Guard has an aggressive capital improvement plan to modernize the air and maritime fleet to include the 11th National Security Cutter expected in FY 2019, obtaining the first Polar Security Cutter expected to be delivered in 2023, and operating the C27J—a multi-role aircraft in the U.S. Coast Guard fleet.

- 100% of protectees (e.g., President, Vice President, and Foreign Dignitaries) arrive and depart safely.

- 0.0064% of currency was identified as counterfeit, consistent with prior year's results.
