DHS Career Successors,

With the Presidential election approaching, the Department completed a comprehensive review of the succession plan for key officials. This process was completed with the Secretary's approval on September 14. A key aspect of this process has been to identify career successors for all key leadership positions within the Department. You are one of the career leaders who serves in a successor position.

Part of a smooth transition is to ensure that the career employees who may step in to act are prepared for the challenges that they may face. To ensure all career successors are *Ready to Act*, the Presidential Transition Office has worked with several Components and good government partners to provide executive briefing sessions for you.

Participation in the session is a mandatory requirement for you as a career successor.

This 90-minute session will include an update on the Department's Presidential Transition preparations and how they impact you. Also, a brief overview of Continuity of Operations, Continuity of Government, and Incident Response responsibilities for successors will be provided. The session will conclude with a discussion on preparing and managing the arrival of the new Administration leadership within your organization.

**Paper Decision Brief Deputy's Management
Action Group (DMAG) August 4, 2016**



Homeland
Security

Overview

- This is a decision briefing to request the DMAG members review, provide feedback and approve a recommended list of Presidential transition strategic topics by August 9, 2016. This list was briefly discussed at the DMAG on July 28, 2016. Note: The list is intended to begin a discussion with the incoming Administration about the issues the Department faces and is not meant to be the sole, comprehensive, or final issues that will be discussed. While conducting a review of past transition practices, the Presidential Transition Office (PTO) received guidance and advice to not overwhelm the incoming Administration with excessive written briefing materials. The PTO is preparing four types of briefing materials: DHS Overview, Strategic Issues, Threat and Intelligence, and a Playbook for the Incoming Secretary. To determine the Strategic Issues, Operational Components and HQ Offices nominated topics (119 received) and ranked their top 30. The rankings were weighted to ensure operations focused topics were identified. Similar topics were combined. The issues were then assigned into three broad categories: Policy & Operations, Management & Resources, and Employees & Engagement. The PTO added a small number of additional topics that should be included.



Methodology

- Nominations from all Operational Components and HQ Offices
Operational Components and HQ Offices ranked top 30 issues
Rankings calculated by counting each instance of a specific ranking and assigning inverse points to each ranking (i.e., #1 ranking = 30 pts, #2 ranking = 29 pts, #30 ranking = 1 pt, etc.)
Sums were calculated to offer Operational Component rankings additional weight
Weighting: HQ Offices = 1X; Operational Components = 2X; MGMT Lines of Business = 0.14X (combined MGMT = 1X)



Data Overview

- 119 strategic issue topics were nominated: 74 Policy and Operations topics 30 Management topics 15 Personnel topics Several nominated topics were either duplicates or closely aligned: Cybersecurity Transnational Organized Crime Emergency Management Over 8,000 calculations completed to derive final raw and weighted scores: Top 30

High / Low Scores Raw: 361 / 117 Weighted: 489 / 150 Standard Deviation Raw = 79.1 Weighted = 100.5

Overview:

- The list of nominations is intended to begin a discussion with the incoming Administration about the issues the Department should address.
- The PTO will finalize a strategic issue paper list, identify Component/Office co-leads, and disseminate task-out papers by August 12, 2016.

Background:



All ICE officials identified in the succession plan are required to attend DHS's "Ready to Act: Successor Executive Briefing." 


FY16 Criminal Arrests



FY16 Detainers (by AOR)








Pending Immigration Court Cases
