- ▶ Met on November 17, 2015, to discussing work products and ongoing initiatives.
- ▶ Discussed the current T-band situation and will draft executive briefing talking points to assist associations and states in educating officials on the issue.
- ▶ Discussed land mobile radio (LMR) encryption and will review additional LMR products including the Guidelines for LMR Encryption and the Non-P25 Fact Sheet.

SAFECOM Association Highlights and Current Events

National Public Safety Telecommunications Council (NPSTC)

- ▶ The Border Working Group completed a two-page outreach document highlighting the recent agreement between the U.S. and Canada on use of portable radios at and across the border. The document is ready to publish, pending coordination with CITIG on a joint release date. The Working Group is also monitoring efforts by the Federal Communications Commission's (FCC) and Industry Canada regarding policy direction on the licensing of public safety base stations across the border.

SAFECOM

- ▶ At the FCC's encouragement the National Regional Planning Council (NRPC) and NPSTC identified specific Reserve Channels to support deployable trunked systems on a nationwide basis. Six channels were identified as being available on a nationwide basis, including border area access, and were subsequently approved by the FCC. The Working Group published a report October 16.
- ▶ The Local Control Working Group was formed to update the 2012 NPSTC Local Control Report on public safety issues with LTE deployments. The final report was approved by the Governing Board and published on October 13, and has also been transmitted to the FirstNet Public Safety Advisory Committee (PSAC).
- ▶ The Deployable Systems Working Group is a joint effort of the Department of Homeland Security and Canada's Centre for Security Science to study public safety LTE deployable assets that will operate along jurisdictional boundaries. Approximately 90 volunteers from Canada and the U.S. participate in this working group. The Working Group is reviewing the new Incident Commander Deployable Systems Checklist and has completed the Broadband Deployable System Report outline. A focus group is now meeting to finalize the operational capabilities to technical challenges and the operational requirements documents.
