NOTICE TO RESPONDENT: PENALTIES

A violation of a Final Protective Order is a crime and law enforcement shall arrest the Respondent, with or without a warrant, and take the Respondent into custody if the officer has probable cause to believe that the Respondent has violated any provision of the Interim, Temporary, or Final Protective Order. Violation of this Order may result in criminal prosecution, imprisonment or fine or both, or a finding of contempt. In accordance with Maryland Code, Family Law Article § 4-506(f), no respondent against whom a current final civil protective order has been entered may possess any firearm. This Protective Order shall be recognized and enforced by the courts of any state, the District of Columbia, any U.S. Territory, tribal lands (18 U.S.C. § 22a5) or Department of Defense installations. (10 U.S.C. § 1561a) Crossing state, territorial, or tribal boundaries to violate this Order may result in federal imprisonment. (18 U.S.C. § 2262)

Federal law provides penalties of up to \$250,000 fine and 10 years in prison for possessing, transporting, shipping, or receiving any firearm or ammunition while subject to a protective order or after being convicted of a misdemeanor crime of domestic violence (18 U.S.C. § 922(g)(8) and (9)) or knowingly transferring a firearm after a conviction of a misdemeanor crime of domestic violence (18 U.S.C. § 922(d)(9)).

(Residence includes yard, grounds, outbuildings, and common areas surrounding the dwelling.)
5. The Respondent SHALL STAY AWAY from:

6. The Respondent SHALL PAY Emergency Family Maintenance in the amount of \$750.00 every month to GLADYS TORDIL beginning 03/17/2016 and BY DEPOSIT TO ACCOUNT FOR WHICH DEPOSIT SLIPS HAVE BEEN PROVIDED ON THE 15TH DAY OF EVERY MONTH THEREAFTER

8. The Respondent SHALL immediately surrender all firearm(s) to law enforcement agency PRINCE GEORGE'S CD. SHERIFF'S DEPT., and refrain from possession of any firearm, for the duration of this Final Protective Order.

FPS can confirm that Eulalio Tordil is a law enforcement officer with the Federal Protective Service. In March, FPS placed him on administrative duties after a protective order was issued against him. FPS immediately removed his duty weapon, badge, and credentials. He was subsequently placed on administrative leave. As this incident took place off-duty, all questions should be referred to the investigating agency, Prince George's County Police Department. FPS is cooperating with the Prince George's County Police Department during this ongoing investigation.





Nothing is on hold. To be very clear, I am writing regarding your request, on behalf of Eulalio Tordil, to make a written reply and an oral reply to the April 20, 2016 Notice of Proposed Indefinite Suspension ("Proposal Notice") that was issued to Mr. Tordil. I am extending the time for Mr. Tordil to submit a written reply and to make an oral reply to on or before May 18, 2016. If Mr. Tordil wishes to make an oral reply, he/you must contact me no later than Tuesday, May 10, 2016 and identify more than one date and time that your propose for the oral reply (to take place on or before May 18, 2016), and with at least a couple of days' notice so that we can arrange for a stenographer.

As you know, the Proposal Notice was served on Mr. Tordil on April 20, 2016, and it specifically informed him that he had 15 days (i.e., until May 5, 2016) to submit a response and 10 days to

request an oral reply (i.e., until April 30, 2016).
