DHS OHA presented at the 10th Annual Federal Occupational Health Nurse Symposium, and initiated discussions with the National Registry of EMTs (NREMT) and the National Association of State EMS Officials (NASEMSO) on the development of a national first responder curriculum. HTPU met with representatives of the National Survivor Network in May 2017, who shared their perspectives on law enforcement efforts to combat trafficking. The DOS TIP Office hosted a public meeting and solicited public comments via a Federal Register Notice on effective approaches to inform a new \$25 million dollar program to reduce the prevalence of modern slavery in specific countries and regions. HHS partnered with Coro, a nationally recognized leadership development organization, to pilot the Human Trafficking Leadership Academy (HTLA) that brought together both human trafficking survivors and anti-trafficking grantees to acquire leadership skills while working to inform federal anti-trafficking programming.
