Top Stories

- Officials reported September 14 that businesses and surrounding streets in Philadelphia, Pennsylvania, were evacuated September 12 after a water main ruptured and poured 15 million gallons of water to surrounding areas. – *WPVI 6 Philadelphia* (See item [19](#))

1. *September 13, Cliffview Pilot* – (New Jersey) **Evacuations lifted, residents return after explosion, fire at Waldwick substation.** Evacuation orders for residents were lifted nearly 8 hours after an explosion and oil fire at a PSE&G-owned Hopper Avenue switching station in Waldwick September 13 that was caused by equipment failure. Crews de-energized the station and doused flames with foam.

2. *September 11, Casper Star-Tribune* – (Wyoming) **Chesapeake Energy works to quell Douglas well fire as concerns mount.** Two of six Chesapeake Energy-owned oil wells near Douglas, Wyoming, were capped September 11 after Wyoming Oil and Gas officials found that the company had been pumping methanol into the affected wells before a fire started. An investigation is ongoing and crews are monitoring the air around the fire for any particulate matter and volatile organic compounds.

3. *September 10, U.S. Department of Labor* – (Connecticut) **Employees of Plainville, Connecticut, electroplating company exposed to chemical, mechanical hazards.** The Occupational Safety and Health Administration announced September 10 that it issued Connecticut-based Plainville Plating Co. Inc., 2 repeat and 11 serious citations September 2 for exposing employees to dangerous levels of lead and cadmium, and for failing to evaluate employee forklift operation, among other safety violations during a 2010 inspection. Proposed fines total \$48,304.

4. *September 14, Help Net Security* – (International) **New malware can make ATMs not**

- give users' card back.** Security researchers from FireEye reported that new ATM malware dubbed Suceful has the capability to read all credit and debit card track data, data from the card's microchip, and retain or eject an inserted card on demand. The malware can also be controlled via the ATM's personal identification number (PIN) pad and, may disable the device's alarm and proximity sensors.

5. *September 13, Attleboro Sun Chronicle* – (Rhode Island; Massachusetts; Connecticut) **Area bank robber dubbed the 'Teardrop Bandit' suspected in pair of recent heists.** East Providence, Rhode Island police arrested a suspect September 11 dubbed the "Teardrop Bandit" in connection to an August 18 robbery at a People's Bank branch in Milford, Connecticut, and a September 9 robbery at a Citizen's Bank branch in Wareham, Massachusetts. The suspect was recently released from prison for a series of bank robberies in New Hampshire and Massachusetts.

 6. *September 12, Southern California City News Service* – (California) **'Bluto Bandit,' suspected in Irvine and other bank robberies, is charged.** FBI officials reported that a Rancho Cucamonga suspect dubbed the "Bluto Bandit" was arrested and charged September 10 in connection to 8 bank robberies across the Los Angeles, Orange, and San Bernardino counties between June 10 and August 12.

 7. *September 11, WSAZ 3 Huntington* – (West Virginia) **At least 100 fake credit cards connected to fraud scheme.** Authorities in Bourboursville, West Virginia, arrested 4 individuals they dubbed the "Chinese Mafia" the week of September 7 after finding over 100 fake credit cards and merchandise bought using stolen credit card information. Officials believe that the suspects, who are all from the New England, are part of a larger organized crime ring, and that they skimmed card information using a pocket device while working at West Virginia area Chinese restaurants.

 8. *September 11, U.S. Securities and Exchange Commission* – (International) **SEC charges five Arizona residents with stealing millions from investors to fund travel and entertainment sprees.** The U.S. Securities and Exchange Commission charged 5 Arizona residents September 11 for allegedly defrauding 225 investors out of nearly \$18 million by promising to use the funds for property acquisition and development in Mexico, to operate recycling facilities, and to purchase foreclosed properties for resale, while instead using the investments to fund their lifestyle. The suspects lied about the prospects and progress of investments and made Ponzi-like payments to investors who threatened litigation.

9. *September 11, Asheville Courier-Tribune* – (International) **Three charged in major credit scam.** Authorities arrested 3 New York men in Randolph County, North Carolina, September 4 after finding at least 200 fraudulent credit cards with international identifications as well as credit-card embossing equipment at an apartment in Randleman. The origin of the credit card numbers is under investigation.

10. *September 14, KUSA 9 Denver* – (Colorado) **Semi carrying wine rear-ends semi carrying mean on I-25.** Colorado State Patrol reported September 14 that southbound lanes of Interstate 25 near mile marker 250 in Berthoud were closed for several hours after a semi-truck carrying wine rear ended another semi-truck carrying meat, causing 1 vehicle to catch fire. One man was injured and officials expected lanes to reopen after clean-up efforts were completed.

11. *September 13, KREM 2 Spokane* – (Washington) **ISP: three dead in Highway 95 collision.** Southbound lanes of Highway 95 in Kootenai County, Idaho, were closed for 4 hours September 12 while crews cleared the scene of a fatal head-on collision that left 3 people dead and 1 injured. The cause of the accident remains under investigation.

12. *September 12, FOX 31 Denver* – (Colorado) **One killed in multivehicle accident on I-70.** Westbound lanes of Highway 1-70 in Denver were closed for 5 hours September 12 while crews investigated a multi-vehicle collision that killed 1 person. The cause of the accident is under investigation.

13. *September 11, Dallas Morning News* – (Texas) **Westbound LBJ reopens hours after tanker truck overturns near Plano Road.** Both directions of LBJ Freeway in Dallas were closed for several hours September 11 while HAZMAT crews cleared the scene after propane or butane fuel spilled from an overturned semi-truck that collided with several other vehicles. No serious injuries were reported.

14. *September 11, KVIA 7 El Paso* – (Texas) **El Paso-Carlsbad highway shut down after pedestrian killed.** Highway 62/180 near mile marker 66 in El Paso, Texas, was shut down for several hours September 11 while police investigated the death of a woman who was found in the middle of the highway.

15. *September 14, U.S. Food and Drug Administration* – (National) **Custom Produce Sales voluntarily recalls Fat Boy Brand and unlabeled cucumbers because of possible health risk.** The U.S. Food and Drug Administration reported September 11 that Custom Produce Sales of Parlier, California voluntarily recalled all its cucumbers sold under the Fat Boy label and unlabeled cucumbers packaged in a black reusable plastic container August 2015 due to potential Salmonella contamination. Fat Boy cucumbers were produced in Baja California and distributed nationwide.

16. *September 11, U.S. Food and Drug Administration* – (National) **The One Minute Miracle Inc. issues voluntarily nationwide recall of Miracle diet 30 due to presence of undeclared phenolphthalein & Miracle Rock 48 due to presence of undeclared thiosildenafil.** North Miami Beach based- The One Minute Miracle Inc., is voluntarily recalling all lots of Miracle Diet 30 capsules and Miracle Rock 48 capsules after an FDA analysis revealed that the dietary supplements contained undeclared phenolphthalein in Miracle Diet 30 and undeclared thiosildenafil in Miracle Rock 48 September 11. The products were distributed via Internet sales nationwide.

17. *September 10, U.S. Department of Labor* – (New York) **Recurring hazards at Wegmans Food Markets Inc. bakery in Rochester, New York, injure 2 workers.** The Occupational Safety and Health Administration cited Wegmans Food Markets Inc., September 10 for 3 repeated and 2 serious violations after a recent inspection at the store in Rochester, New York, revealed hazardous conditions following two 2015 incidents in which a crew member lost his fingertips when cleaning an operating conveyor and a mechanic sustained first degree burns while attempting to repair a valve. Proposed fines total \$188,200.

18. *September 13, Spectrum* – (Utah) **Contaminated water prompts alert in industrial park.** Residents and more than 100 businesses in Fort Pierce Industrial Park were issued a boil water advisory September 13 after a routine water quality test revealed the presence of fecal coliform bacteria September 12. Authorities replaced the contaminated sampling station and flushed the distribution system, and expect the boil advisory to lift September 14.

The health system learned of the April 2013 breach in August 2015 and found no evidence of misuse regarding the information.

Authorities removed the suspicious object and continue to investigate the incident.

The incident was contained to a single housing unit and prompted a lockdown of the prison while authorities investigated.

28. *September 14, Securityweek* – (International) **Attackers use Google Search Console to hide website hacks.** Security researchers from Sucuri discovered that cybercriminals have been using the Google Search Console to improve spam page search engine optimization (SEO) and to hide their presence on hijacked Web sites by receiving notification when hacks are detected, and by unverified legitimate Web site owners.

30. *September 11, Associated Press* – (International) **CVS alerts photo site users after confirming July data breach.** CVS Health Corp., confirmed September 11 that its photo Web site was shut down after investigators detected a data breach potentially resulting in the theft of some CVS customers’ information July 2015. The photo sites of Rite Aid, Costco, and Wal-Mart Canada were also affected in the breach and the company expects to contact potentially-affected customers September 11. 31. *September 11, WTHI 10 Terre Haute* – (Indiana) **Officials report nothing found in Linton Wal-Mart after bomb threat made.** Police authorities reported September 11 that the Wal-Mart in Linton, Indiana, was evacuated and closed while officials searched the building after the store manager received a bomb threat and notified police authorities. Damages total \$1.5 million and the cause of the blaze remains under investigation.
