- American Honda Motor Company, Inc., recalled 303,904 Accord sedan vehicles October 29 after determining the side Supplemental Restraint System software requires updating due to premature deployment of the side curtain airbags. – *Honda.com* (See item [3](#))

## Nuclear Reactors, Materials, and Waste Sector

1. *November 2, U.S. Federal Register* – (National) **Cyber security event notifications.** The U.S. Nuclear Regulatory Commission adopted new rules effective December 2 to guide nuclear power plants following the commission’s analysis on the reliability and effectiveness of nuclear power reactor licensees. The guidelines establish new cyber security event notification requirements, codify certain reporting activities, and help provide high assurance that communication systems and digital computers and networks are providing adequate protection against cyber-attacks.

2. *October 30, Agence France-Presse* – (International) **Porsche recalls close to 60,000 vehicles over leak.** Porsche AG issued a recall October 30 for 58,881 Macan S and Macan Turbo models worldwide, including 21,835 in the U.S., due to risks of engine leaks as a result of low-pressure fuel lines in the engine compartment. There have been no reported accidents due to the issue.

3. *October 29, Honda.com* – (National) **Statement by American Honda regarding side airbag inadvertent deployment recall: 2008 – 2009 Honda Accord sedan.** American Honda Motor Company, Inc., issued a recall October 29 for 303,904 model year 2008 – 2009 Accord sedan vehicles after the company determined that the side Supplemental Restraint System (SRS) software requires updating due to premature deployment of the side and/or side curtain airbags if the ignition is on and a door is forcefully slammed, or if the vehicle’s underbody receives significant impact. The issue is related to the side impact deployment threshold specification and Honda has received 19 injury claims related to the problem.

4. *October 30, Reuters* – (National) **BofA reaches \$335 mln settlement over mortgages, MERS.** Charlotte, North Carolina-based Bank of America Corp reached a \$335 million settlement with the U.S. Securities and Exchange Commission October 30 to resolve accusations that the bank misled shareholders about its exposure to risky mortgage securities and its dependence on an electronic mortgage registry known as MERS.

5. *October 30, Associated Press* – (Texas) **South Texan faces \$5M securities fraud, theft charges.** A South Texas man was indicted October 26 for securities fraud, theft, and money laundering due to his alleged involvement in a \$5 million investment scam in the Alice area since 2013.

## Transportation Systems Sector

6. *November 1, KMGH 7 Denver* – (Colorado) **Wrong-way driver caused crash that shut down westbound I-70 in Denver overnight, police said.** Interstate 70 in Denver was shut down overnight November 1 while crews cleaned up and investigated 2 separate crashes after a wrong-way driver collided with a car, while another vehicle was hit when pulling over to call 9-1-1. The wrong-way driver was hospitalized and another person was injured in the second collision.

7. *November 1, Easton Express-Times* – (Pennsylvania) **Police investigate crash that shut-down I-80 for 6 hours.** Interstate 80 near mile marker 295 in Pocono Township was shut down for 6 hours November 1 while crews cleared the scene of a single-vehicle accident that injured both the passenger and driver. The cause of the crash remains under investigation.

8. *October 31, Chicago Tribune* – (Illinois) **Service resumes on CTA Red Line after derailment.** The Chicago Transit Red Line resumed service October 31 after being shut down for 5 hours while officials responded to a train derailment on the North Side, prompting passengers to evacuate the train.

9. *October 31, WJXT 4 Jacksonville* – (Florida) **1 dead, 13 hospitalized from I-75 crashes.** Interstate 75 and all northbound lanes of Interstate 10 in Columbia County were shut down for several hours October 30 due to 2 separate accidents that killed 1 person and injured 13 others.

10. *October 30, KTBC 7 Austin* – (Texas) **Electrical damage at ABIA leads to cancellations, delays.** Austin Bergstrom International Airport officials reported that major floods following recent heavy storms caused electrical failures and equipment damage at the air traffic tower and the radar approach facility, causing air traffic controllers unable to direct aircrafts and provide limited service October 30. Houston George Bush Intercontinental Airport took control of all flights in and out of the Austin airport while the U.S. Federal Aviation Administration brought a portable air traffic control tower from storage in Kansas City to Austin.

11. *November 2, NBC News* – (Washington; Oregon) **43 Washington and Oregon Chipotle restaurants closed after E. coli outbreak.** Health officials reported October 31 that 43 Chipotle restaurants in Washington and Oregon were closed indefinitely after the Washington State Department of Health announced 19 cases of E. coli in Washington and 3 in Oregon tied to the chain. The company is working with health officials to determine the cause of the outbreak.

12. *November 1, KCBD 11 Lubbock* – (National) **All American Meats, INC. recalls ground beef due to possible E. coli contamination.** Omaha, Nebraska-based All American Meats, Inc., issued a voluntary recall November 1 for approximately 167,427 pounds of its ground beef products after in-commerce surveillance program testing revealed positive results for E. coli. The items were shipped nationwide and customers were advised to discard any unused products.

13. *November 1, U.S. Department of Agriculture* – (California) **Ready Pac Foods, Inc. recalls salad kit products due to misbranding and undeclared allergens.** Irwindale, California-based Ready Pac Foods, Inc., issued a voluntary recall for approximately 265 pounds of its Bistro Salad Kit with Grilled Chicken products packaged in 15-ounce bowls November 1 due to misbranding and undeclared allergens after initial launch sample testing revealed that the bowls possessed the wrong dressing, which contained anchovies and eggs. The products were shipped to retail locations in California.

14. *October 30, U.S. Food and Drug Administration* – (Minnesota) **Northstar Produce Inc. recalls Granny Smith Size 175 apples because of possible health risk.** St. Louis Park-based Northstar Produce Inc., recalled 33 cases of its Granny Smith Size 175 count apples October 26 after sample testing revealed positive traces of Listeria

monocytogenes, Salmonella, and Enterohemorrhagic E. coli. The products were sold at Mike's Discount Foods stores in Minnesota.

15. *October 30, U.S. Food and Drug Administration* – (National) **Kar's Nuts recalling certain packages of Sweet 'N Salty Mix.** Kar's Nuts, Inc., issued a voluntary recall October 22 for a limited number of packages of its Sweet 'N Salty Mix products after consumer reports revealed that a hard, clear foreign material was found in several packages.

16. *October 30, U.S. Food and Drug Administration* – (Oregon) **Farmer Creek is issuing a voluntary recall on canned albacore tuna products because of a possible health risk.** Cloverdale, Oregon-based Farmer Creek issued a voluntary recall October 30 for its canned albacore tuna products manufactured by Skipanon Brand Seafoods LLC due to potential Clostridium botulinum contamination after an inspection at the manufacturer revealed that the products may have been under-processed. The products were sold to farm stands and farmers markets in Oregon.

17. *October 30, U.S. Food and Drug Administration* – (National) **Giant Food alerts customers to voluntary recall of Nature's Promise Organic Edamame.** Landover, Maryland-based Giant Food, LLC recalled Nature's Promise Organic Edamame products October 30 due to misbranding and undeclared soy. The products were taken off store shelves and customers were advised to discard any unused products.

18. *October 30, U.S. Food and Drug Administration* – (National) **Stop & Shop alerts customers to voluntary recall of Nature's Promise Organic Edamame.** The Stop & Shop Supermarket Company LLC recalled Nature's Promise Organic Edamame products October 30 due to misbranding and undeclared soy. Customers were advised to discard any unused products or return the products for a full refund.

19. *November 2, USA Today* – (Texas) **2M gallons of sewage spills in Houston bayous.** Recent heavy storms in the Houston area overwhelmed the waste water system and caused more than 2 million gallons of sewage to spill out at 4 sites and potentially influenced Halls, White Oak, Brays, and Sims bayous October 31. Officials issued a water advisory to the public.

20. *October 30, Del Ray Patch* – (Washington, D.C.) **Reagan National Airport jet fuel spills into Potomac River.** Officials reported that an estimated 7,500 to 9,000 gallons of Jet A aviation fuel spilled into the Potomac River south of Regan Washington

National Airport October 29. The source of the spill is secure and all recoverable fuel was removed from storm water overflow drains on the airport property, while crews continued to clean the scene with an estimated completion date of October 31.

21. *November 1, Ogden Standard-Examiner* – (National) **4,800 McKay-Dee patients could have been exposed to hepatitis C.** McKay-Dee Hospital in Ogden notified nearly 4,800 patients October 30 that they may have been exposed to hepatitis C between June 2013 and November 2014 after the Utah Department of Health notified the hospital that a former nurse and a patient treated at the hospital's emergency department were both infected with the same hepatitis genotype. The incident is under investigation and authorities reported that the former nurse was terminated after allegedly admitting to diverting drugs from the emergency department.

22. *November 2, WEWS 5 Cleveland* – (Ohio) **Eastlake Middle School, Thomas Jefferson Elementary School closed due to power outage.** Thomas Jefferson Elementary School and Eastlake Middle School in Eastlake, Ohio, were closed November 2 due to a power outage.

23. *October 30, U.S. Immigration and Customs Enforcement* – (California) **4 men indicted in destructive national forest marijuana grow.** Federal and State authorities charged 4 men October 29 for their alleged roles in a marijuana cultivation operation at the Sequoia National Forest in California after law enforcement agents found 2,608 plants and toxic chemicals, fertilizer, and trash from the site. Officers determined that the cultivation activities caused significant damage to the land and natural resources.

24. *November 1, Softpedia* – (International) **Latest flash zero-day bug already part of the Angler and Nuclear exploit kits.** Researchers from Malwarebytes detected that recent

versions of the Angler and Nuclear exploit kits (EK) were actively integrating and using a previously patched Adobe zero-day flaw that affected several Flash versions on Windows and Linux systems which could allow successful exploitation causing a crash and allowing the hacker to take control of the affected system. Experts recommended that users disable Flash in browsers while it is not in use.

25. *November 1, WHAS 11 Louisville* – (Kentucky) **Jeffersontown fire kills one, leaves 19 others homeless.** An October 31 fire at the Regency Three Condominiums in Louisville caused significant damage to the building, displacing 19 people and killing 1 other while firefighters contained the incident. Officials are investigating the cause of the fire.

26. *October 30, Reuters* – (California) **Twelve taken to hospital over chemical odor at California hotel.** Officials reported October 30 that a chemical odor at a Westin hotel in Palo Alto prompted the evacuation of first floor residents and sent 12 people to area hospitals for respiratory irritant issues. HAZMAT crews could not identify the source of the odor, and cleared the scene of any toxic fumes.
