# Executive Summary

DHS secures our Nation's air, land, and sea borders to prevent illegal activity while facilitating lawful travel and trade. DHS's border security and management efforts focus on three interrelated goals: effectively securing U.S. air, land, and sea borders; safeguarding and streamlining lawful trade and travel; and disrupting and, in coordination with other federal agencies, dismantling transnational criminal and terrorist organizations.

DHS is working to secure U.S. borders through the unprecedented deployment of personnel, technology, and infrastructure. The integration of intelligence and enforcement capabilities through intergovernmental task forces and partnerships has facilitated better information sharing, leading to the increased interdiction of drugs, weapons, and currency. By focusing on the largest threats and responding rapidly, DHS has strengthened security across the U.S. borders while facilitating international travel and trade.

Highlights for FY 2020 Q4 compared to FY 2019 Q4 include:

- U.S. Customs and Border Protection (CBP) U.S. Border Patrol (USBP) apprehensions decreased 14 percent in FY 2020 Q4 (141,347) compared to FY 2019 Q4 (165,300) (Table 1).
- CBP USBP apprehensions of Mexican nationals increased 134 percent in FY 2020 Q4 (100,882) compared to FY 2019 Q4 (43,103) (Table 2).
- CBP USBP apprehensions of non-Mexican nationals decreased 67 percent in FY 2020 (40,465) compared to FY 2019 Q4 (122,197) (Table 3).
- DHS removals decreased by 72 percent in FY 2020 (25,411) compared to FY 2019 Q4 (90,715) (Table H1).
- DHS returns decreased 31 percent in FY 2020 Q4 (30,645) compared to FY 2019 Q4 (44,300) (Table H1).

Highlights for FY 2020, with no quarterly breakdown, compared to FY 2019 include:

- CBP USBP apprehensions decreased 53 percent in FY 2020 (405,020) compared to FY 2019 (859,501) (Table 1).
- CBP USBP apprehensions of Mexican nationals increased 50 percent in FY 2020 (254,633) compared to FY 2019 (169,536) (Table 2).
- CBP USBP apprehensions of non-Mexican nationals decreased 78 percent in FY 2020 (150,387) compared to FY 2019 (689,965) (Table 3).
- DHS removals decreased by 35 percent in FY 2020 (231,908) compared to FY 2019 (356,098) (Table H1).
- DHS returns decreased 3 percent in FY 2020 (166,202) compared to FY 2019 (170,565) (Table H1).

# I. Legislative Language

This report was prepared pursuant to the direction in Senate Report 116-125 accompanying the Fiscal Year (FY) 2020 Department of Homeland Security (DHS) Appropriations Act (P.L. 116-93). Senate Report 116-125 states:

*Public Reporting of Operational Statistics.*—The Committee continues its requirement that the Department submit quarterly Border Security Status reports and data on the deportation of the parents of U.S.-born children semiannually, as in prior years.

## II. Background

### A. Overview of Congressional Mandate

This Border Security Status Report (BSSR) includes data for the fourth quarter (Q4) of FY 2020. The BSSR is a revised version of the Secure Border Initiative report, which last was released with data through FY 2010.

The original *Quarterly Status Report on the Department of Homeland Security's Border Security Performance and Resources* was provided in 2006 in response to a letter from the House Appropriations Committee. The data included in the BSSR overlap with many of those in prior border security performance and resources reports; however, the BSSR excludes detailed program descriptions, accomplishments, and resource information. The list of data provided in this report was reviewed with committee staff and is described in Section B.

### B. Data Presented

There are 25 figures and 19 tables in the body of this report and 32 tables in the appendix that provide data on the enforcement-related activities listed below. This report provides data on the following categories of border security and immigration enforcement-related activities:

- Apprehensions, administrative arrests, and inadmissible noncitizens;<sup>1</sup>
- Notices to appear (NTA);
- Criminal arrests;
- Legal entries;
- Detention;
- Removals and returns;
- Worksite enforcement and E-Verify;
- Seizures: drugs, weapons, and currency;
- U.S. Customs and Border Protection (CBP) and U.S. Immigration and Customs Enforcement (ICE) staffing;
- Violence against CBP and ICE agents and officers; and
- Operation Stonegarden grants.

### C. Summary of Changes

Tables and figures have been updated with data for the new reporting period and updated to show this fiscal year's individual quarterly data. Data for the previous fiscal year's quarters have been shifted to single-year columns and/or to the appendix, as indicated.

### III. Results/Analysis

DHS's Office of Immigration Statistics (OIS) compiles the BSSR from data received from DHS Components. The compilation of these data shows specifics and trends as shown below.

#### A. Data Trends

Highlights for FY 2020 Q4 compared to FY 2019 Q4, as well as for all of FY 2020 compared to all of FY 2019, include:

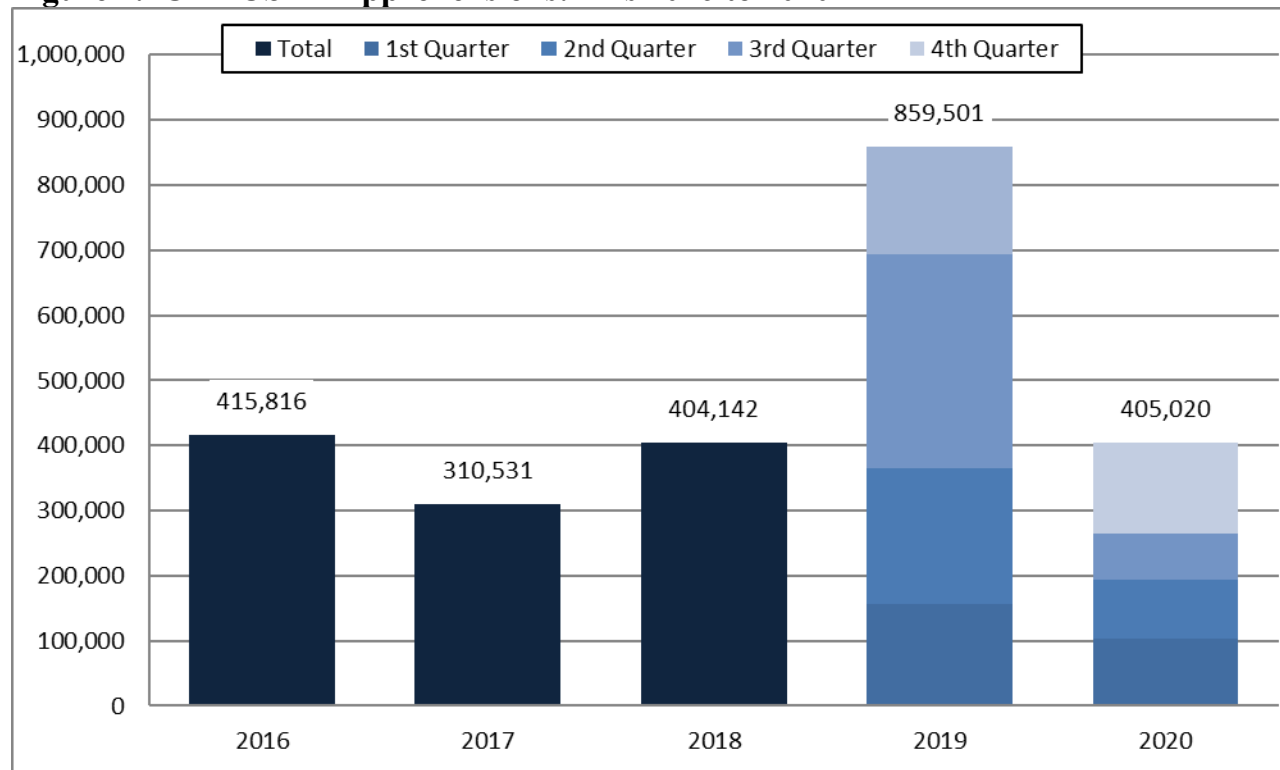

The figures and tables in this section include notes about the data sources and, where applicable, descriptions of changes in definitions over time or in data compared to past reports. Quarterly data, when not included in the Results/Analysis (Section III), are provided in the appendices (Section IV, Appendix C, and Data Tables). The data included in this report were provided by CBP, ICE, and U.S. Citizenship and Immigration Services (USCIS) and may differ from data independently reported by each Component because of differences in data compilation or reporting practices. Moreover, Component systems frequently are “living,” meaning that such systems accept corrections, modifications, and new entries for a period. As a result, data

provided to OIS are a snapshot as of a specific date, and numbers retrieved on a subsequent date may differ from those originally provided.

## B. Apprehensions, Administrative Arrests, and Inadmissible Noncitizens<sup>2</sup> (Figures 1-4 and Tables 1-4)

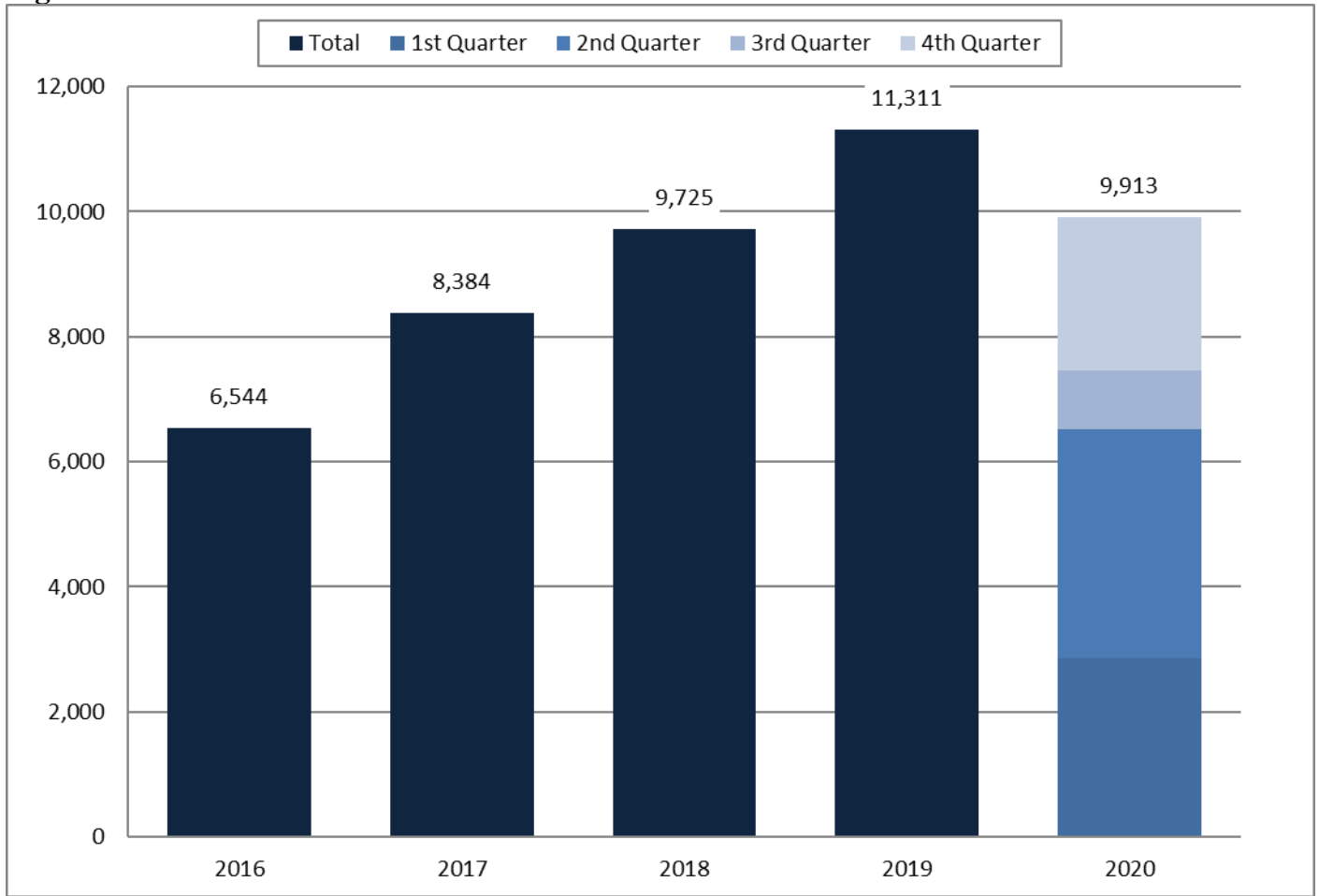

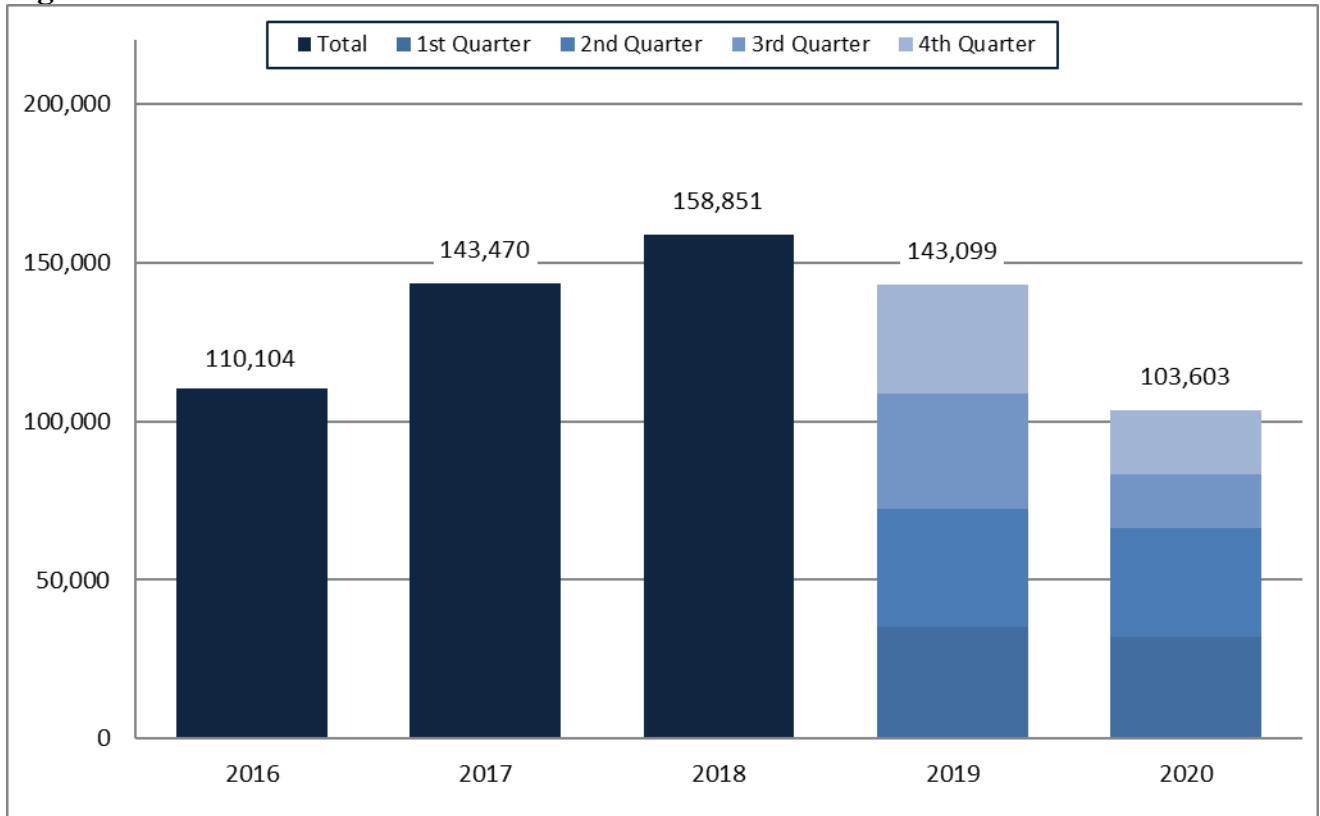
**Figure 2. ICE HSI Administrative Arrests: FYs 2016 to 2020**

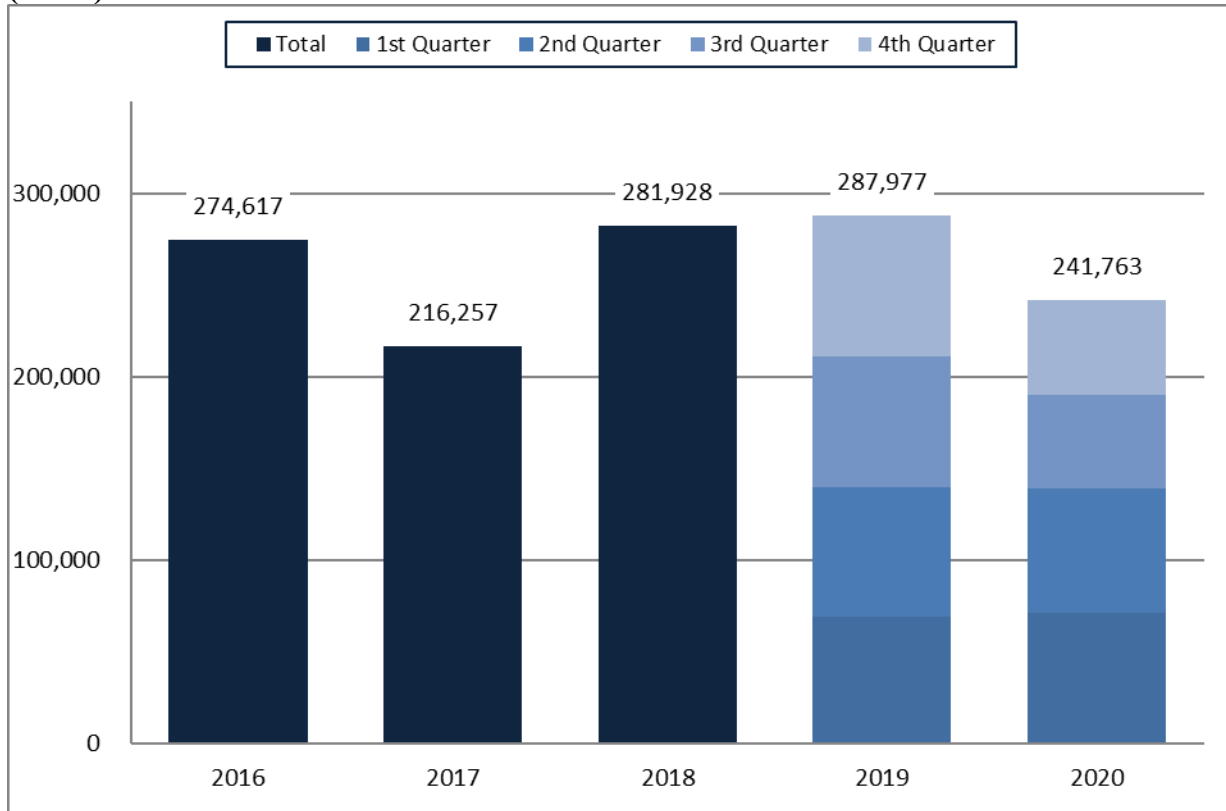
**Figure 3. ICE ERO Administrative Arrests: FYs 2016 to 2020**

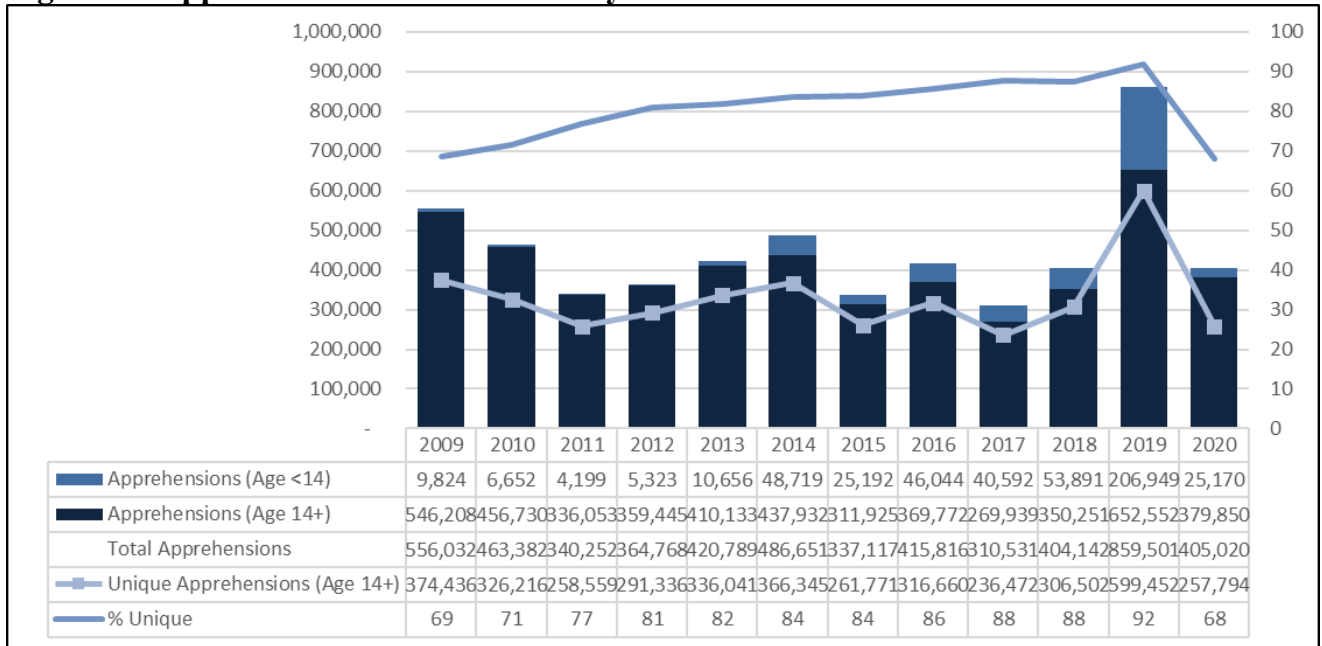

### C. Unique Individuals Apprehended by CBP USBP (Figure 5)

With the Automated Biometric Identification System (IDENT), fingerprint records can be matched, making it possible to count both the number of unique individuals apprehended and the total number of apprehensions (Figure 5). Because of data collection procedures, data are tabulated at the end of the fiscal year.

**Figure 5. Apprehensions from IDENT by CBP USBP: FYs 2009 to 2020**



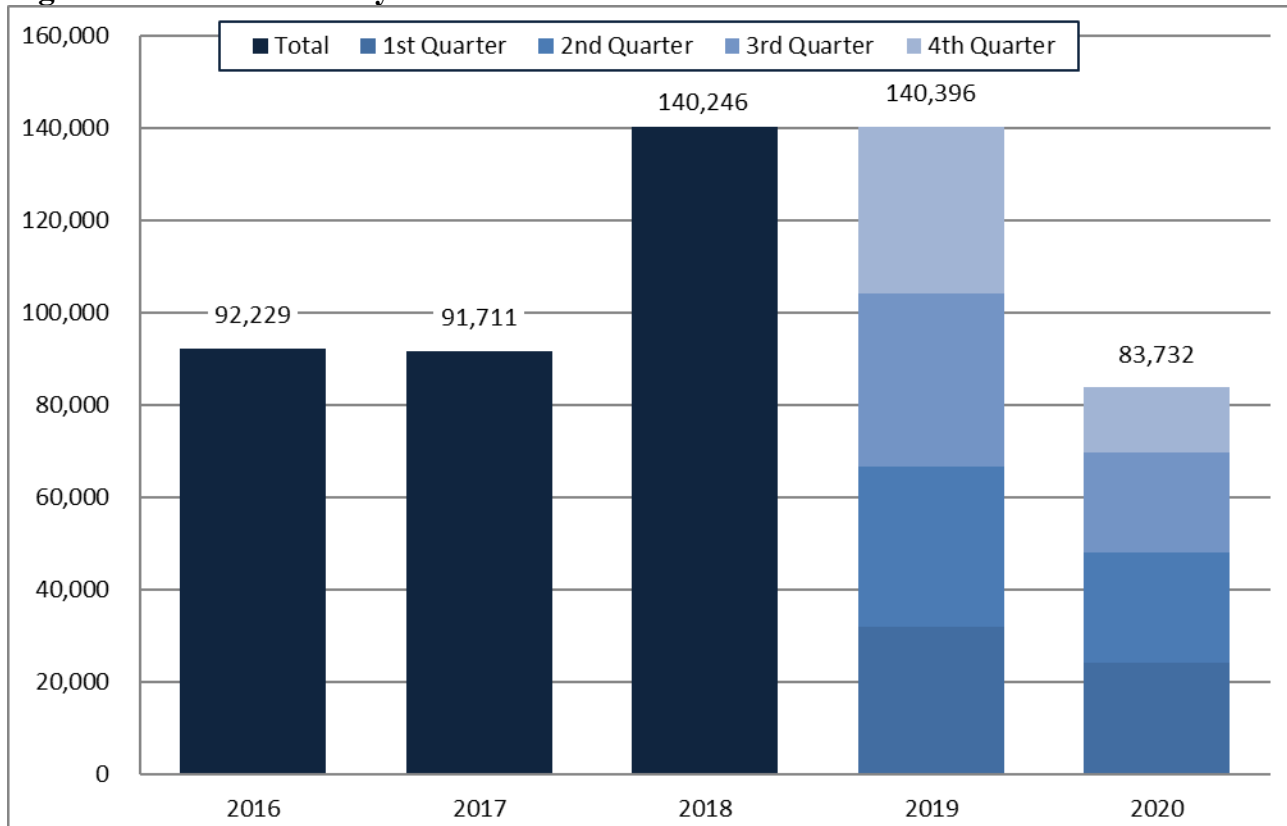

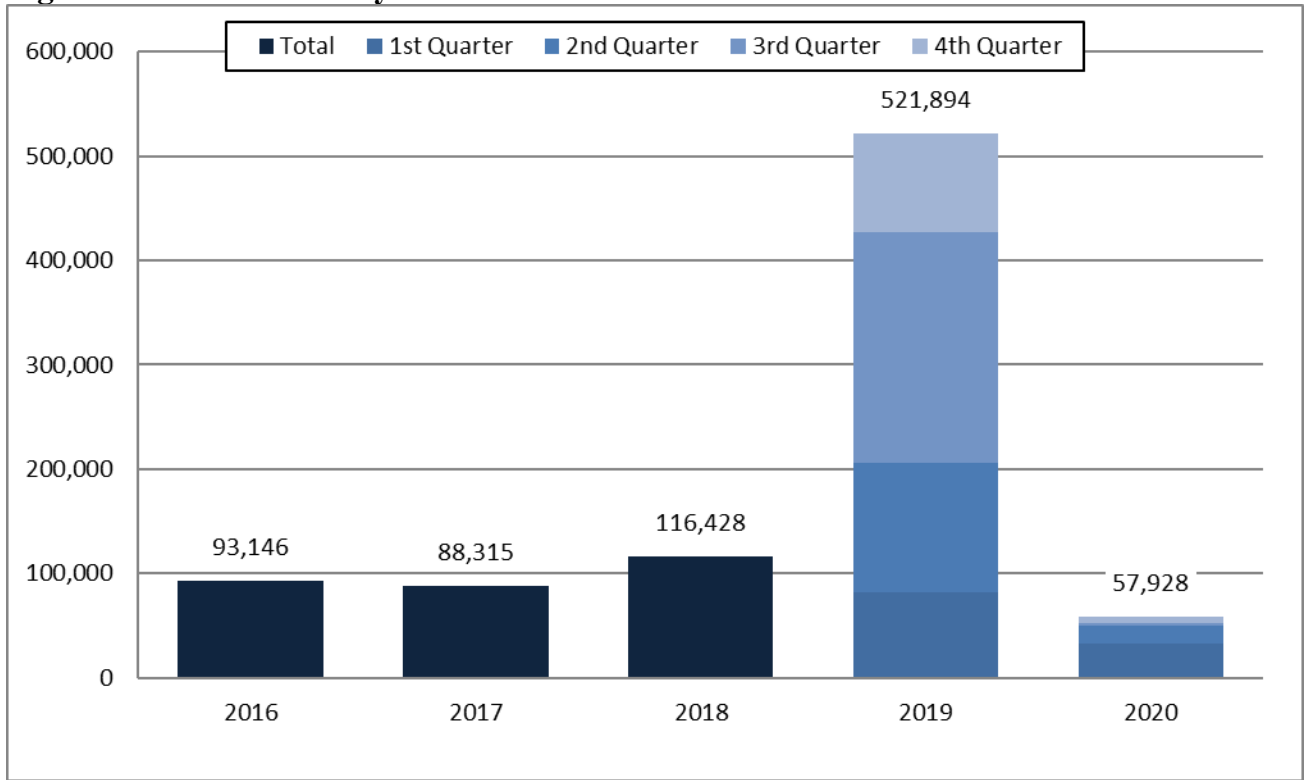
**Figure 6. NTAs Issued by USCIS: FYs 2016 to 2020**

## D. NTAs Issued (Figures 6-9) and USCIS Fraud Cases Referred to ICE (Figure 10)

NTAs are served on noncitizens and, once filed with an immigration court, initiate civil immigration removal proceedings against a noncitizen before an immigration judge with the U.S. Department of Justice Executive Office for Immigration Review. This section includes NTAs issued by USCIS, CBP USBP, CBP OFO, and ICE ERO, as well as the number of applications accepted by ICE for investigation under suspicion of fraud by USCIS.

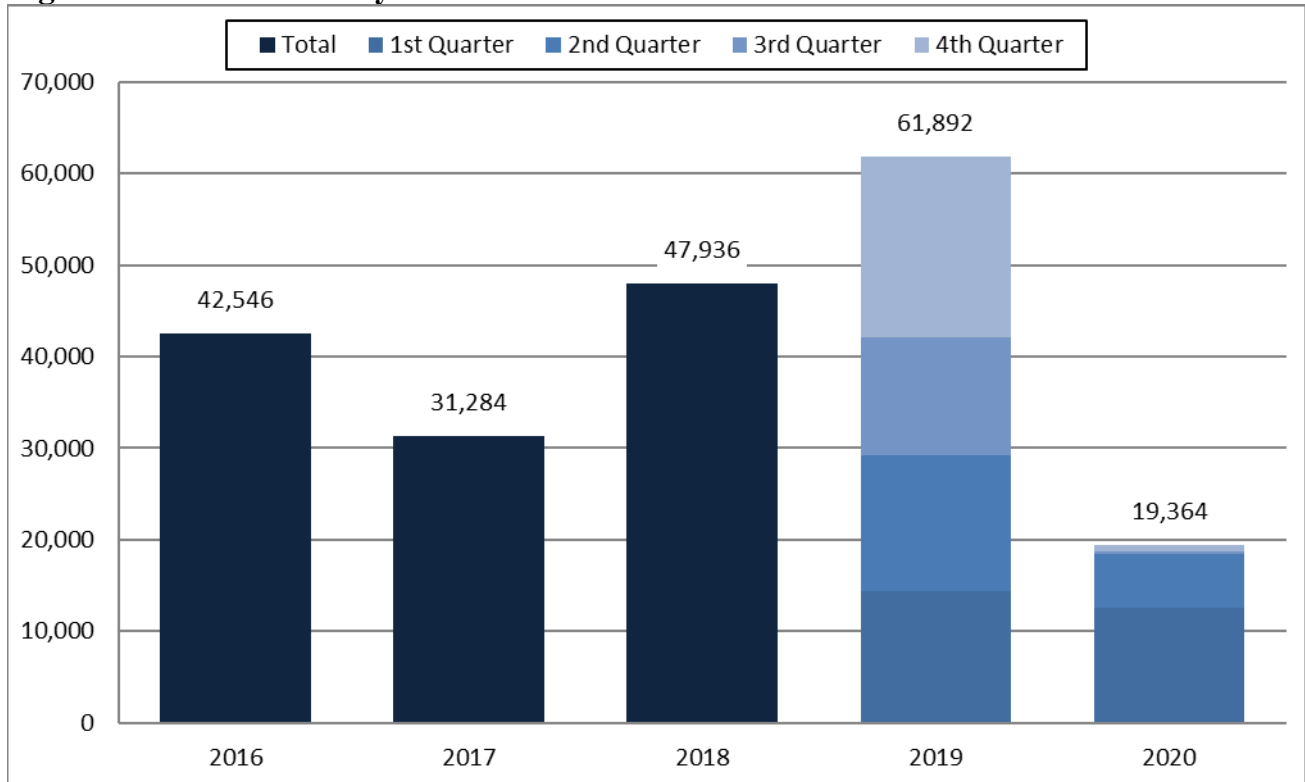

**Figure 7. NTAs Issued by CBP USBP: FYs 2016 to 2020**



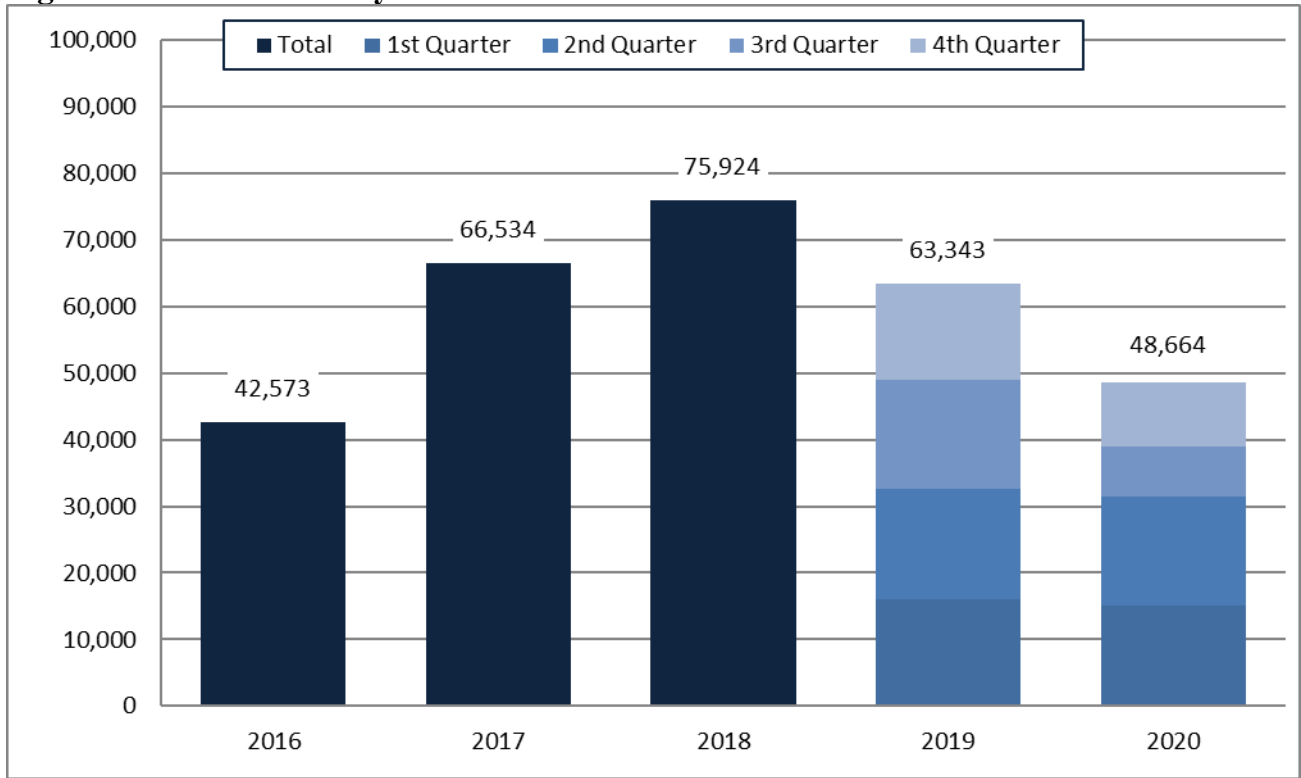

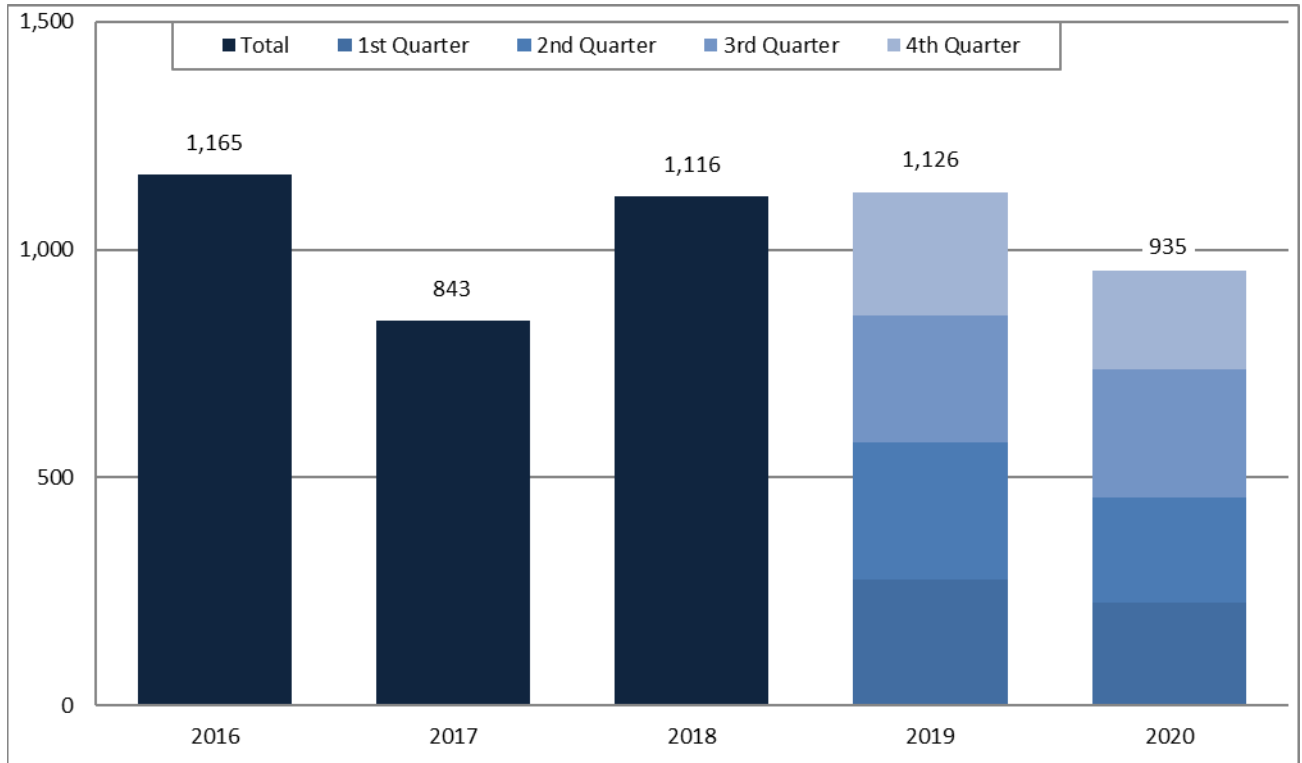
**Figure 9. NTAs Issued by ICE ERO: FYs 2016 to 2020**

**Figure 10. USCIS Fraud Cases Referred to ICE for Criminal Investigation: FYs 2016 to 2020**



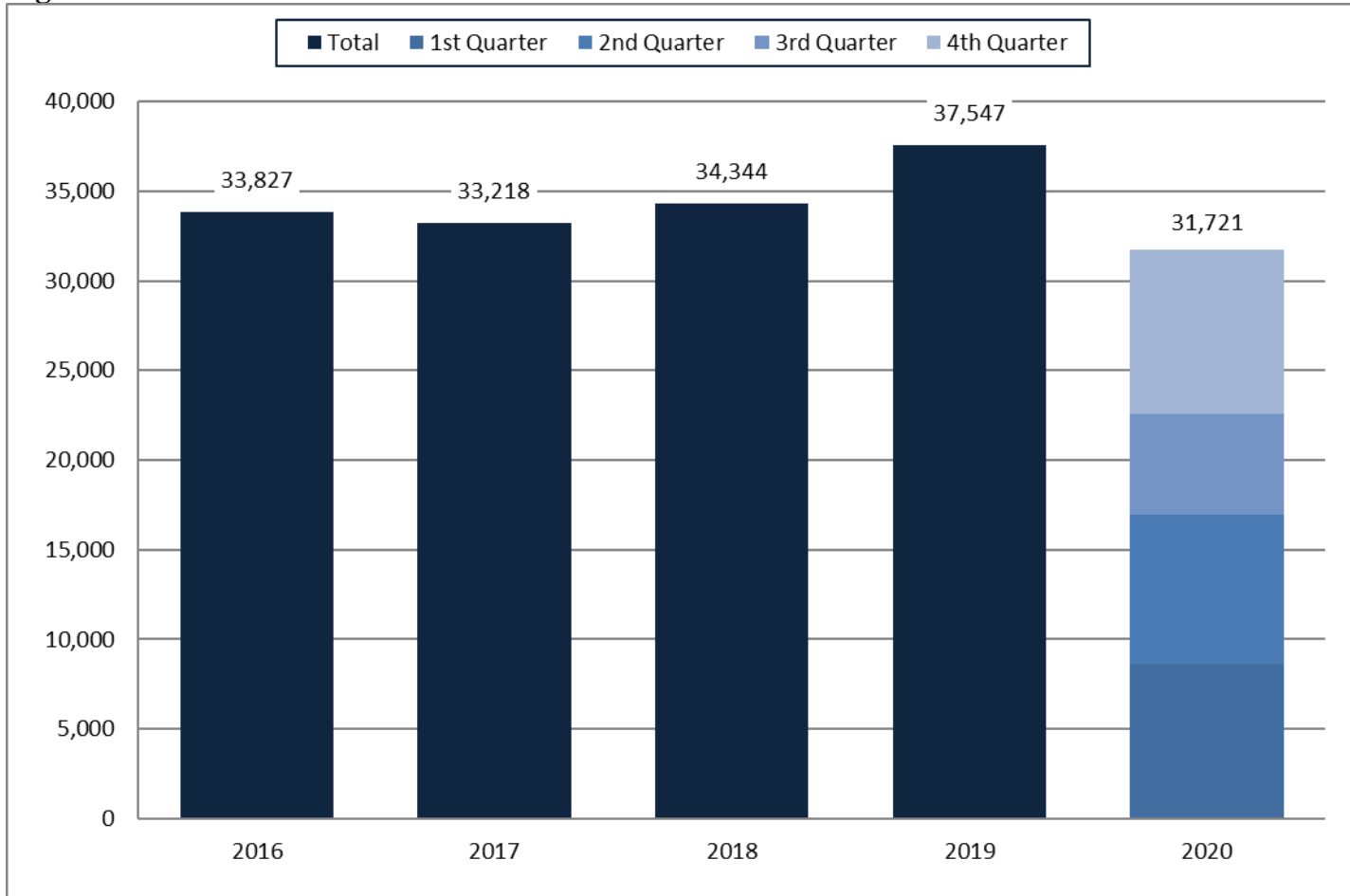

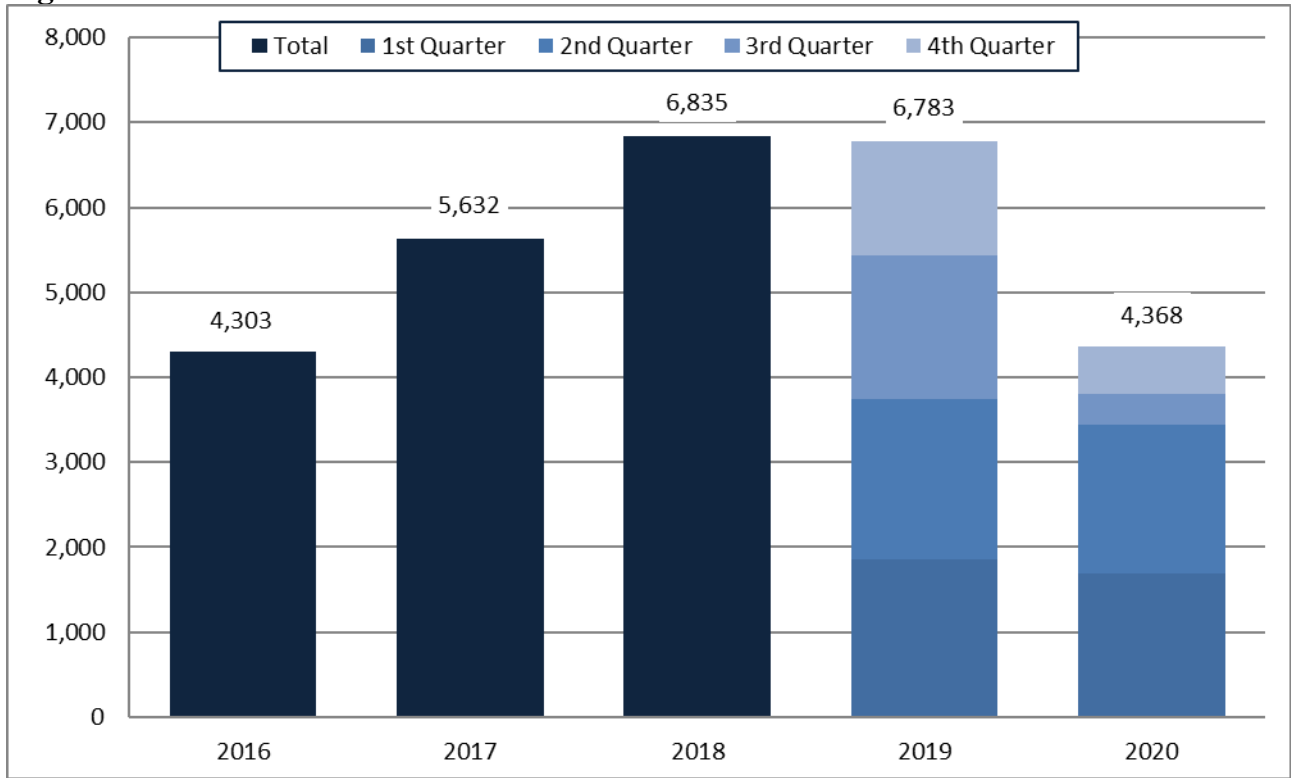
**Figure 11. ICE HSI Criminal Arrests: FYs 2016 to 2020**

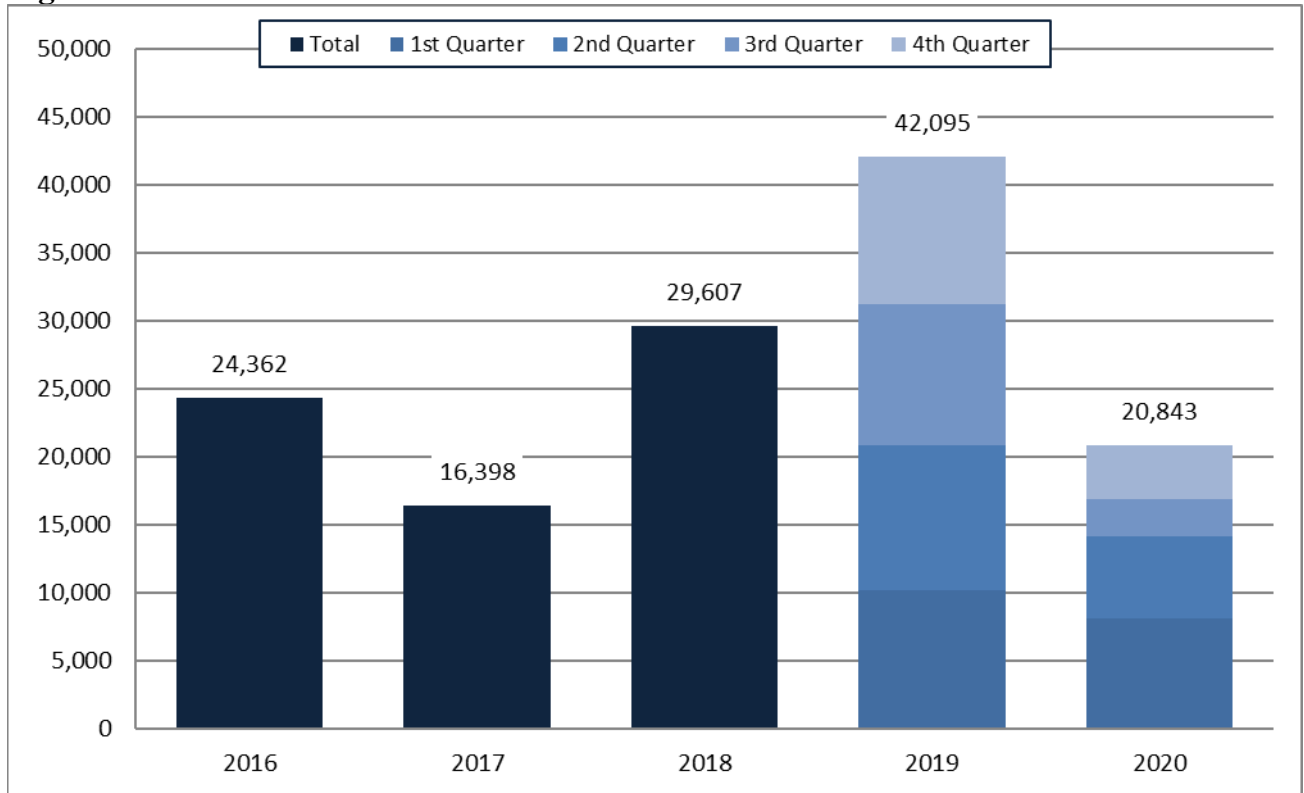
**Figure 12. ICE ERO Criminal Arrests: FYs 2016 to 2020**

**Figure 13. CBP OFO Criminal Arrests: FYs 2016 to 2020**



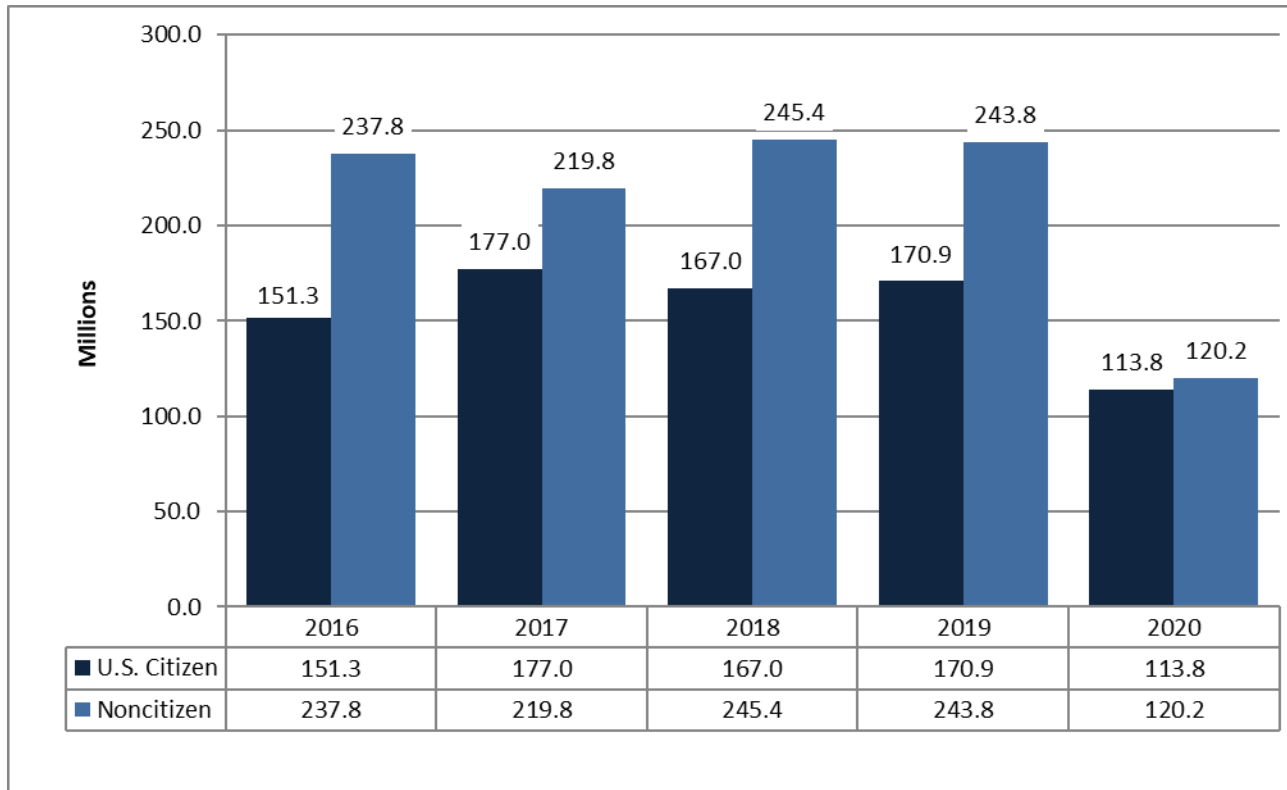

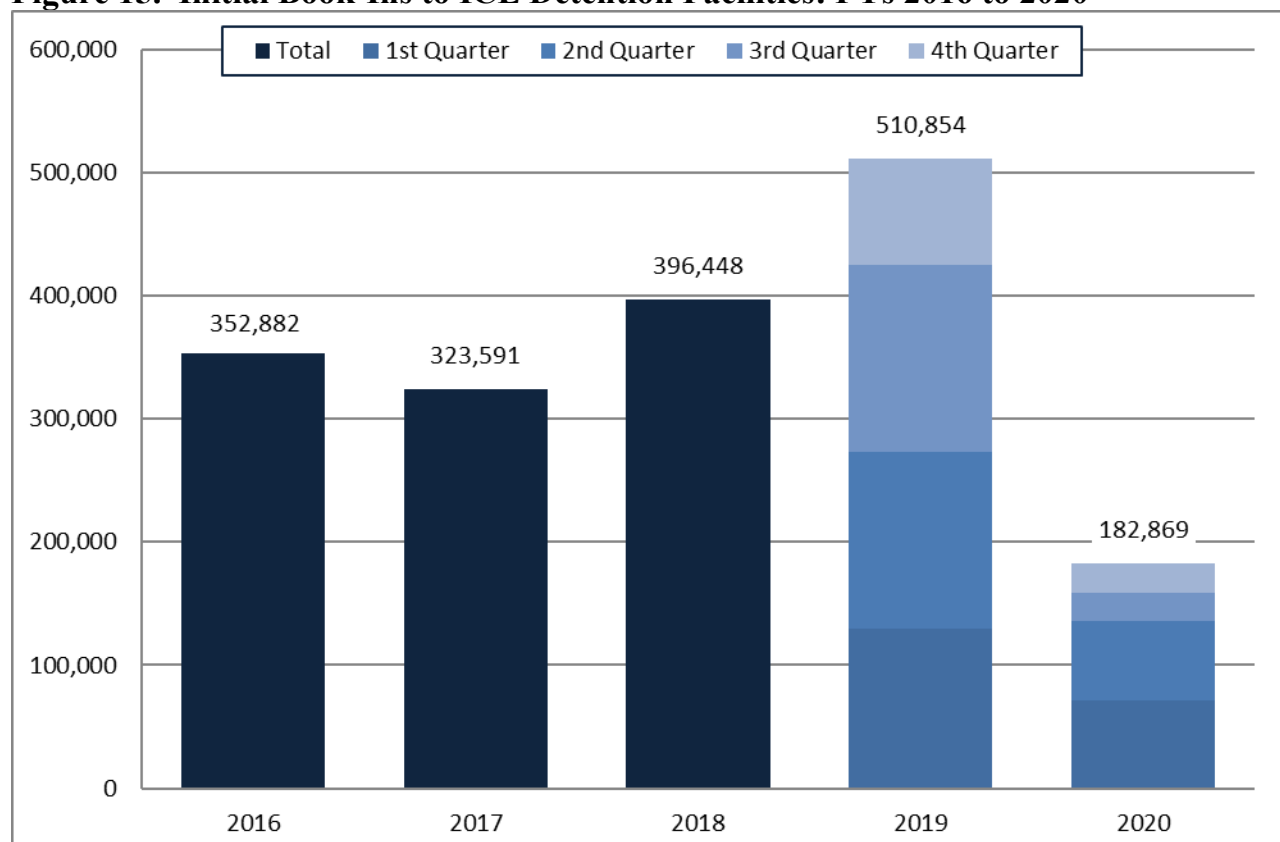

## G. Detention (Figures 15-17 and Tables 6-8)

Removable noncitizens who are apprehended by CBP and ICE and are determined to warrant custodial supervision are placed in detention facilities that are managed by ICE ERO. Noncitizens detained by ICE are housed in local or state government facilities under intergovernmental service agreements (IGSA), contract detention facilities, and ICE-owned facilities (service processing centers). ICE sometimes uses Federal Bureau of Prisons-controlled facilities to house immigration detainees, but this practice generally is in limited circumstances and is accomplished using an interagency agreement. Detentions were much lower in 2020 compared to 2019, in part because apprehensions in 2020 were at less than half of the level compared to the previous year (see Figure 1). In addition, in April 2020, a U.S. district court judge ordered ICE to identify and review custody of certain detained noncitizens because of Coronavirus Disease 2019 considerations and risk factors.<sup>3</sup>

**Figure 15. Initial Book-Ins to ICE Detention Facilities: FYs 2016 to 2020**

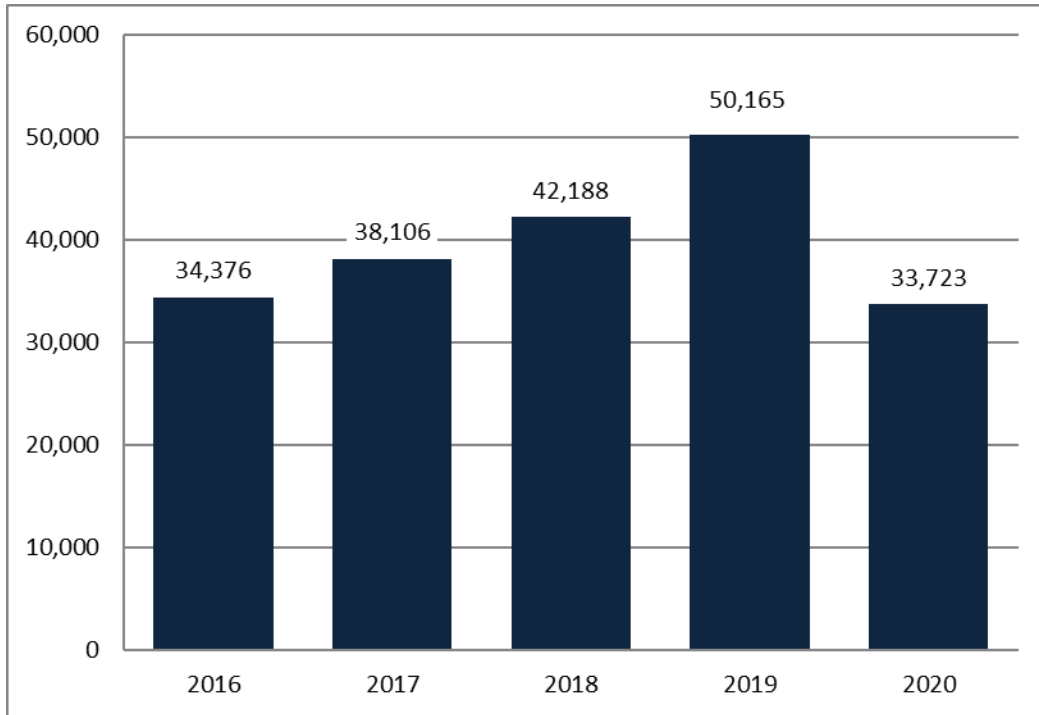

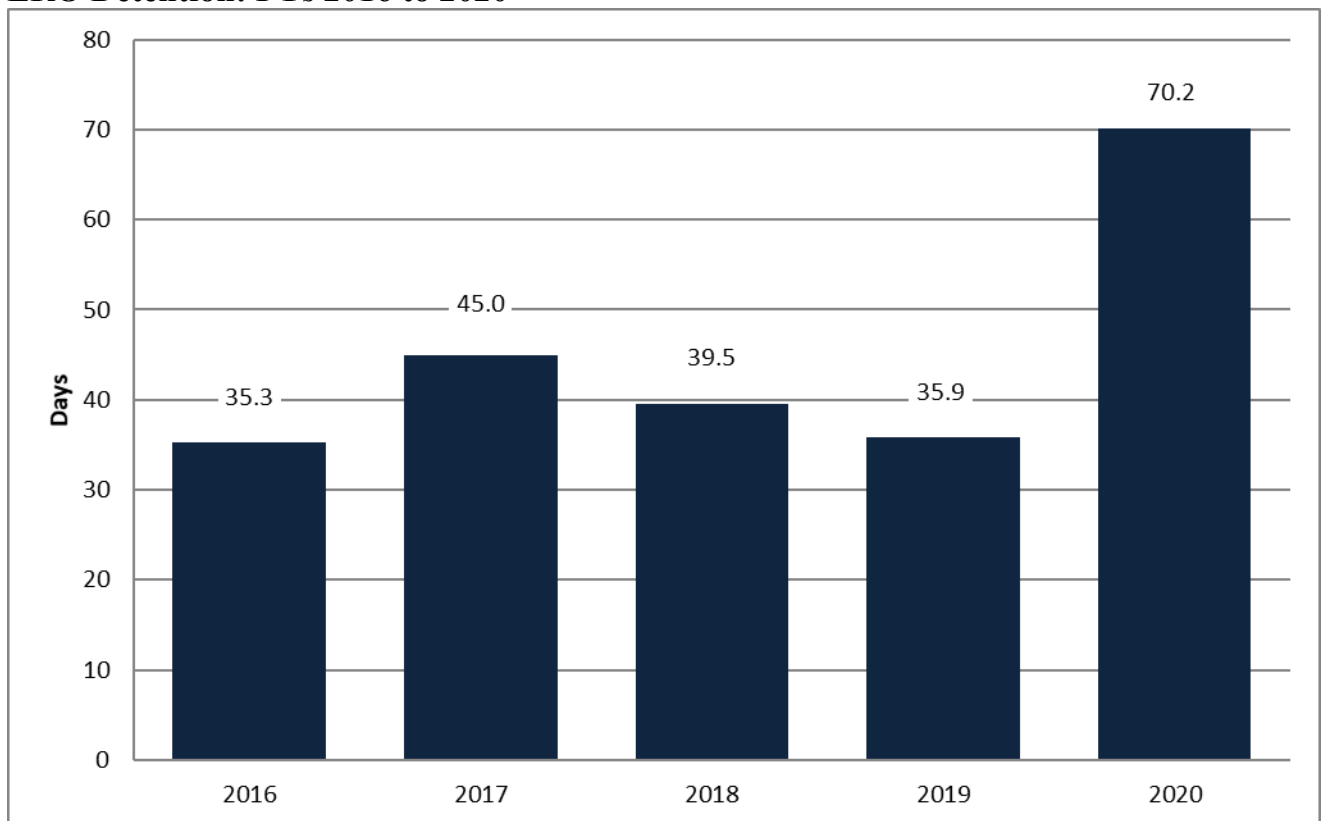

ERO Detention: FYs 2016 to 2020**



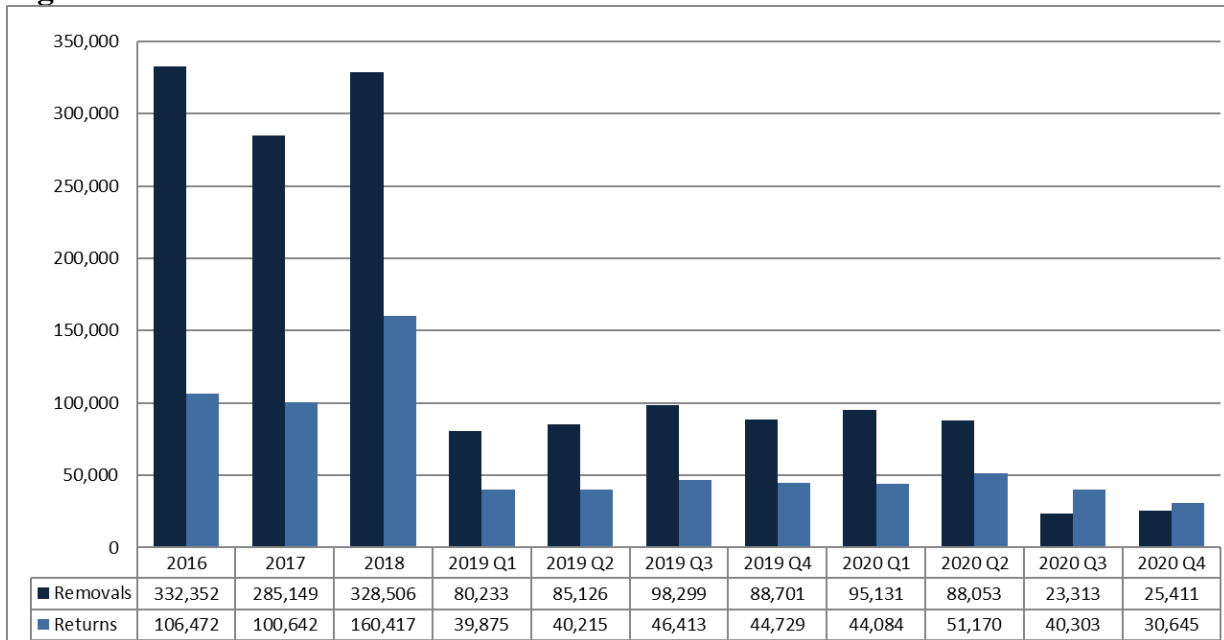

## H. Removals and Returns (Figure 18)

Noncitizen removals refer to repatriations of inadmissible or removable noncitizens subject to a final order of removal, whereas returns refer to confirmed departures of inadmissible or removable noncitizens. This report includes fiscal year removals effectuated and returns conducted by both CBP and ICE. A noncitizen who is removed may be subject to additional administrative or criminal consequences upon subsequent illegal reentry owing to the fact of the removal.

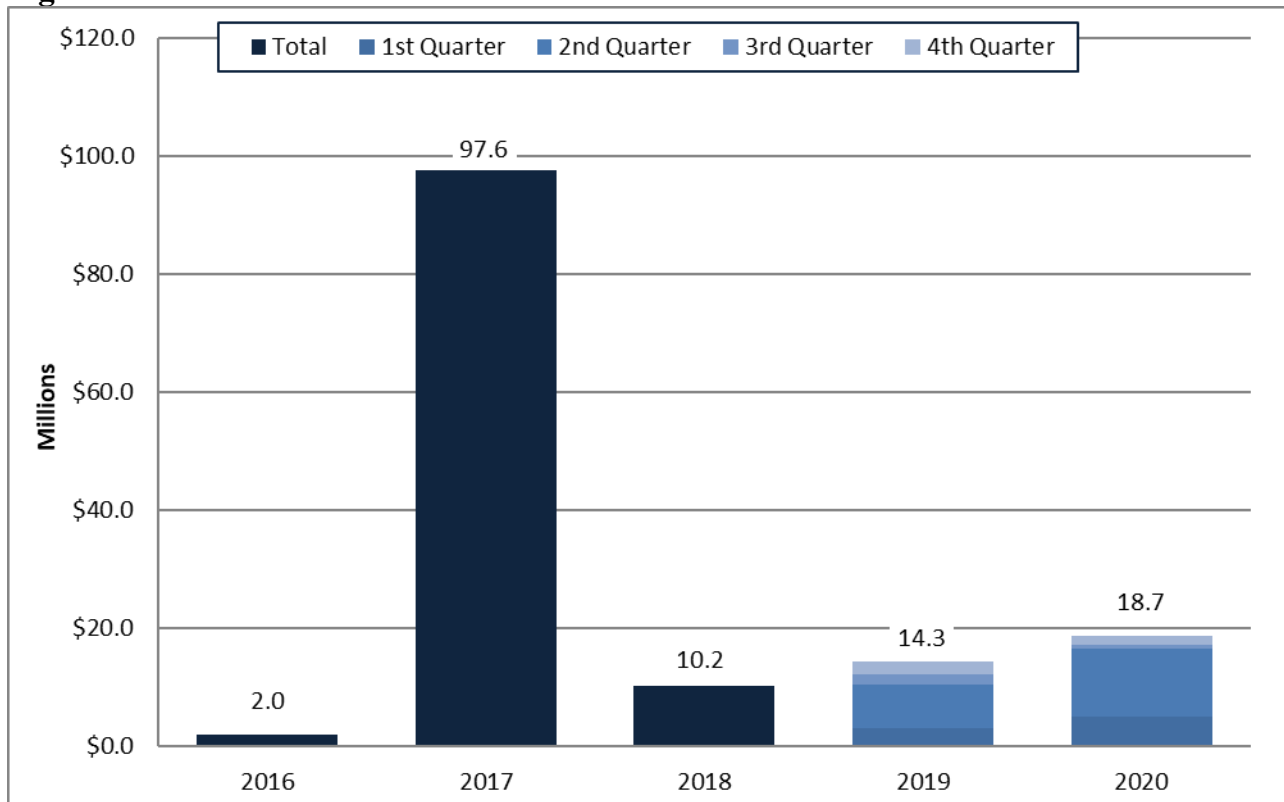

The number of employers registered for E-Verify and the number of queries each year also are provided below. For the purposes of the E-Verify program, each query represents one new hire or new verification.

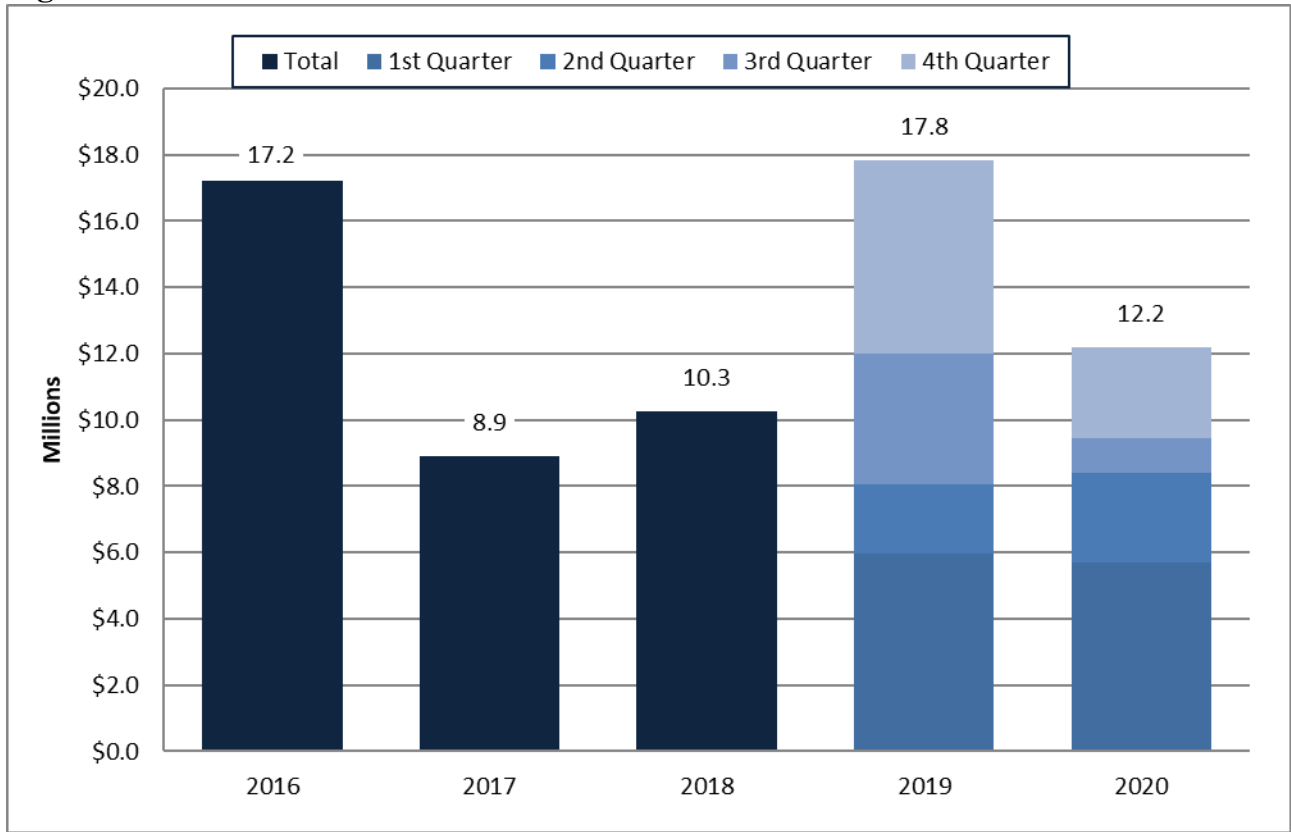
**Figure 19. Worksite Enforcement – Criminal Fines: FYs 2016 to 2020**

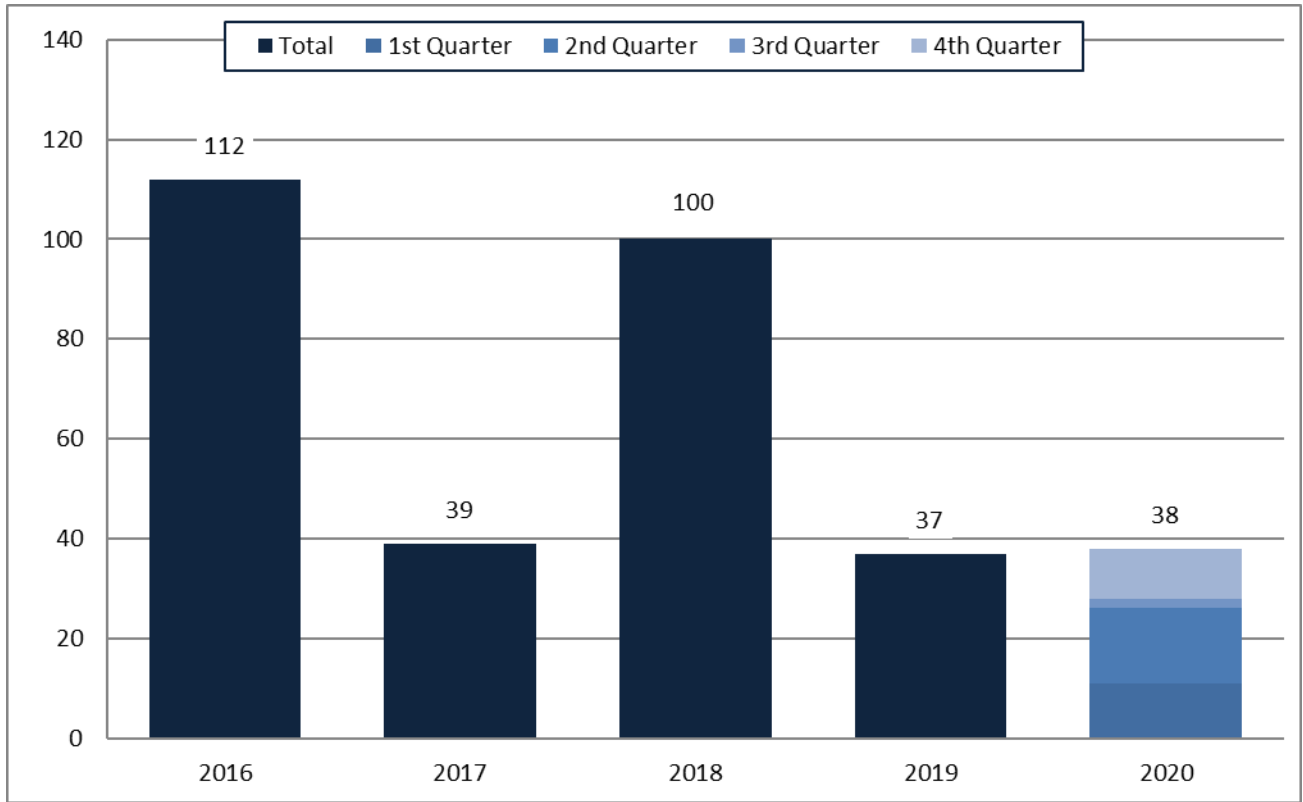

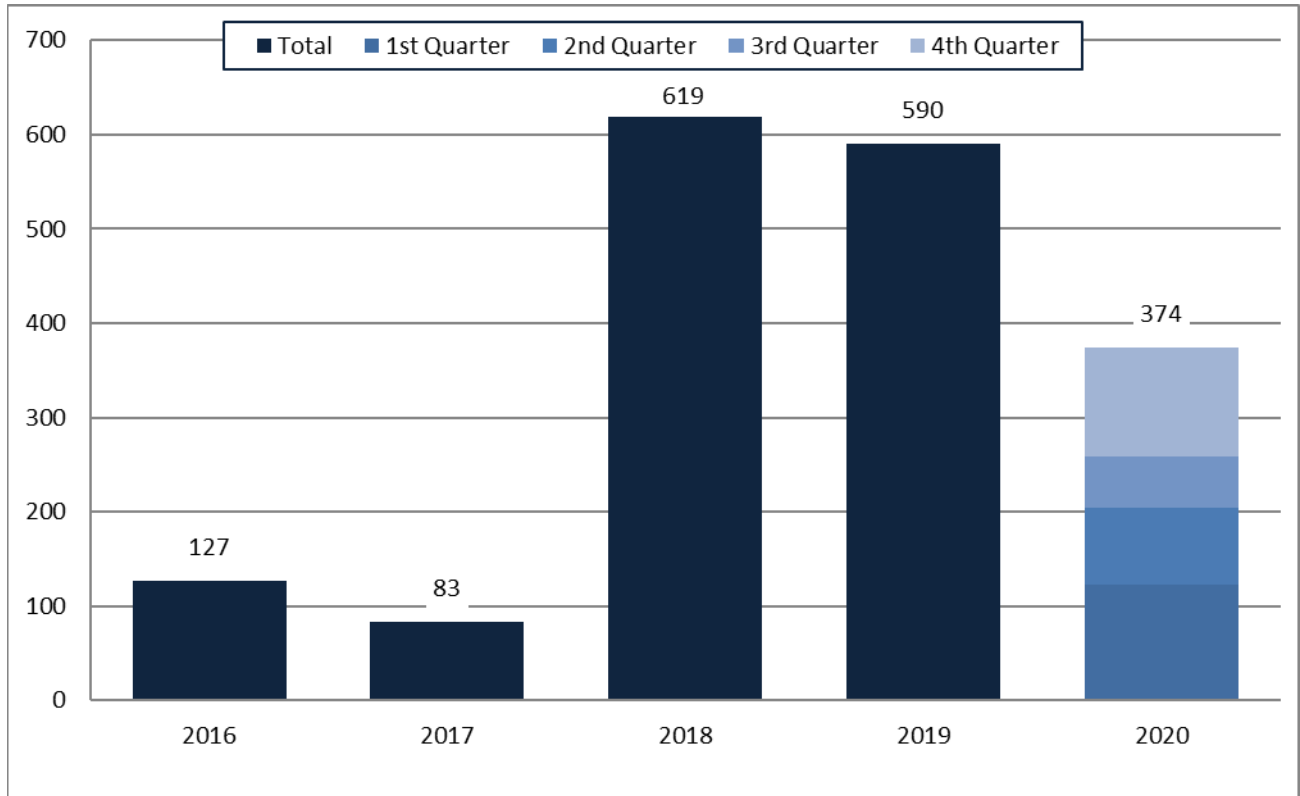
**Figure 21. ICE HSI Worksite Criminal Arrests – Owners/Employers:

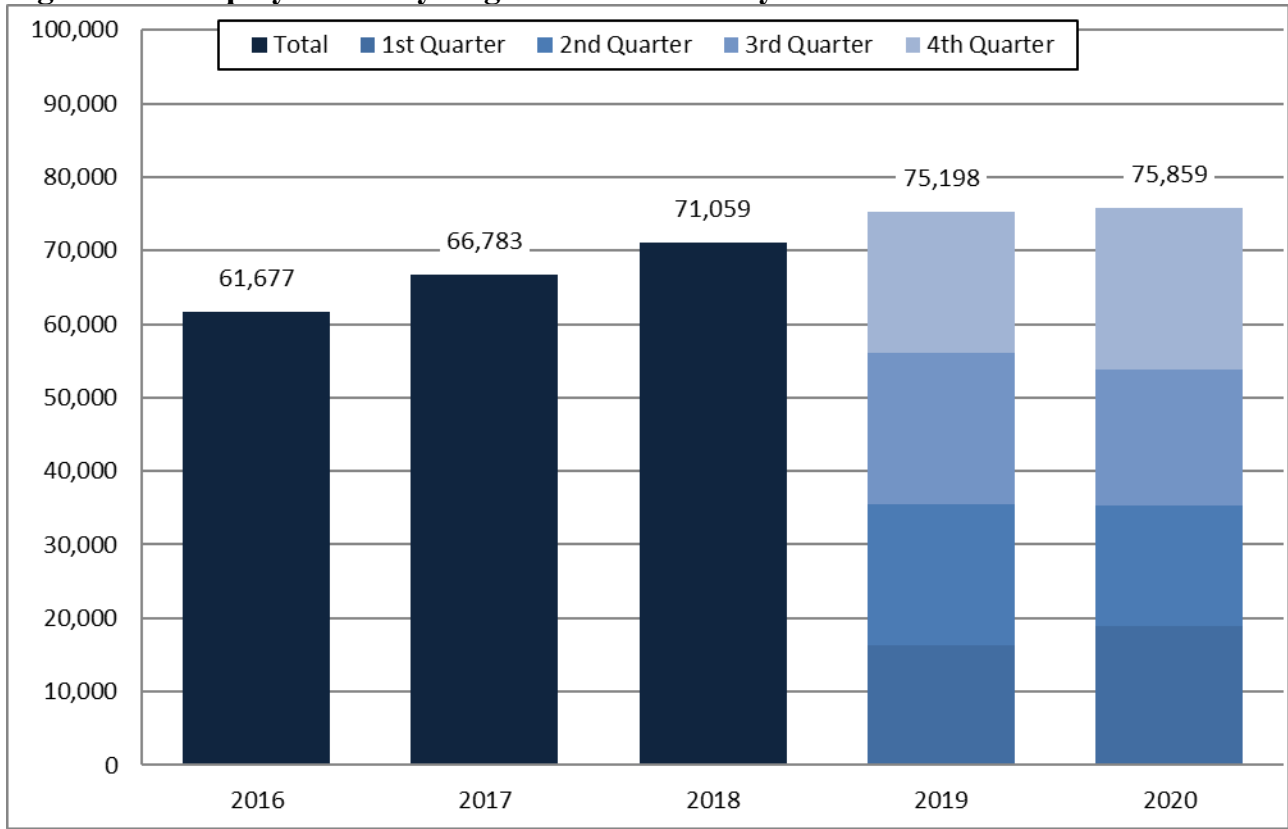
**Figure 22. ICE HSI Worksite Criminal Arrests – Employees/Other:

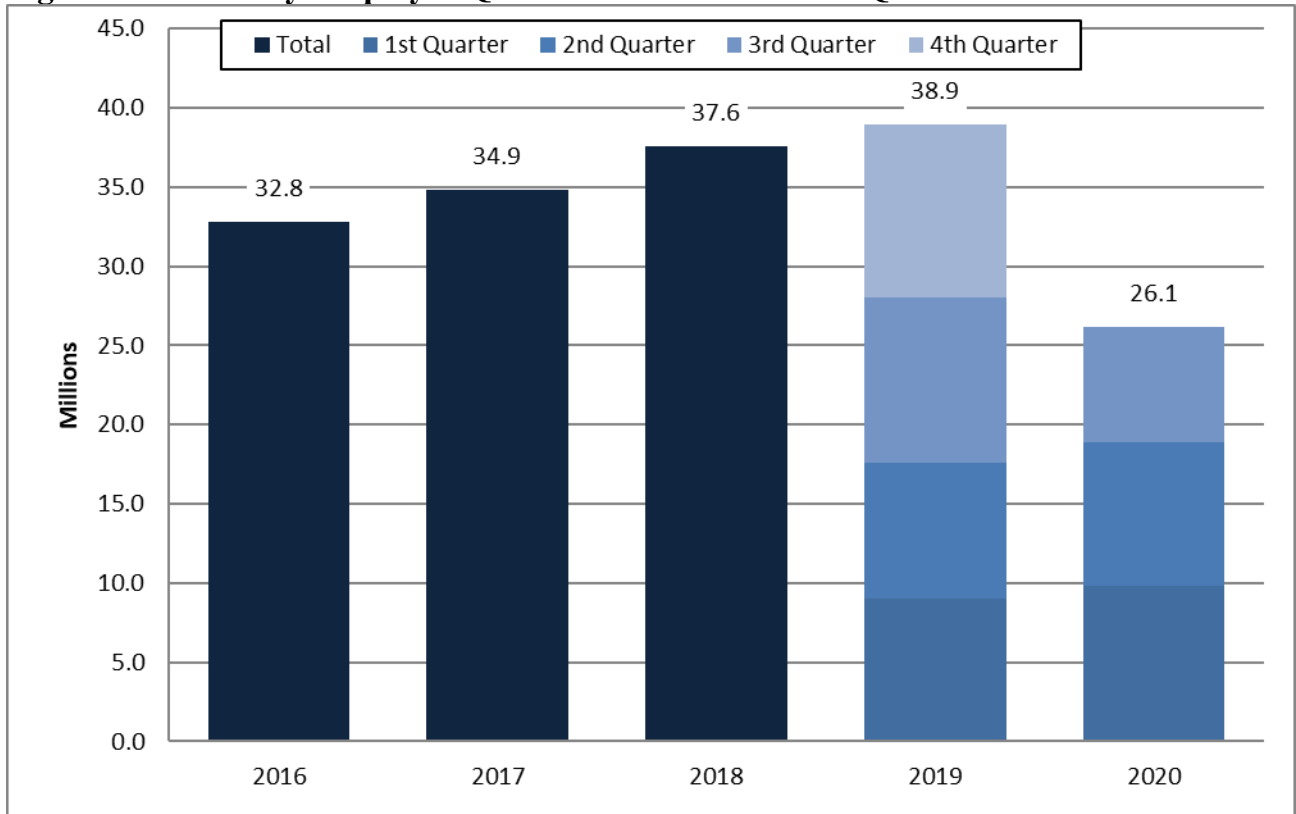
**Figure 23. Employers Newly Registered in E-Verify: FYs 2016 to 2020**

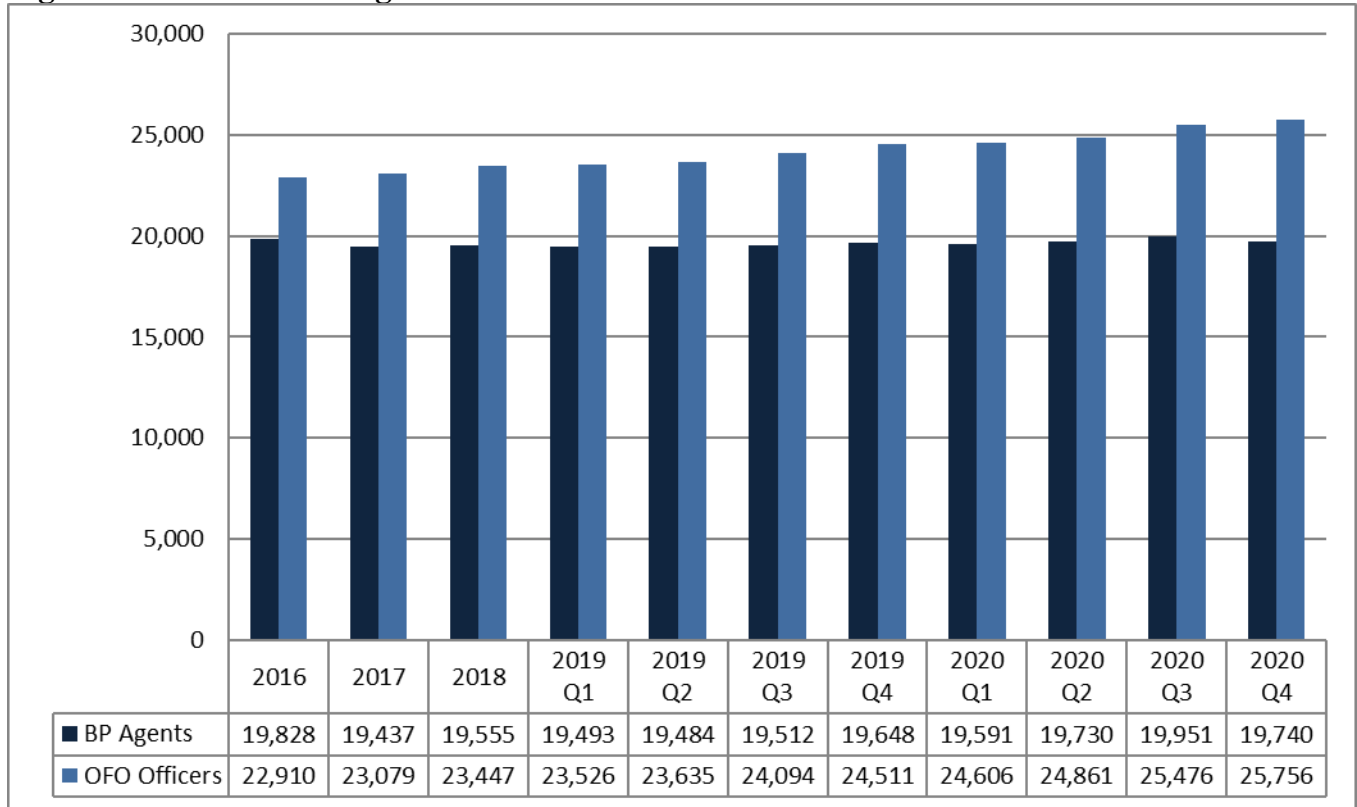

## IV. Appendices

### Appendix A. Glossary

**Administrative Arrest** - The arrest of a noncitizen who is charged with removability under the Immigration and Nationality Act (INA).

**Average Daily Population** - Average daily detention population for the months included in the reporting period.

**Average Length of Stay in Detention** - The mean length of stay in detention from the time of initial admission to the time of release for those noncitizens released during the reporting period. Noncitizens in detention at the end of the reporting period are excluded from the calculation.

**Consequence Delivery System** - A U.S. Customs and Border Protection (CBP)-developed system that guides management and agents through a process that is designed to evaluate each subject apprehended by the CBP U.S. Border Patrol (USBP) and to identify the most appropriate consequence on the basis of the individual's crossing history. The Consequence Delivery System initially was implemented in the Tucson Sector in January 2011 and now is deployed across the Southwest Border.

**E-Verify** - An Internet-based system administered by U.S. Citizenship and Immigration Services (USCIS) in partnership with the Social Security Administration that allows employers to verify the employment eligibility of workers electronically.

**Deportable Noncitizen under INA § 237** - A noncitizen in and admitted to the United States subject to any grounds of deportability specified in section 237 of the INA, 8 U.S.C. § 1227. This includes, but is not limited to, noncitizens who are illegally in the United States by fraud or misrepresentation or entered legally but subsequently violated the terms of his or her nonimmigrant classification or status or committed a criminal offense that renders him or her deportable.

**Inadmissible Noncitizen** - A noncitizen ineligible to receive visas or ineligible to be admitted to the United States based on one or more grounds of inadmissibility described in section 212 of the INA, 8 U.S.C. § 1182.

**Removals** - The compulsory and confirmed movement of an inadmissible or deportable noncitizen out of the United States based on an order of removal. Ineligibility to remain in the United States is based on grounds of inadmissibility under INA § 212 or deportability under INA § 237. A noncitizen who is removed may be subject to additional administrative and/or criminal consequences with respect to subsequent illegal reentry owing to the fact of the removal. This report includes removals effectuated by both U.S. Immigration and Customs Enforcement (ICE) and CBP.



**Returns** - The confirmed movement of an inadmissible or deportable noncitizen out of the United States not based on an order of removal. Ineligibility to remain in the United States is based on grounds of inadmissibility under INA § 212 or deportability under INA § 237. A noncitizen may withdraw his or her application for admission and/or choose to depart the United States and return to his or her home country in lieu of removal proceedings. This report includes returns effectuated by both ICE and CBP.

**Queries** - For the purposes of the E-Verify program, each query represents one new hire or new verification.

**Seizure** - Taking physical possession and/or control of property, merchandise, or other articles from the possession or control of an individual or establishment.

**Violence against CBP USBP Agents** - Any assault directed at a CBP USBP agent in the performance of or with a nexus to their official duties, including, but not limited to, rockings, shootings, vehicular assaults, other physical assaults, and any other threat of bodily harm or death, while engaged in or on account of border enforcement activities.

**Violence against CBP Office of Field Operations (OFO) Officers** - Physical threats or elevated use of force occurring in reaction to a legitimate or perceived threat to CBP OFO personnel. Along with physical assaults, violent incidents involve vehicles being operated in a manner that poses a risk or harm or the use or intended use of a deadly weapon.

**287(g) Program** - A state and local cross-designation program authorized by INA § 287(g). This program provides specific officers of participating state and local law enforcement agencies with the necessary delegation of authority, training, and resources to perform certain functions of an immigration officer under the direction of ICE.
