Top Stories

- A man from Hong Kong was arrested January 14 at the San Francisco Airport after being accused of smuggling stolen military devices into the U.S., improperly importing goods, and providing false statements on the origin of the devices from 2005 through 2009. – *Associated Press; South China Morning Post* (See item [2](#))
- Two individuals pleaded guilty to committing more than \$82,000 in credit card fraud at a Walmart store in Burton. One of the individuals was a cashier at the store and aided in the fraud. – *Flint Journal* (See item [3](#))

Officials evacuated a section of the building as they examined the contents of the man's backpack.

Phishing campaigns analyzed thus far show that Web mail, corporate, and bank email addresses were targeted.
