1. *February 7, Associated Press* – (Pennsylvania; Maryland) **Ice storm's wake leaves customers in the dark.** Utility crews worked February 7 to restore power to more than 320,000 customers in Pennsylvania and roughly 30,000 customers in Maryland that remained without service after an ice storm downed power lines and trees February 5.

2. *February 6, Salt Lake City Deseret News* – (Utah) **Energy company to pay fine for polluting Uintah County wetlands.** Gasco Energy agreed to pay \$110,000 and permanently shut down a natural gas well in Uintah County in response to violating the Clean Water Act after the well contaminated wetlands near the Green River, the U.S. Environmental Protection Agency announced.

## Chemical Industry Sector

3. *February 6, KMYT 41 Tulsa* – (Oklahoma) **One person injured in chemical spill at Pryor plant.** Pryor Chemical officials are investigating a chemical spill at its facility in Mayes County after a worker was injured by anhydrous ammonia February 6. Pryor Chemical did not evacuate the plant, but a nearby fertilizer company evacuated its facility after authorities warned that winds could blow the ammonia toward the plant.

4. *February 6, Pensacola News Journal* – (Florida) **EPA cleaning up extensive acid spill in northern Escambia County.** The Florida State Department of Environmental Protection announced that a CSX freight train derailed during an ice storm in Molino January 28 and spilled between 24,000 and 30,000 gallons of phosphoric acid into Fletcher Creek, which feeds into the Escambia River. Crews removed the derailed cars and the acid was being contained and neutralized on site before being transported to a wastewater treatment plant for treatment.

5. *January 6, U.S. Department of Labor* – (Ohio) **Solvay Specialty Polymers cited by US Labor Department's OSHA; fines of \$77,000 proposed.** Solvay Specialty Polymers was cited by the Occupational Safety and Health Administration for 12 safety violations, primarily for exposing workers at its Marietta, Ohio facility to chemical hazards from solvents used during manufacturing. Proposed fines totaled \$77,000.

6. *February 6, Beaver County Times* – (Pennsylvania) **NRC proposes fine for company that lost radioactive gauge.** The U.S. Nuclear Regulatory Commission proposed a \$3,500 fine for Chambersburg-based Valley Quarries Inc., after a May 3, 2013 incident where a soil density gauge containing radioactive materials was lost after it fell from a truck belonging to the company. The gauge was found and reported by a citizen in West Virginia and recovered.

The man also pleaded guilty to attempting to murder a straw buyer who was part of the scheme. **derailment in Sedalia, detour in place.** Highway 67 near Sedalia was closed indefinitely February 6 after 17 BNSF Railway cars derailed and scattered broken rail parts. There were no reports of spills or injuries and detours were put in place while authorities continued to investigate the incident.

15. *February 6, KPTV 12 Portland* – (Oregon) **20-vehicle crash shuts down snowy I-5 near Albany.** Wintery conditions in Albany, Oregon, caused a 20-vehicle crash that shut down a portion of southbound lanes on Interstate 5 for several hours before opening one lane. Oregon Department of Transportation officials advised motorists to stay off the roads if possible due to the weather.

28. *February 7, Softpedia* – (International) **Cybercriminals hijack router DNS settings to lure users to fake banking websites.** Researchers at Poland’s Computer Emergency Response Team (CERT Polska) identified an attack that uses vulnerabilities in home routers to redirect users to fake banking Web sites. The attack hijacks DNS settings and then redirects users to malicious Web sites that mimic legitimate banking sites.
