1. *March 3, CNN* – (National) **One more time: Snow, sleet, misery fall on East Coast.** A severe winter storm dumped snow and brought freezing temperatures throughout the Midwest and East Coast, prompting the closure of federal government offices, school closures, about 2,000 flight cancellations, and causing thousands to lose power across several States March 3.

2. *March 3, KTXL 40 Sacramento* – (California) **Thousands of SMUD customers without power after SUV plows through power pole.** An SUV crashed into a power pole in Sacramento March 2, causing more than 20,000 Sacramento Municipal Utility District customers to lose power before crews were able to reroute service.

3. *March 3, Longview News-Journal* – (Texas; Louisiana) **Thousands of east Texans without power as freezing rain blankets area.** More than 22,000 AEP Southwestern Electric Power Co. (SWEPCO), customers lost service March 2 due to freezing rainfall and sleet throughout east Texas and northwest Louisiana.

4. *March 2, Cleveland News-Herald* – (Ohio) **Power outages in Lake County; transformer ‘explodes’ in Fairport Harbor, Mentor-on-the-Lake police say.** Police departments in multiple cities in Lake County reported that several transformers in Fairpoint Harbor exploded and caused 42,950 customers to lose power March 1.

5. *March 2, Washington Observer-Reporter* – (Pennsylvania) **Third well capped in Dunkard Township.** Crews capped a third well at the Chevron gas well pad in Dunkard Township in Greene County after a February 11 explosion that killed a worker and injured another. Officials stated that a new well head was installed March 1 on the well that was not leaking, but had been monitored.

6. *March 1, Racine Journal Times* – (Wisconsin) **Just 100 pounds of coal remain at trail derailment site.** Officials stated that only about 100 pounds of coal remained at a crash site in Caledonia, Wisconsin, where 19 Union Pacific train cars derailed and dumped hundreds of tons of coal in January, due to the ground being frozen. Crews will clean up the remaining coal once temperatures are warmer.

7. *February 28, KTLA 5 Los Angeles* – (California) **Storm knocks out power to tens of thousands of SoCal homes.** Southern California Edison and Los Angeles Department of Water and Power crews worked to restore power to more than 36,000 customers after a severe storm knocked out electricity February 28.

8. *February 28, Associated Press* – (North Carolina) **Violations issued against Duke for coal ash spill.** The North Carolina Department of Environment and Natural Resources issued two formal notices to Duke Energy February 28 stating that the company will be cited for violating environmental standards in connection with a massive coal ash spill that began February 2 and coated 70 miles of the Dan River with toxic sludge.

The fire department cleared the scene after stopping the leak.

10. *February 28, Connecticut Day* – (Connecticut) **Unit 2 at Millstone partially shut down Thursday.** Operators at the Millstone Power Station in Waterford began powering down the Unit 2 reactor February 27 after a battery that powers emergency safety equipment was found to not be working. The reactor was reduced to 20 percent power when crews bypassed the battery, and the reactor returned to near full power February 28.

11. *March 1, Softpedia* – (International) **Casino operator Las Vegas Sands admits hackers have stolen customer data.** Las Vegas Sands announced that cyberattacks which defaced some of its Web sites also compromised employee and customer data from its Sands Bethlehem casino in Bethlehem, Pennsylvania, potentially exposing credit card and bank account information, Social Security numbers, and other personal information. The company is continuing its investigation of the breach.

12. *February 28, WMAQ 5 Chicago* – (Illinois) **First American Bank reports data breach in Chicago taxis.** First American Bank announced that it has received reports of fraudulent charges after customers used taxis in Chicago that utilize two companies to process transactions. The bank is continuing to investigate the fraudulent transactions.

13. *February 28, U.S. Attorney's Office, Northern District of Illinois* – (Illinois; Pennsylvania) **Two executives indicted in alleged \$190 million equipment financing fraud scheme that caused \$100 million loss to lenders.** The owner of Palatine, Illinois-based Equipment Acquisition Resources Inc., and the owner of former Machine Tools Direct Inc., based in Carlisle, Pennsylvania, were indicted February 28 for allegedly running a scheme to fraudulently obtain \$190 million in financing, causing \$100 million in losses for lenders.

14. *February 28, IDG News Service* – (International) **GameOver malware tougher to kill with new rootkit component.** Sophos researchers reported that a new variant of the Gameover banking malware that steals online banking credentials includes a kernel-level rootkit called Necurs that can make the malware more difficult to remove from

infected systems.

16. *March 2, Associated Press* – (Colorado) **1 killed, 30 injured in massive Colorado pileup.** A portion of the northbound lanes of Interstate 25 in south Denver were shut down for several hours after sudden snow caused about 104 vehicles to crash in a roughly 2-mile stretch of highway March 2, killing 1 person and injuring several others.

17. *March 2, Associated Press* – (Indiana) **Icy roads in S. Indiana make driving conditions hazardous.** A late winter storm in Indiana caused 14 counties to post travel watches recommending only essential travel March 2 after about 9 inches of snow and ice glazed roads and caused highway closures and accidents throughout the State.

19. *March 2, Murrieta Patch* – (California) **Ortega Highway to remain closed until rain lets up, spokeswoman says.** Around 30 miles of the Ortega Highway between Orange and Riverside counties were closed February 28 and remained closed through March 2 due to debris and mud that covered several lanes of the highway following heavy rains.

Repairs were expected to be completed March 3.

30. *March 3, Softpedia* – (International) **Meetup down for days due to DDoS attack allegedly ordered by a competitor.** Social networking portal Meetup was hit by a distributed denial of service (DDoS) attack beginning February 27 that took the portal's Web site offline for several days. An attacker contacted the company, claimed responsibility, and demanded a payment to end the attack.

The researchers believe the rootkit was created by a Russian intelligence agency and has been in operation since 2011.

Crews repaired the leak and officials believe expanding ice in the valve pit of the tank forced the main valve open and allowed gas to escape.
