1. *August 21, KTXS 12 Sweetwater* – (Texas) **Names of 2 killed in west Texas oil field accident released.** Two Rayco Pumping Unit Service workers were killed and one was injured August 20 when a cable from their winch truck came in contact with a power line at an oil field site in Mitchell County. The Occupational Safety and Health Administration will be investigating the accident.

2. *August 21, Associated Press* – (Tennessee) **TVA board votes to retire Memphis coal plant.** The Tennessee Valley Authority (TVA) voted August 21 to retire the coal-fired units at its Allen Fossil Plant in Memphis by December 2018 and replace them with a natural gas facility in order to reduce emissions under an agreement with the U.S. Environmental Protection Agency.

3. *August 21, KVLY 11 Fargo; KXJB 4 Valley City* – (North Dakota) **Oil and Gas Division reports saltwater spill near Williston.** The North Dakota Oil and Gas Division reported that a leaking pipe at a Kodiak Oil and Gas saltwater disposal site near Williston caused 300 barrels of saltwater to be spilled. The company stated that the spilled material was contained and recovered.

5. *August 21, U.S. Consumer Product Safety Commission* – (International) **SolarWorld recalls solar systems with copper grounding lugs due to electrocution, electric shock or fire hazard.** SolarWorld announced a recall of around 1.5 million solar systems with bare-copper grounding lugs in the U.S. and Canada due to the potential for the lugs to corrode, which could cause a faulty ground circuit and pose electric shock, electrocution, or fire hazards to consumers.

6. *August 21, U.S. Department of Labor* – (Ohio) **2 workers injured by machine hazards in separate incidents at Hicksville, Ohio, telecommunication tower manufacturing plant.** The Occupational Safety and Health Administration cited FWT LLC with one serious and one repeat violation at its Hicksville telecommunication tower manufacturing facility for exposing workers to amputation hazards following two injuries. Proposed fines totaled \$45,500.

8. *August 22, KFOX 14 El Paso* – (Texas) **Almost a dozen train cars including some tanks derailed in the lower valley.** A Union Pacific train derailed 11 of its cars, including some tanks, in El Paso August 21. No leaks or injuries were reported.

10. *August 22, WRTV 6 Indianapolis* – (Indiana) **Plane makes emergency landing in Indy after pilot notices smoke in cockpit.** A United Airlines flight en route to Chicago from Columbus was forced to make an emergency landing at the Indianapolis International Airport August 21 after crews reported smoke in the cockpit. All passengers on board were evacuated and taken back to the terminal.

11. *August 21, WTOV 9 Steubenville* – (Ohio) **Crews clean up after train derailment, fire, fuel spill.** Crews remained on-scene in Steubenville to contain the remaining 200 gallons of fuel under rail tracks after a Norfolk Southern train carrying 500 gallons of fuel in one of its fuel tanks derailed August 20, sparking a fire and the spill. Norfolk Southern resumed service on one line August 21 but the second line remained closed.

13. *August 21, Food Poisoning Bulletin* – (Texas) **Hepatitis A exposure at Whataburger in Austin, Texas.** Austin/Travis County health officials issued a warning to patrons who ate at a Whataburger restaurant in Austin between August 7 and August 19 after an employee who handles food was diagnosed with hepatitis A, putting the individuals at risk of exposure. Authorities believe the transmission of infection is unlikely, but advised some customers to seek medical advice if they display certain symptoms.

14. *August 21, U.S. Department of Agriculture* – (National) **California firm recalls chicken Caesar salad kits for possible Listeria contamination.** The Food Safety and Inspection Service announced August 21 that California-based APPA Fine Foods issued a recall for approximately 92,657 pounds of its APPA Fine Foods/Sam’s Club Daily Chef Chicken Caesar Salad kits due to possible Listeria monocytogenes contamination. The product was distributed nationwide to a bulk warehouse chain and sold in its in-store cafés.

19. *August 21, Federal Bureau of Investigation* – (Ohio) **Westlake cardiologist indicted for overbilling Medicare and others of \$7.2 million for unnecessary procedures.** A

cardiologist in Westlake was indicted for allegedly performing unnecessary medical procedures and referring patients for bypass surgeries they did not need as part of a scheme to overbill Medicaid and private health-insurance companies by \$7.2, defrauding Medicare and private insurers of around \$1.5 million between February 16 and June 28. The 16-count indictment includes 1 count of health care fraud, 14 counts of making false statements, and 1 count of engaging in monetary transactions in property derived from criminal activity.

20. *August 21, Fairbanks Daily News-Miner* – (Alaska) **University of Alaska internet outage caused by denial of service attack.** University of Alaska campuses in Fairbanks, Anchorage, and Juneau experienced a network outage for several hours August 20 after hackers targeted the university's servers with a distributed denial of service (DDoS) attack that came from multiple sources and consumed 490,000 of 500,000 available sessions on the university's firewall. The outage caused off-campus users to lose access to the university's Web sites and blocked Internet access for on-campus users.

21. *August 21, WTOC 11 Savannah* – (Georgia) **Copper wiring worth tens of thousands stolen in Effingham County.** Police are searching for suspects who broke into Central Elementary School in Effingham County and stole equipment and tens of thousands of dollars in copper wiring, leaving the vacant school building that hosts public events and houses offices without power.

22. *August 21, WTVD 11 Durham* – (North Carolina) **Water main break closes 2 schools early, boil water advisory in place.** A 12-inch water main ruptured August 21 prompting Wake County school officials to dismiss students from Timber Drive Elementary School in Garner and Vance Elementary School in Raleigh and cancel classes. Crews completed repairs to the line over 4 hours later and classes were expected to resume August 22.

23. *August 21, WBNS 10 Columbus* – (Ohio) **Major gas leak forces evacuation of Bishop Ready High School.** Bishop Ready High School in Columbus was evacuated and

closed August 21 after a 3-inch medium pressure gas line ruptured near the school. Between 12 and 15 homes and businesses were also evacuated while crews worked to repair the leak, which was expected to take hours.

25. *August 22, Elmira Star-Gazette*– (New York) **Tioga County officials recall evacuation message.** Tioga County emergency officials were preparing to notify residents of concerns surrounding the Valley View Pond dam when a message being programmed into the county's reverse 9-1-1 system was sent by accident, directing residents in Richford to evacuate August 21. Emergency management officials met with residents to explain the situation and address concerns while the Richford Fire Department started the process of siphoning water from the pond August 22 to reduce water hazard at the dam.

## **Information Technology Sector**

26. *August 22, Softpedia* – (International) **Credentials can be stolen in UI state inference attack.** Researchers presenting at the USENIX Security Symposium published a paper outlining a new form of attack called a user interface (UI) inference attack that can steal Android users' credentials by conducting a side-channel attack relying on a common shared-memory mechanism used by window managers. The attack uses a malicious app that does not require permissions and the researchers believe that the same vulnerability likely exists in other operating systems such as iOS, Windows, and OSX.

27. *August 22, Securityweek* – (International) **Vulnerability found in Google Wallet, Alipay payment SDKs.** Researchers with Trend Micro identified and reported a security vulnerability in the in-app payment SDKs for Google Wallet and Alibaba Alipay in Android that can be exploited by attackers using intent-filters to display phishing messages and obtain user credentials. Alibaba and Google both released

updates to their apps after being informed by the researchers May 27.

28. *August 22, Softpedia* – (International) **Vulnerability in Akeeba Backup for Joomla went undetected for years.** Sucuri researchers found a vulnerability in the Akeeba Backup extension for Joomla that has existed for years and could allow a skilled attacker to access backup files created with Akeeba and download them. The researchers stated that the security risk presented by the vulnerability was low due to the difficulty in exploiting it, and the newest version of Akeeba is no longer vulnerable. repaired the line.
