Top Stories

- A school bus from the Larimore Public School District in Fargo, North Dakota, collided with an oncoming train at a railroad crossing January 5, killing the bus driver and 1 student and injuring 12 others. – *Associated Press* (See item [8](#))

1. *January 6, Pittsburgh Tribune-Review* – (West Virginia) **Methane fire extinguished at West Virginia power plant.** An evacuation order for 10 homes was lifted 2 hours after a fire ignited January 5 among storage tanks at a coal-fired Longview Power plant near Morgantown. The fire burned itself out and was contained to the transferring equipment without disrupting operations.

2. *January 5, Pennsylvania Department of Environmental Protection* – (Pennsylvania) **DEP fines Leighow Oil Co. Inc. more than \$63,000 for violations at two facilities in Montour County.** The Pennsylvania Department of Environmental Protection announced January 5 that it issued a fine of \$63,351 against Leighow Oil Co. Inc., for Clean Streams Law and storage tank violations at 2 of its facilities in Mahoning and Valley townships after causing environmental degradation to 2 creeks and wetland which could have been prevented with proper maintenance and monitoring.

3. *January 5, U.S. Department of Labor* – (Pennsylvania) **‘Severe violator’ Domestic Casting endangers workers by ignoring prior OSHA violations at iron foundry.** The Occupational Safety and Health Administration (OSHA) cited Domestic Casting for 27 violations at its Shippensburg iron foundry, including 2 willful and 12 repeat violations, for exposing workers to machine guarding, fall, sling, and other hazards. Proposed fines totaled \$152,912 and the facility remains in OSHA’s Severe Violator Enforcement Program.

4. *January 5, U.S. Department of Labor* – (Alabama) **OSHA cites auto parts supplier for exposing workers to amputation, electrical and struck-by hazards.** Auto parts supplier Saehaesung Alabama Inc., was cited by the Occupational Safety and Health Administration for a total of 10 safety violations at the company's Andalusia and LaFayette facilities in Alabama for exposing workers to amputation, electrical, and struck-by hazards. Proposed fines totaled \$102,000.

5. *January 4, WBTV 3 Charlotte* – (North Carolina) **Four-alarm fire engulfs Rowan Co. factory, 1 injury reported.** Firefighters responded to a 4-alarm fire at the Mid State Manufacturing metal components facility in Rowan County January 4 that spread through the roof of the building. One firefighter was taken to a hospital for suffering from smoke inhalation while responding to the fire.

6. *January 6, Softpedia* – (International) **Over \$5 million stolen from Bitstamp's Bitcoin wallets.** Bitstamp stated January 6 that some of its wallet accounts for the Bitcoin virtual currency were compromised January 4, resulting in a loss of around \$5 million in Bitcoins. The company suspended its services January 5 to investigate the compromise and stated that law enforcement agencies are involved in the inquiry.

7. *January 6, WKBW 7 Buffalo* – (New York) **Cargo plane forced to make emergency landing.** A FedEx cargo plane made an emergency landing at Buffalo-Niagara International Airport January 5 due to issues with one of its landing gears. The flight landed safely and none of the three crew members were hurt.

8. *January 6, Associated Press* – (North Dakota) **2 dead, a dozen injured in North Dakota train-bus crash.** A school bus from the Larimore Public School District in Fargo collided with an oncoming train at a railroad crossing January 5, killing the bus driver and 1 student and injuring 12 others. The train was not carrying cargo at the time and two crew members on board were not injured.

9. *January 6, Weather.com* – (National) **Winter Storm Gorgon state-by-state update: one dead in Nebraska; multi-vehicle pileups in Midwest; traffic snarled in Northeast.** Winter Storm Gorgon moved from the West Coast January 5 to the East Coast January 6 affecting transportation nationally and causing road and flight delays in several Midwestern and Northeastern States. Additionally a landslide in Aberdeen-Hoquiam, Washington, isolated 200 people and closed Highways 12, 101, and 107 for cleanup and the city of Snoqualmie, Washington, ordered flood evacuations January 5 due to rain from the storm.

10. *January 6, Kennebec Journal* – (Maine) **One lane reopens on I-95 in Augusta.** A semi-truck accident caused by icy conditions spilled 120 gallons of diesel fuel onto Interstate 95 in Augusta, Maine, and damaged a bridge guardrail, prompting an overnight highway closure January 5. Only one lane opened January 6 and the Maine Department of Environmental Protection Officials shut down a water well located near the accident as a precaution.

11. *January 5, KCCI 8 Des Moines* – (Iowa) **20-vehicle plus crash closes Interstate 80 westbound.** Westbound lanes of Interstate 80 near Altoona, Iowa, were closed for several hours January 5 due to a crash that involved more than 20 vehicles. Ambulances were called onto the scene to respond to injuries.

14. *January 5, KTIV 4 Sioux City* – (Iowa) **Water main break causes street collapse in Sioux City.** A water main break in Sioux City January 5 caused a street to collapse and resulted in a gas main break leaving several homes without heat. MidAmerican Energy shut down the broken gas line and city officials stated that extremely cold weather was the cause of the water main break.

North Texas Municipal Water District officials stated that lab test results have not identified any potential environmental health concerns.

The hospital worked to treat patients through backup means and service was uninterrupted.

Police searched the campus and deemed it safe once nothing suspicious was found.

Emergency operations were temporarily moved to police headquarters and the Mobile Operations Center vehicle while officials investigated and assessed the damage.

26. *January 6, Securityweek* – (International) **Researchers find several UEFI vulnerabilities.** The Computer Emergency Response Team Coordination Center (CERT/CC) released three advisories for vulnerabilities in the Unified Extensible Firmware Interface (UEFI) identified by researchers at Bromium and MITRE Corporation. Two vulnerabilities could be exploited by a local, authenticated attacker to bypass security functions and the third is a buffer overflow vulnerability.

27. *January 6, The Register* – (International) **HTTPS can be set as your super-cookie.** A researcher demonstrated that the HTTP Strict Transport Security (HSTS) mechanism in HTTPS can be used by a malicious Web site to track which Web sites a user has visited due to HSTS creating a unique identifier to remember preferences for HTTPS sites. HSTS identifiers can be cleared in the Chrome, Firefox, and Opera browsers, are not used in Internet Explorer, but cannot be cleared in the Safari browser and syncs with the iCloud service as well.

28. *January 6, Softpedia* – (International) **Custom greeting card seller Moonpig fixes security blunder 17 months after responsible disclosure.** Greeting card seller Moonpig closed a vulnerability in its Android app that was first reported to the company in August 2013 and could have allowed an attacker to change the customer ID and access customer names, email addresses, dates of birth, addresses, order histories,

and the last four digits of payment card numbers.

29. *January 6, WSBT 22 South Bend* – (Indiana) **Officials release likely cause of Dunlap strip mall fire.** A January 3 fire at Dunlap Plaza in Elkhart destroyed two units in the structure that housed the Iglesia De Jesucristo Palabra Miel church and the Community Action of Northeast Indiana non-profit group, while a salon and day spa also suffered some structural damage. Firefighters contained the blaze before it spread to other businesses and officials determined the fire was ignited by an electrical overload in the back of the building.

No injuries were reported.

warehouse in Rockford and an adjacent warehouse be torn down to avoid an accidental structural collapse after both structures were engulfed by fire January 6. Power to about 350 ComEd customers was cut off and nearby businesses were forced to close while crews battled the blaze.
