The cause of the fire that started where roof work was being done was ruled undetermined, and operations were expected to resume January 13.

3. *January 13, Barre Montpelier Times Argus* – (Vermont) **Fuel removed from Yankee reactor.** The U.S. Nuclear Regulatory Commission stated January 12 that the 368 fuel assemblies in the reactor core of the Vermont Yankee nuclear power plant in Vernon were transferred to the facility's spent fuel pool, the first major step in the decommissioning of the 620 megawatt power plant.

4. *January 9, WAMC 90.3 FM Albany* – (New York) **Cold weather leads to Indian Point 3 alarm failure.** The operators of the Indian Point nuclear power plant in Buchanan began a temporary, partial shutdown of the Unit 3 reactor January 8 after cold weather caused two sets of low-low water level indicators in the plant's refueling water storage tank to cease functioning. One of the indicator lines was unfrozen and returned to service and operators have 7 days from the incident to restore the other alarm or else shut down the reactor.

January 12 and caused the death of 1 person and injuries to 84 others, many of whom were aboard a Yellow Line train that stopped suddenly and began to fill with smoke after departing the platform.

The fire was ruled accidental and attributed to temporary wiring used in lighting the construction site.

Police are investigating at least 10 additional reports of illness that may be connected to the tainted bread which was distributed to 9 stores in Orange County and one in Long Beach.

US Foods issued a recall January 12 for about 700 pounds of beef fajita strip products after the company was alerted by the U.S. Food and Drug Administration that cumin in a spice mix used to produce the beef products may have been contaminated with peanut residue. The recalled product was shipped to US Foods divisions in Connecticut, Massachusetts, and New York.

15. *January 12, U.S. Food and Drug Administration* – (National) **Spice N' More issues allergy alert on undeclared peanuts in cumin powder "Casablanca", "Salma", "Spice Class", "La Mina", "Leader Meret", "All Island Spice", "Key Food" and "H Harvest"**. The U.S. Food and Drug Administration reported January 12 that Spice N' More Corp., recalled multiple sizes of various cumin powder products due to undeclared peanuts. The affected products were distributed to wholesale and retail stores in several States.

16. *January 12, U.S. Food and Drug Administration* – (National) **La Flor Products Co., Inc. is issuing an allergy alert on undeclared peanuts in "La Flor-Ground Cumin"**. The U.S. Food and Drug Administration reported January 12 that La Flor Products Co. Inc., recalled its La Flor-Ground Cumin after a supplier notified the company that the product contained traces of undeclared peanut. The recall includes 2-ounce, 6-ounce, and 5-pound jars of the product that were sent to retailers in multiple States.

The U.S. Food and Drug Administration reported January 12 that Zenobia Company LLC. issued a recall for multiple size packages of its MY Spice Sage Cumin Ground after a supplier notified the company that the Cumin Ground unknowingly contained peanut protein that was not declared on the product's labels. The product was distributed nationwide via online mail orders between July 2014 and January 8.

23. *January 12, WFMZ 69 Allentown* – (Pennsylvania) **Former Lehigh County Prison doctor pleads guilty to defrauding IRS.** The former medical director of Lehigh County Prison in Pennsylvania pleaded guilty January 12 to defrauding the Internal Revenue Service (IRS), the U.S. Department of Education, and the U.S. Department of Health and Human Services out of hundreds of thousands of dollars and was ordered to pay a fine up to nearly \$2.9 million and restitution to the victims. The former medical director tried to defraud the IRS to avoid paying over \$200,000 in personal income taxes, filed false applications to the U.S. Department of Education for financial aid for his four children, and tried to file a fraudulent claim for Social Security disability benefits.

The researchers initially identified and reported the vulnerabilities in December.

Simplex - hackers.** Dell SecureWorks researchers identified a piece of malware known as Skeleton Key that can bypass authentication on Microsoft Active Directory (AD) systems, allowing attackers to authenticate as any corporate user. The malware must be redeployed when a domain controller is restarted and requires domain administrator credentials for initial deployment.

39. *January 12, Securityweek* – (International) **Number of IE vulnerabilities fixed by Microsoft doubled in 2014: Report.** ESET released a report on vulnerabilities closed by Microsoft in 2014 and found that the majority of the vulnerabilities affected the Internet Explorer browser. The report stated that 7 out of 240 security vulnerabilities were zero-days exploited by attackers before they were patched, and that the total number of Internet Explorer vulnerabilities doubled compared to 2013, among other findings.
