- A California man and 3 other individuals were convicted January 16 in a scheme that defrauded 200 people out of more than \$3 million through fake oil-well investments in Kentucky from mid-2012 through August 2014. – *Lexington Herald-Leader* (See item [2](#))

1. *January 19, Greenwich Time* – (North Dakota) **Company says 260-barrel oil spill caused by vandalism.** Petro-Hunt L.L.C. reported January 19 that a 260-barrel oil spill at an oil well site near Watford City was due to vandalism after an individual came on site, broke the seals on the tank valves, and opened them. Authorities are investigating the incident after the oil was contained and recovered at the site.

2. *January 18, Lexington Herald-Leader* – (National) **California man is convicted in \$3 million Kentucky oil-well scheme.** A California man was found guilty January 16 for conducting a plan that defrauded 200 people out of more than \$3 million through fake oil-well investments in Kentucky from mid-2012 through August 2014. Three other individuals were also charged in the scheme which included utilizing documents that included fake geological surveys to make it appear that the wells were producing substantial amounts of oil and that the sites had large reserves.

3. *January 18, KOMO 4 Seattle* – (Washington) **Over 65,000 people in the dark as windstorm powers through region.** Utility crews worked to restore power to about 65,000 customers in western Washington January 18 after strong wind gusts knocked out service.

4. *January 19, Help Net Security* – (National) **2+ million US cars can be hacked remotely, researchers claim.** A researcher with Digital Bond Labs presented a vulnerability that he

identified at the S4 conference in Miami when he reverse-engineered the Snapshot tracking dongle offered by Progressive Insurance that is currently in use in over 2 million vehicles across the U.S. that could allow the attacker to control some of the core functions of a car by compromising its on-board system via Snapshot remotely due to minimal security in the firmware.

5. *January 20, WCAU 10 Philadelphia* – (Pennsylvania) **1 dead, 30 hurt in massive I-76 pileup in Montgomery County.** Westbound lanes on I-76 in Upper Merion, Pennsylvania, were closed for more than 4 hours January 18 after a 56 vehicle pileup that left 1 person dead and 30 others injured due to icy road conditions.

6. *January 19, WCBS 2 New York City* – (New York) **Police swarm JFK after alleged bomb threat directed at landing Delta flight.** An alleged bomb threat that was called in for a Delta Air Lines flight 468 landing at John F. Kennedy International Airport in New York January 20 prompted officials to search two Delta planes sharing the same flight number, with one moved to a remote area of the airport to rescreen luggage for potential explosive devices. Both flights were cleared when nothing suspicious was found.

7. *January 19, KVUE 24 Austin* – (Texas) **Upper deck SB I-35 reopens after animal waste spill.** The southbound upper deck of Interstate 35 in Austin was closed for approximately 5 hours January 19 during clean up following an animal waste spill.

8. *January 18, WTIC 61 Hartford* – (Connecticut) **Bradley International Airport**

- reopens after closing for icy conditions.** Bradley International Airport in Connecticut was closed for about 2 hours January 18 due to icy conditions which prompted a dozen flights to be delayed.

9. *January 18, KPIX 5 San Francisco* – (California) **Windshield crack forces Oakland-to-Honolulu flight to divert to Mineta San Jose airport.** A Hawaiian Airlines flight from Oakland to Hawaii was rerouted to San Jose Mineta Airport in California January 18 for an emergency landing due to a crack in the windshield. Crews worked to repair the windshield while passengers were placed on another flight.

10. *January 17, Portland Oregonian* – (Oregon) **Interstate 84 finally reopened after massive 26-car pileup closes it for most of day.** More than 160 miles of eastbound lanes on Interstate 84 from Pendleton to Ontario were closed for several hours January 17 following a massive 26-car pileup that involved 12 semi-trucks and trapped over 50 vehicles due to icy road conditions. Twelve people were injured and treated at local hospitals.

11. *January 16, CNN* – (National) **FAA says safety inspectors can't bypass security check points.** The Federal Aviation Administration announced January 16 that it suspended a program which allowed safety inspectors to bypass the Transportation Security Administration's security checkpoints after a series of recent security breaches involving firearms from airport personnel.

Police are investigating the incident after a witness reported a dump truck knocked down the power lines and drove off.

13. *January 18, U.S. Food and Drug Administration* – (International) **Inventure Foods, Inc. issues voluntary recall of its Rader Farms Fresh Start Smoothie Blend, Sunrise Refresh Fusion, and Daily Power Fusion due to possible health risk.** The U.S. Food and Drug Administration announced January 18 that Inventure Foods, Inc., issued a precautionary recall of its Rader Farms Fresh Start Smoothie Blend, Fresh

Start Sunrise Refresh Fusion, and Fresh Start Daily Power Fusion due to possible *Listeria monocytogenes* contamination. The affected products were distributed throughout several States and Canada.

14. *January 18, U.S. Department of Agriculture* – (Florida; Georgia) **Georgia firm recalls chicken and beef products due to misbranding and an undeclared allergen.** The Food Safety and Inspection Service announced January 17 that Sentry Food Solutions recalled about 14,130 pounds of chicken and beef products after a spice supplier notified the company that the cumin in a spice mix used to formulate the products may have been contaminated with peanut allergens. The affected products were distributed for institutional use in Florida.

15. *January 18, U.S. Department of Agriculture* – (International) **Illinois firm recalls pork products produced without benefit of inspection.** The Food Safety and Inspection Service reported January 17 that Kalle USA recalled about 168,473 pounds of pork products that were imported from Denmark because they were not presented at a Chicago, Illinois point of entry for Food Safety and Inspection Service re-inspection, posing possible adverse health consequences. The affected products were produced between October 18, 2013 and November 19, 2014 and were distributed in several States.

16. *January 18, U.S. Department of Agriculture* – (Illinois) **Illinois firm recalls chicken products produced without adequate Ready-To-Eat HACCP plan and a *Listeria Monocytogenes* program.** The Food Safety and Inspection Service reported January 17 that La Guadalupana Wholesale, Inc., recalled approximately 8,856 pounds of its chicken tamales product because they were not produced under a fully implemented Ready-To-Eat (RTE) Hazard Analysis & Critical Control Points (HACCP) plan; a *Listeria monocytogenes* program; and a hazard analysis. The recalled product was distributed for retail sale in Chicago.

17. *January 18, U.S. Department of Agriculture* – (International) **California firm recalls pork products produced without benefit of inspection.** Food Club Corp., issued a recall January 17 for about 3,233 pounds of pork products imported from Spain because they were not presented at the U.S. point of entry for inspection by the Food Safety and Inspection Service, posing possible health risks. The recalled products were shipped to customers via the Internet in California.

18. *January 17, U.S. Department of Agriculture* – (National) **Georgia firm recalls beef and chicken products due to misbranding and undeclared allergens.** The Food Safety and Inspection Service announced January 16 a recall for about 869 pounds of Kabob’s Acquisition Inc. beef and chicken products that was initiated after a supplier notified the company that the ground cumin spice used during the products’ production may be contaminated with peanut residue. The recalled products were shipped to distribution centers in several States for shipment to catering firms.

19. *January 17, U.S. Department of Agriculture* – (Connecticut; New Jersey; New York) **New York Firm recalls chorizo products due to misbranding and an undeclared allergen.** The Food Safety and Inspection Service reported January 16 that Buffalo Provisions recalled about 48,210 pounds of chorizo product due to undeclared allergens after a supplier notified the company that the cumin in a spice mix used during manufacturing may be contaminated with peanut residue. The recalled products were sent to retail and wholesale locations in Connecticut, New Jersey, and New York.

20. *January 17, U.S. Department of Agriculture* – (Georgia) **Georgia firm recalls pork products due to misbranding and undeclared allergens.** The Food Safety and Inspection Service announced January 16 that Heywood’s Meat Haus & Provision Co., recalled about 931 pounds of tasso (pork shoulder) products after the company’s ingredient supplier informed them that the ground cumin spice used during production contained undeclared peanut. The product was sold in 10-pound cases and shipped to restaurant locations in Georgia.

21. *January 16, U.S. Food and Drug Administration* – (Washington; Oregon) **Queseria Bendita LLC recalls fresh cheeses and sour cream because of possible health risk.** The U.S. Food and Drug Administration reported January 16 that Queseria Bendita LLC recalled all lots of its sour cream and Panela, Queso Fresco, Requeson, and Cotija fresh soft cheese products due to possible *Listeria monocytogenes* contamination. The recalled products yield a best by date up to April 16 and were sold at the company’s on-site store in Yakima, Washington, and distributed to Hispanic grocery stores in Washington and Oregon.

22. *January 16, U.S. Food and Drug Administration* – (National) **B&M, Inc. issues allergy alert on undeclared peanut protein in ground cumin and other seasonings sold at Target and the Fresh Market nationwide due to potential undeclared peanut protein.** The U.S. Food and Drug Administration announced January 16 that B&M, Inc., recalled certain lots of Cumin Ground and Dark Chili Powder after a supplier notified the company that ground cumin used as an ingredient in the products

was potentially contaminated with peanut protein. The products were distributed to Target and The Fresh Market stores nationwide between December 1 and January 7.

23. *January 16, U.S. Food and Drug Administration* – (National) **B&M, Inc. issues allergy alert on undeclared peanut protein in ground seasonings sold at Harris Teeter in the southeast region due to potential undeclared peanut protein.** The U.S. Food and Drug Administration reported January 16 that B&M, Inc., issued a recall for 3.7-ounce containers of Blue Cheese Jalapeno Seasoning after the company was notified by a supplier that ground cumin that was used during production of the seasoning may contain undeclared peanut. The product was distributed December 1 for sale at Harris Teeter stores in the southeast region of the U.S.

24. *January 20, CBS News; Associated Press* – (Montana) **Yellowstone River spill: Oil detected in water supplies.** Preliminary testing detected oil in the city of Glendive’s public water supplies prompting officials to bring in drinking water for residents following a January 17 Bridger Pipeline LLC-owned pipeline break that caused up to 50,000 gallons of oil to spill along the Yellowstone River in Montana. The pipeline remained shut down indefinitely while crews worked to contain the oil and officials continued to test the water.

25. *January 20, Associated Press* – (Washington) **Wastewater biosolids spill into creek at Blewett Pass.** A semi-truck overturned on Highway 97 in Blewett Pass January 19 and spilled approximately 60,000 pounds of sewage biosolids into Swauk Creek prompting an advisory to stay out of the creek. Cleanup work continued January 20 while Kittitas County health officials continued to monitor the spill.

26. *January 20, Associated Press* – (Pennsylvania) **Police: Brothers stole \$500,000 worth of sewer grates from Philadelphia suburbs.** Two brothers were arrested January 17 for allegedly stealing 13 sewer grates worth approximately \$500,000 from parking lots in Philadelphia suburbs and selling them as scrap metal.

27. *January 18, KVUE 24 Austin* – (Texas) **Cedar Park issues boil water notice for area affected by water break.** The city of Cedar Park issued a boil water advisory after a water transmission main leak January 17 forced officials to shut off the water supply to more than 600 residents, including an apartment complex and several area businesses.

28. *January 19, KNSD 39 San Diego* – (California) **Suspected case of measles closes urgent care center in Rancho Bernardo.** The Sharp-Rees Rancho Bernardo Urgent Care center was closed for 6 hours January 19 after a patient entered the center with a suspected case of measles. Test samples were sent to health officials following an announcement by the County of San Diego Health and Human Services Agency that three new possible cases of measles in the county, potentially connected to an ongoing measles outbreak in the State, were being investigated.

29. *January 15, South Florida Sun-Sentinel* – (Florida) **Police: Juvenile posed as doctor at St. Mary's hospital.** West Palm Beach police questioned a juvenile for posing as a doctor for a month at St. Mary's Medical Center in Florida after authorities received a call January 13 claiming an individual was walking around the medical center in a doctor's lab coat carrying a stethoscope and informing patient and staff that he was a doctor. The juvenile's parent informed police that the boy is under the care of a doctor for an undisclosed illness.

Clean up costs were estimated at \$17,000 after authorities destroyed the plants at the grow sites.

31. *January 20, Securityweek* – (International) **VideoLan says flaws exist in codecs library, not VLC.** A security researcher discovered two vulnerabilities in libavcodec, a free open-source audio/video codecs library used by VLC, Xine and MPlayer media players that could allow the attacker the ability to corrupt memory and exploit arbitrary code.

32. *January 20, Securityweek* – (International) **CSRF flaw allowed attackers to hijack GoDaddy domains.** A security researcher discovered that Internet domain registrar GoDaddy failed to implement any cross-site request forgery (CSRF) protections for many DNS management actions which an attacker could have exploited to edit nameservers, edit DNS records, and modify automatic renewal settings. GoDaddy took measures to fix the vulnerability and introduced CSRF protections for sensitive account actions January 19.

33. *January 20, Softpedia* – (International) **Oracle addresses 167 bugs in critical patch update.** Oracle released its quarterly Critical Patch Update January 20, closing 167 vulnerabilities found in 48 of the company's products. The developer's Oracle Fusion Middleware product received 35 security patches, more than any other product, including 28 patches for vulnerabilities exploited remotely without authentication of the potential attacker.

34. *January 20, CNET News* – (National) **Verizon races out fix for email security flaw.** Verizon patched a serious vulnerability in its My FiOS mobile app after a security researcher discovered a flaw that could allow a user to access any Verizon email account, scan the inbox, read individual emails, and send messages.

Police continue to investigate the incident.

37. *January 19, Florida Today* – (Florida) **Florida mall reopens after fatal shooting.** The Melbourne Square mall in Florida was evacuated and closed when a gunman opened fire inside the mall's food court January 17, wounding an intended target and killing a second individual before the gunman died of a self-inflicted gunshot wound. Authorities recovered three handguns at the scene and continue to investigate the incident, while the shopping mall reopened for business January 18.

38. *January 19, WTOP 103.5 FM Washington, D.C.* – (Maryland) **Mont. Co. mall partially evacuated after freon leak.** A Freon leak from a heating and cooling unit prompted an evacuation of an H&R Block tax preparation center and two restaurants at the Westfield Mall in Wheaton January 19. The businesses remained closed until the leak was capped and the Montgomery County Health Departments verified the area as safe.
