1. *April 15, Portland Tribune* – (Utah) **PacifiCorp closes a coal plant.** Portland-based PacifiCorp closed its Carbon Plant (Castle Gate Plant) in Utah April 15 due to economic and financial reasons as part of the company's plan to shift to lower-carbon energy sources.

2. *April 15, Pittsburgh Post-Gazette* – (Pennsylvania) **Malfunction forces partial shutdown at FirstEnergy's Beaver Valley Plant.** FirstEnergy Corp., reported April 15 that operators at the Beaver Valley Nuclear Power Station in Shippingport, Pennsylvania, shut down the plant's Unit 1 reactor after noticing anomalies caused by a bearing failure in a non-radioactive water pump for the reactor. The company will inspect the reactor before restarting it at half-power within a few days.

3. *April 15, Chattanooga Times Free Press* – (Alabama) **TVA completes refueling of Browns Ferry Nuclear Plant.** Officials from the Tennessee Valley Authority reported that the Browns Ferry Nuclear Plant's Unit 2 reactor in Alabama returned to full service April 10 after successfully completing a 27-day scheduled refueling and maintenance project. Crews installed 260 new fuel assemblies in the reactor core and completed 12,250 work activities during the outage.

4. *April 15, KDKA 2 Pittsburgh* – (Pennsylvania) **FBI offering reward for info leading to capture of ‘North Hills Bandits’ bank robbery suspects.** The FBI is offering a \$10,000 reward for information leading to the arrest of 2 robbery suspects, dubbed the “North Hills Bandits,” who carried out armed robberies at 3 banks in the North Hills area of Pittsburgh since January. FBI agents reported that the suspects appeared to have former firearms training and used different vehicles in each robbery.

5. *April 15, Softpedia* – (National) **HSBC Finance Corporation exposes mortgage account info.** HSBC Finance Corporation notified at least 1,000 mortgage account customers in States including New Hampshire, California, Maine, Massachusetts, and Alabama, that the company inadvertently published names, Social Security numbers, account numbers, and other personal data in a breach that was discovered March 27. The data was immediately secured following the discovery, law enforcement was notified, and HSBC offered all impacted customers a free one-year subscription to Identity Guard services.

6. *April 16, WTOP 103.5 FM Washington, D.C.* – (Maryland) **Bridge collapses onto Metro, MARC train tracks in Prince George’s Co.** The Washington Metropolitan Area Transit Authority’s Greenbelt Metro station reopened and Green Line service was restored between College Park and Greenbelt stations April 16 after being closed for approximately 15 hours while crews worked to make repairs after a pedestrian bridge fell onto Metro and Maryland Area Regional Commuter train tracks in Prince George’s County April 15. No injuries were reported.

7. *April 16, KMGH 7 Denver* – (Colorado) **Cars on top of cars: 2 dead in multi-vehicle I-25 crash near Mead.** Northbound lanes of Interstate 25 near Mead reopened after being closed for several hours while officials investigated a multi-vehicle crash that killed 2 people April 15. The cause of the crash remains unknown.

8. *April 16, Wilmington News Journal* – (Delaware) **Fiery wrong-way crash on NB I-95 kills one.** All northbound lanes of Interstate 95 near Newark reopened April 16 after being closed for approximately 4 hours while officials cleared the scene of a fiery 3-vehicle wrong-way crash that killed 1 person. The accident remains under investigation by the Delaware State Police Crash Reconstruction Unit.

9. *April 16, Associated Press* – (Maine) **Maine to get more than \$138,000 for Highway Safety Initiatives.** The National Highway Traffic Safety Administration issued the Maine Bureau of Highway Safety 2 grants totaling more than \$138,000 aimed at improving highway and traffic safety. The grants will be used to improve emergency services, increase safety for pedestrians, bicyclists, and motorcycle riders, and reduce impaired and unsafe driving, among other things.

The recalled products were individually packaged in 2-ounce pouches and were distributed at three Cleveland, Ohio retail stores.

14. *April 15, U.S. Department of Agriculture* – (Arkansas) **B & R Meat Processing, Inc. recalls products due to nitrite levels in excess of regulatory limit.** The Food Safety and Inspection Service announced April 15 that B & R Meat Processing, Inc., recalled about 569 pounds of cured pork products due to nitrite levels that exceed regulatory levels. The recalled products were shipped to retailers throughout Arkansas.

16. *April 16, Associated Press; WRC 4 Washington, D.C.* – (Washington, D.C.) **Man in custody after gyrocopter lands on Capitol grounds.** A Florida man was arrested by U.S. Capitol Police April 15 after flying over and landing a gyrocopter on the grounds of the U.S. Capitol building in Washington, D.C., prompting the building and visitor center to be locked down for 2 hours before authorities cleared the scene. The man had allegedly been plotting the incident since 2013.

Marie* – (Michigan) **Ruptured gas line causes Cheboygan County schools to evacuate.** A gas line rupture April 15 prompted the closure of Cheboygan County Area Schools in Michigan, April 16 following the evacuation of the high school, middle school, and bus garage when a student driver lost control and hit a high power gas line.

19. *April 15, CNN* – (International) **Feds say National Guardsmen tried to sell guns, ammo to cartel.** Two U.S. Army National Guard members were arrested in San Diego April 15 for allegedly attempting to sell guns, body armor, and military ammunition to purported Mexican drug cartel members. The Guardsmen were supposedly caught in a sting operation run by agents with the Bureau of Alcohol, Tobacco, Firearms and Explosives (ATF) after making more than a dozen sales of firearms and stolen military ammunition to informants working with the ATF.

20. *April 15, Minneapolis Star-Tribune* – (Minnesota) **Computer hacker likely exposed data of 160,000 at Metropolitan State University.** An investigation into a January breach at the St. Paul-based Metropolitan State University concluded the week of April 13 and found that a hacker broke into the university's database and likely exposed the personal information of as many as 160,000 current, former, and potential students. The investigation also found that about 11,000 students had portions of their Social Security numbers accessed.

21. *April 15, KNSD 39 San Diego* – (California) **Student arrested for break-in, arson at school.** Authorities arrested a student in connection with a break-in and arson at the Clairemont High School in San Diego that prompted the cancelation of classes April 15 after a small fire was discovered inside a custodial closet in a chemistry room. Police are still searching for a second suspect who was seen running from the school.

22. *April 15, Hendersonville Times-News* – (North Carolina) **'Human error' caused 911 outage last week.** Officials with E-911 Communications in Henderson County, North Carolina, reported April 15 that a 12-hour outage of the county's emergency 9-1-1 system was due to an error at Colorado-based system provider Intrado Inc. The company stated that there were portions of the monitoring system that were not completely installed, and that an individual attempted to transfer large files from one

piece of equipment to another, causing the outage.

23. *April 16, Softpedia* – (International) **Current threat prevention systems are not enough protection for enterprises.** Findings from a recent study in automated breach detection carried out by security researchers at Seculert revealed that gateway solutions at participating Fortune 2000 enterprises only blocked 87 percent of communications from compromised devices within their networks. The report also found that about 2 percent of devices in organizations were compromised by malware while nearly 400,000 interactions that were generated went undetected, among other findings.

24. *April 16, Softpedia* – (International) **Company employees not sufficiently trained to avoid phishing, study finds.** A survey commissioned by Intel Security of 700 respondents in businesses across multiple continents revealed that 38 percent of information technology and security professionals believe vulnerability to social engineering is a significant factor in the success of attacks and that threat actors' use of multiple attack vectors, exploits, and payloads makes defending against attacks difficult, among other findings.

25. *April 16, Help Net Security* – (International) **TeslaCrypt ransomware pushed by several exploit kits.** Security researchers discovered that threat actors are distributing a new ransomware called TeslaCrypt via the Angler, Sweet Orange, and Nuclear exploit kits (EKs), which encrypts the typical assortment of file types along with those related to video games and game-related software, and iTunes-related files. Users have been targeted via redirects to compromised WordPress Web sites and hosts running vulnerable out-of-date Adobe Flash plugins.

26. *April 15, IDG News Service* – (International) **AirDroid app fixes severe authentication vulnerability.** AirDroid fixed a severe authentication software flaw in its Web interface affecting versions 3.0.4 and earlier, that could have allowed attackers to take over a device running the software by sending targets a malicious link over short message service (SMS) which exploit the app's use of JavaScript Object Notation (JSONP) to request data from a server in a different domain.

27. *April 15, WFAA 8 Dallas* – (Texas) **Walmart employee accused of stealing \$240K.** A former employee at a Walmart store in Decatur, Texas, was arrested and charged April 15 for allegedly stealing about \$240,000 worth of property between January 2013 and October 2014 by creating fake returns to pocket the refunds. The store began to investigate in October 2014 where the suspect admitted to stealing from the store's cash office and to stealing up to \$8,000 in merchandise in a day.

28. *April 15, WPXI 11 Pittsburgh* – (Pennsylvania) **Van crashes into Pittsburgh doughnut shop, 2 customers hurt.** Two patrons of the Better Maid Donuts shop in the Crafton Heights area of Pittsburgh were injured when a driver lost control of his vehicle and crashed into the store April 15. The area was closed for about 2 hours while crews removed the vehicle from the shop.

30. *April 16, Sacramento Bee* – (California) **California to build temporary Delta Dam.** The California Department of Water Resources announced April 15 plans to install a temporary rock barrier dam in Sacramento-San Joaquin Delta to prevent a worst-case

scenario in which Delta waters become too salty for the 25 million Californians and 3 million acres of farmland that depend on it. Officials hope to install the \$28 million dam in May and remove it by the end of October.

31. *April 15, Associated Press* – (Louisiana) **Eastern New Orleans gets levees approved by FEMA.** The Southeast Louisiana Flood Protection Authority-East announced April 14 that the Federal Emergency Management Agency certified 2 non-Federal levee segments in New Orleans that will fall inside the larger flood protection system built by the Army Corps of Engineers to help keep flood insurance rates from spiking in the area. The New Orleans East Business Association reported April 15 that two other non-Federal levee segments in New Orleans are also under review for certification.

32. *April 15, WLWT 5 Cincinnati* – (Ohio) **New rules in place at Ohio lake with deteriorating dam.** The Ohio Department of Natural Resources set new construction and dock usage policies for Buckeye Lake April 14 in an effort to protect the dam's remaining structural integrity and prevent additional erosion due to the dam's high risk of failure. Officials reported that the dam will remain at winter levels until it is replaced, rendering the State-owned docks at Buckeye Lake unavailable to residents in 2015.
