Top Stories

- An elevated section of Interstate 10 in Desert Center, California collapsed July 19 due to heavy rains and floods, while westbound lanes were closed indefinitely. – *KNBC 4 Los Angeles* (See item [8](#))
- As many as 4.5 million patients at UCLA Health System may have been affected by a breach of unencrypted information discovered October 2014 and announced July 17. – *Securityweek* (See item [17](#))
- All U.S. Marine Corps recruiting offices within a 40-mile radius of Chattanooga, Tennessee were closed July 17 in response to an attack on 2 military facilities which left 4 Marines and one Sailor dead. – *Marine Corps Times* (See item [18](#))
- The North Fire in San Bernardino National Forest burned 3,500 acres July 18, closing I-15 near Cajon Pass after destroying or damaging 30 vehicles. – *KTLA 5 Los Angeles* (See item [20](#))

1. *July 19, iFreePress* – (Wisconsin; Minnesota) **Storm knocks out power to 225,000 in western Wisconsin and Minnesota.** About 240,000 Minnesota and western Wisconsin residents lost power July 17 after a line of severe thunderstorms caused damage across the region.

2. *July 17, Associated Press* – (Montana) **At least 35,000 gallons of oil spills after Montana train derailment.** A train derailment in northeastern Minnesota spilled an estimated 35,000 gallons of oil July 16, forcing the evacuation of nearby homes. A HAZMAT team was able to contain the spill and no fire or injuries were reported.

3. *July 20, Reuters* – (International) **Canadian pleads guilty in massive U.S. penny stock fraud case.** A Canadian man pleaded guilty July 17 to charging U.S. penny stock investors with \$5 million in fees for nonexistent services, stemming from a related \$140 million penny stock fraud operation. Nine defendants in four countries have been charged in connection to both schemes.

4. *July 17, KHQA 7 Hannibal* – (Missouri) **Three men arrested for 100+ fraudulent credit cards.** Marion County, Missouri authorities charged 3 suspects with trafficking in stolen identities July 16 after discovering over 115 fraudulent credit cards and card-

manufacturing equipment in their vehicle in Palmyra.

5. *July 17, Chicago Tribune* – (Illinois) **FBI: Midday Bandit strikes again in Galewood bank robbery.** Authorities are searching for a suspect dubbed the “Midday Bandit” who allegedly robbed a Galewood bank in Chicago July 17 and is believed to be connected to 6 other bank robberies and 2 attempted robberies dating back to 2014.

6. *July 17, Reuters* – (International) **TD Bank to pay \$20 million to settle Ponzi scheme lawsuit.** TD Bank agreed to pay \$20 million July 17 to resolve allegations from a class action lawsuit that the bank aided a \$223 million-plus Ponzi scheme run on European investors by failing to properly monitor trust accounts and investigate suspicious activity.

7. *July 17, Reuters* – (International) **JPMorgan reaches \$388 mln settlement in mortgage securities case.** JPMorgan Chase & Co agreed to pay \$388 million to settle charges brought by the Fort Worth Employees’ Retirement fund and other investors alleging that the bank misled them about the quality and safety of \$10 billion worth of residential mortgage-backed securities leading up to the 2008 financial crisis.

8. *July 20, KNBC 4 Los Angeles* – (California) **Flooding, bridge collapse shut down 10 Freeway east of Coachella.** An elevated section of Interstate 10 in Desert Center, California collapsed July 19 due to heavy rains and floods. Transportation officials say the westbound side of the 10 Freeway was also damaged by flooding, leaving the interstate closed indefinitely.

9. *July 20, KWWL 7 Waterloo* – (Iowa) **Interstate 380 reopens after chase suspect hits squad car.** Northbound I-380 in Johnson County, Iowa was closed for nearly 3 hours July 20 while police investigated a crash that involved 2 Iowa State Patrol cars.

1. *July 19, Corvallis Gazette-Times* – (Oregon) **Vehicle hits power pole, closes Highway 20.** Highway 20 in Albany was shut down for 5 hours July 19 after a car crashed into a utility pole and downed power and phone cables in the area. No injuries were reported.

10. *July 18, WSMV 4 Nashville* – (Tennessee) **Southwest flight diverted to Nashville.** A Southwest Airlines flight from St. Louis, Missouri, to Newark, New Jersey, was diverted to Nashville International Airport in Tennessee July 18 due to an unruly passenger, delaying the flight about 4 hours.

11. *July 18, KRMG 740 AM* – (Oklahoma) **Major Tulsa highway shut down due to jumper threat.** The Broken Arrow Expressway in Tulsa was shut down for several hours July 18 while police talked down a man who threatened to jump from the Peoria Avenue Bridge. No injuries were reported.

12. *July 18, Associated Press* – (Alaska) **1 dead, 4 injured in Alaska plane crash, Coast Guard.** Officials reported that a small plane operated by Wings of Alaska, a company that provides services to small southeast Alaska communities and includes sightseeing trips and charters, crashed July 17 in southeast Alaska and left 1 dead and 4 others injured.

13. *July 17, New Haven Register* – (Connecticut) **Part of Route 7 in New Milford shut down after police chase, crash.** Part of Route 7 in New Milford was shut down for approximately 4 hours July 17 after a speeding driver refused to pull over, prompting a police pursuit that ended with the alleged suspect driving at a trooper before crashing the vehicle. The suspect was taken to the hospital for evaluation.

14. *July 17, U.S. Food and Drug Administration* – (National) **It Takes A Village Foods LLC dba Veggie Evolution issues an allergy alert on undeclared soy in Veggie Evolution Kale crisps Zen Nori.** The U.S. Food and Drug Administration reported July 17 that It Takes a Village Foods LLC, a Hailey, Idaho establishment, is recalling Veggie Evolution Kale Crisps Zen Nori due to an undeclared soy allergen. The product was distributed to retail stores nationwide.

15. *July 17, Mason City Globe Gazette* – (Iowa) **Clear Lake chlorine leak contained; gas line repaired.** Iowa officials reported July 17 that a chlorine leak at Clear Lake's Water Treatment Plant prompted an evacuation of surrounding homes and HAZMAT crews

after a gas line was found cracked. Crews cleared the scene and repaired the leak.

16. *July 17, KATC 3 Lafayette* – (Louisiana) **Mire Branch Water System issues boil advisory.** The Mire Branch Water System in Church Point announced a system-wide water boil advisory July 17 after experiencing low water pressure since July 16.

17. *July 17, Securityweek* – (California) **Details of 4.5 million individuals exposed in UCLA Health breach.** As many as 4.5 million patients at UCLA Health System may have been affected by a breach of unencrypted information discovered October 2014 and announced July 17. The hospital is working with the FBI and computer forensics experts to investigate the incident, and is offering a year of identity theft recovery services as well as a year of free credit monitoring for affected individuals.

18. *July 19, Marine Corps Times* – (National) **Marine recruiters told not to wear uniforms after attack.** All Marine Corps recruiting offices within a 40 mile radius of Chattanooga, Tennessee were closed July 17 in response to an attack on 2 military facilities which left 4 Marines and 1 Sailor dead. Governors in at least six states ordered National Guardsmen to be armed and Marine recruiters not to wear uniforms in public while the incident continues to be investigated.

19. *July 18, KTLA 5 Los Angeles* – (California) **Pines Fire grows to 200 acres; evacuations at multiple campgrounds remain in place.** Over 300 campers were evacuated from campgrounds in Angeles National Forest July 18 due to the 200-acre Pines Fire. Evacuees were taken to Serrano High School in Phelan, California, which had already been established as an evacuation center for the North Fire.

20. *July 17, KTLA 5 Los Angeles* – (California) **3,500-acre North Fire in Cajon Pass burns homes and vehicles, shuts down 15 Freeway.** The North Fire in San Bernardino National Forest burned 3,500 acres July 18, forcing the closure of the I-15 Freeway near Cajon Pass after it destroyed 20 cars and damaged 10. An evacuation center was established at Serrano High School in Phelan, California for Baldy Mesa residents.

A bomb squad neutralized the device and an investigation is ongoing.

23. *July 20, Help Net Security* – (International) **Ashley Madison hacked, info of 37 million users stolen.** Hackers calling themselves “The Impact Team” reportedly accessed and stole personal information and financial records of 37 million of Avid Life’s Ashley Madison Web site as well as user databases for 2 other sites that the company owns. The hack was perpetrated in response to Avid Life’s failure to provide its offered “full delete” feature for user profiles.

24. *July 17, Securityweek* – (International) **Eaton patches TCP/IP stack flaw affecting controls, relays.** Eaton released software updates addressing a remotely executable Transmission Control Protocol/Internet Protocol (TCP/IP) stack vulnerability in its Cooper Power Series Form 6 recloser control and Idea/IdeaPLUS relay protection platforms that could allow an attacker to launch man-in-the-middle (MitM) attacks and execute arbitrary code or crash systems connected to the Internet.

25. *July 17, Securityweek* – (International) **CVS investigating possible payment card breach, shuts down photo Web site.** CVS reported that the company had shut down its CVSPhoto.com Web site while it investigated a possible payment card beach of the independent vendor that manages and hosts the site, PNI Digital Media. Company

officials confirmed that purchases made in-store and on other CVS Web pages are not affected.

26. *July 18, WSAW 7 Wausau* – (Wisconsin) **NOAA weather radio station in Wausau is off the air.** The National Weather Service in Green Bay reported that the U.S. National Oceanic and Atmospheric Administration Weather Radio Station WXJ89 in Wausau has been down since July 17 due to an equipment issue. Crews hoped the station could be restored by July 20 or July 21.

27. *July 20, WLBT 30 Jackson* – (Mississippi) **Downtown Jackson Marriott Hotel evacuated after fire.** A July 19 fire prompted the evacuation of the Marriot Hotel in Jackson, Mississippi after starting inside a dumpster near the back of the hotel. Crews extinguished the flames and no injuries were reported.

28. *July 20, St. Joseph News-Press* – (Missouri) **Blaze in King City destroys apartment homes.** A July 19 fire extensively damaged converted apartments in King City, Missouri, and prompted fire crews to remain onsite for about 4 hours to extinguish the flames. No injuries were reported.

29. *July 19, WTEN 10 Albany* – (New York) **Lightning strike sets apartment roof on fire.** The Hudson Preserve Apartments in Latham, New York sustained extensive damage following a July 19 roof fire that began after lightning struck the building. Four families were displaced and no injuries were reported.

of the fire may be linked to cut wires running between the parking lot's attendant hut and billboard.

No injuries were reported.
