1. *August 3, Detroit News* – (Michigan) **Storms pummel state, produce tornado.** A line of thunderstorms in southeastern Michigan cut power to approximately 92,000 DTE Energy customers August 2 and 63,000 customers remained without service August 3 while crews worked to restore service by August 4. The storm caused flooding which prompted the closure of northbound Interstate 75 ramp at Interstate 94 in Detroit and the southbound Interstate 75 ramp to eastbound Interstate 94.

4. *July 31, U.S. Consumer Product Safety Commission* – (National) **NVIDIA recalls tablet computers due to fire hazard.** NVIDIA issued a recall July 31 for about 83,000 SHIELD tablet computers due to a lithium-ion battery issue that could cause the device to overheat, posing a fire hazard. The product was sold at GameStop stores nationwide and through various online retailers from July 2014 through July 2015.

5. *July 31, Securityweek* – (International) **Flaw in fingerprint access devices could make it easy to open doors.** Security researchers at CERT Coordination Center (CERT/CC) discovered two flaws in several models of fingerprint access controllers developed by Taiwan-based Chiyu Technology in which an unauthenticated attacker

with network access could view and modify the device's configuration by accessing known paths.

6. *July 31, U.S. Securities and Exchange Commission* – (International) **SEC charges man with microcap fraud involving shares of Cynk Technology Corp.** The U.S. Securities and Exchange Commission charged a Canadian man July 31 with allegedly using straw shareholders, foreign dummy corporations, and fake corporate officers worldwide to conceal his control of shares of Cynk Technology Corp., which he intended to liquidate when the stock's price increased.

7. *August 3, WNCN 17 Goldsboro* – (North Carolina) **Grandmother killed, 8 hurt when car and bus crash on I-95 near Benson.** The southbound lanes of Interstate 95 in Benson at mile marker 81 were shut down for almost 3 hours August 2 after a bus driver transporting 48 passengers fell asleep and slammed into a guardrail, killing 1 person and injuring 8 others.

8. *August 1, KSL 102.7 FM Midvale* – (Utah) **Tanker spills milk, starts fire in Weber Canyon rollover.** Interstate 84 in Odgen was shut down for approximately 8 hours August 1 while crews responded to a small grass fire that started after a semi-truck hauling milk overturned. The driver of the truck was taken to the hospital for serious injuries and no other vehicles were involved in the crash.

9. *August 1, KDVR 31 Denver* – (Colorado) **Motorcycle accident causes delays on EB I-70, hospitalizes three.** Interstate 70 at the Hidden Valley exit east of Idaho Springs was shut down for several hours August 1 while officials investigated an accident that involved 2 motorcycles and injured 3 people.

10. *August 1, Yakima Herald-Republic* – (Washington) **SR 970 remains closed following fuel tanker crash and fire near Cle Elum.** State Route 970 two miles east of Cle Elum was shut down for several hours August 1 while crews cleared the scene of a fiery crash that involved a semi-truck and a pick-up truck, leaving 2 people injured.

The cause of the crash remains unknown.

11. *August 1, U.S. Food and Drug Administration* – (National) **The Kraft Heinz Company voluntarily recalls select varieties of Kraft Singles products due to potential choking hazard.** The Kraft Heinz Company is voluntarily recalling select Kraft Singles individually-wrapped slices due to a film that may adhere to the cheese slice causing a choking hazard. The products were shipped to stores nationwide.

12. *July 31, U.S. Food and Drug Administration* – (Pennsylvania) **Allergy alert on undeclared milk in nutrition resource services, Inc.'s Whey, Casein, and Colostrum Protein Products.** The U.S. Food and Drug Administration reported July 30 that Nutrition Resource Services, Inc., of Bethlehem, Pennsylvania is voluntarily recalling products with whey concentrate, whey isolate, casein, and colostrum due to a milk allergen. The products were shipped to local showrooms, the Internet, and select local retail locations.

The product was shipped to 21 retail stores nationwide.

14. *July 31, U.S. Food and Drug Administration* – (National) **Kilwin's Quality Confections, Inc. issues allergy alert on undeclared cashew in Sugar Free Milk Chocolate Caramels.** Kilwin's Quality Confections, Inc., of Petoskey, Michigan is voluntarily recalling 5-ounce containers of Sugar Free Milk Chocolate Caramels due to an undeclared cashew allergen July 31. The product was shipped to Kilwin's stores nationwide.

15. *August 1, WDAZ 8 Grand Forks; WDAY 6 Fargo* – (North Dakota) **Production line catches fire at Grand Forks Simplot plant.** The Simplot plant in Grand Forks, North Dakota sustained extensive damage August 1 after a fryer caught fire and spread to the roof of the building. Crews contained the incident and no injuries were reported.

16. *August 2, WCBS 2 New York City; Associated Press* – (New Jersey) **Coast Guard monitoring oil spill in Bayonne.** Coast Guard crews are monitoring a spill at the International-Matex Tank Terminal in Bayonne after an unspecified amount of oil spilled into the water after a tugboat struck a pier August 1. The boaters and the public have been urged to stay away from the site.

18. *August 1, Associated Press* – (Washington) **Kitsap sewage spill prompts warning to stay out of water.** Health officials issued a water advisory August 1 to avoid contact with water in Dyes Inlet and the Part Washington Narrows on the Kitsap Peninsula after an estimated 40,000 gallons of sewage spilled near the Clear Creek Estuary when a contractor's excavator bucket ruptured a sewer pipeline. Parks in the area were temporarily closed but have reopened.

19. *August 3, Softpedia* – (National) **Data of 4 million patients lost in MIE hacking.** The Indiana Attorney General announced that an estimated 1.5 million State residents and 3.9 million individuals from 11 healthcare providers and 44 radiology clinics nationwide may have been impacted by a May breach of Medical Informatics Engineering and its subsidiary NoMoreClipboard's networks. Officials continue to investigate the attack, which allowed hackers to gain access to patients' personal and medical information.

20. *August 3, Securityweek* – (National) **FDA issues alert over vulnerable Hospira drug pumps.** Healthcare organizations were alerted by the U.S. Food and Drug Administration July 31 regarding cyber security risks associated with the use of Hospira Symbiq infusion systems following flaws discovered in 2014, which included security holes that can be remotely exploited by hackers in order to gain access to the devices and possibly change the dosage they deliver. The company has been working on developing a software update and the vendor is working to remove all of the infusion systems from the market until a permanent replacement is available.

21. *August 1, Sioux City Journal* – (South Dakota) **Siouxland Pain Clinic says patient information likely exposed by hacker.** The Siouxland Pain Clinic in Dakota Dunes reported July 31 that patients' health and other personal information was likely exposed during an attack on the clinic's server between March 26 and April 2, and that there was no evidence that the information was misused. The clinic continues to evaluate the attack after being notified of the breach June 26.

22. *July 31, Rapid City Journal* – (South Dakota) **Files of 1,100 veterans thrown in dumpster at Hot Springs VA.** The U.S. Department of Veterans Affairs announced July 31 that a box containing the personal information of 1,100 military veterans was inadvertently thrown out into a dumpster at the Blacks Hills Health Care System campus in Hot Springs during an office move May 15. Officials stated that the files were retrieved and secured May 17.

23. *August 3, CNN* – (California) **California wildfires torch 134,000 acres – and counting.** Crews continued to work August 3 to contain at least 21 wildfires in California including the 54,000-acre Rocky Fire stretching across 3 counties that threatens over 12,100 individuals and more than 5,100 structures. The wildfires have collectively burned over 134,000 acres across the State, causing the governor to declare a state of emergency July 31.

24. *August 3, Eugene Register-Guard* – (Oregon) **Third forest fire – a small one – breaks out Douglas County as crews continue fight against Stouts and Cable Crossing fires.** Crews reached 3 percent containment August 2 of the Stouts Fire that burned through 15,200 acres in the Canyonville area of Douglas County. Fire crews also reached 15 percent containment of the 1,148-acre Cable Crossing Fire burning near Roseburg.

28. *August 3, Help Net Security* – (International) **Fake “Windows 10 Free Upgrade” emails deliver ransomware.** Security researchers from Cisco’s Talos Group discovered a ransomware campaign in which attackers purporting to be from Microsoft send victims emails with a fake Windows 10 installer attached that is actually a variant of the CTB-Locker crypto-malware.

29. *August 3, Softpedia* – (International) **Chrome extensions can be disabled without user interaction.** Security experts from Detectify Labs discovered that an attacker could disable a list of Google Chrome security extensions upon visiting a site using the “ping” attribute inside a regular link, effectively removing safeguards without the user’s knowledge. Google Chrome was notified of the vulnerability and released a patch addressing the issue.

30. *August 3, IDG News Service* – (International) **DNS server attacks being using BIND software flaw.** Security researchers from Sucuri reported that attackers have begun exploiting a denial-of-service (DoS) flaw in all versions of BIND 9 open-source Domain Name System (DNS) software that was patched the week of July 27. The company confirmed that two clients in different sectors had experienced attacks.

31. *August 3, Help Net Security* – (International) **The leading cause of insider threats? Employee negligence.** The Ponemon Institute released findings from a survey on insider information technology (IT) threats in U.S. and German firms, revealing that in addition to malicious intent, employee negligence is a significant cause of security

incidents that lead to decreases in IT productivity, which can cause a company as much as \$1.5 million in losses per year. The report cited long hours and multitasking as common elements leading to negligence, among other findings.

32. *August 3, Brownsville Herald* – (Texas) **Jack FM burglar charged.** An Alamo man was indicted July 31 on two counts of burglary charges after allegedly breaking into KJAV-FM, also known as “Jack FM” brand, and stealing and damaging radio equipment. Estimated theft and damage costs total over tens of thousands of dollars and forced the station to go offline for an unknown amount of time.

A police investigation is ongoing to determine the cause of the incidents.

- cigarette sparked a porch fire that spread to a nearby building and surrounding units. Fire crews contained the incident and an investigation is ongoing to determine the cause.

36. *August 3, WCVB 5 Boston* – (Massachusetts) **Fire destroys winery at historic Massachusetts farm.** The Charlton Orchards Farm & Winery in Charlton, Massachusetts sustained extensive damage August 2 after a fire destroyed a barn housing all the winemaking equipment and 4,000 gallons of wine. No injuries were reported.

37. *August 3, WWMT 3 Kalamazoo* – (Michigan) **20 displaced after apartment fire in Kalamazoo.** A Michigan State official reported August 3 that 20 residents were displaced after a Kalamazoo apartment fire prompted the evacuation of 7 adjoining units. The cause of the fire is unknown and an investigation is ongoing.

About 17,900 people were without power August 3, down from a peak of 95,000.

No injuries were reported and fire crews remained on site approximately two hours extinguishing the flames.

The chemical prompted a temporary evacuation of the mall while fire crews ventilated the area.
