Janet Napolitano of Arizona faxed request to Secretary Chertoff and Rumsfeld states that the border issue in Arizona needs more Federal attention. Napolitano requests funding for the use of the Arizona National Guard, in a support role, to secure the border. She emphasizes that Federal border control policy in the SW has funneled illegal immigration traffic through Arizona and has created a "primary gateway" at the Border Patrol's Tucson Sector. She says that while over 50% of illegal crossings are through Arizona, only 27% of Border Patrol officers are stationed there. She states that although DHS' resources have increased to this area, Congress has not appropriated even the minimum levels recommended by the 9/11 Commission and authorized by Congress in the Intelligence Reform and Terrorism Act of 2004. Arizona will assist as it can, she said, citing that in 2004, by declaring a state of emergency, she released \$1.5 million in State funds and in January, 2005, she sent a \$100 million border package to the State legislature. She recalled a 12-30-05 letter to Secretary Rumsfeld in which she listed a series of activities that the Arizona National Guard could perform in a support capacity to the Federal Government. They included: 1) augmentation of current Title 32, section 112 -- Drug Interdiction strategy; Title 32, Section 502(f) -- Training and other duties that have been liberally applied in the past; Execution of a MOA between DOD and DHS (like the 2002 MOA between the former-INS and DOD for the Canadian and Mexican borders); and utilizing Chapter 9 of Title 32, which gives the the Secretary of Defense the discretion to provide Federal funds to a governor to employ National Guard Assets for homeland defense. She reiterates an earlier statement to DHS that "the use of National Guard troops allows ICE and CBP to place more personnel in critical front-line enforcement roles and we encourage this cooperation."
